INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Participants
DDH Enterprise, Inc 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination

As discussed in Note 1 to the financial statements, the governing body of DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust approved a resolution on August 10, 2022 to terminate the Plan. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. 

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the predecessor auditor not to perform, and they did not perform, any auditing procedures with respect to the information certified by a qualified institution. The predecessor auditors report for the year ended December 31, 2021 expressed an unmodified opinion on those statements and was issued on October 4, 2022.

Note 1 - Description of the Plan

The following description of the DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information.

Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering all full-time employees of the Company and its wholly owned subsidiaries who had one year of service and were 21 or older. The Plan was initially effective January 1, 1994 and was amended and restated July 1, 2011.

The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company contracted with Equitable Life Insurance Company to provide plan record keeping and administrative services, and to serve as trustee of the Plan's assets.

Plan Termination

The Board of Directors of DDH Enterprise, Inc. (the Plan Sponsor) adopted a resolution on August 10, 2022 that approved the termination of the DDH Enterprise 401(k) Profit Sharing Plan and Trust effective December 31, 2022, and the transfer of the Plan's assets and liabilities to a pooled employer plan with Sheakley Workforce Management, LLC, dba Sheakley Pension, as the pooled plan provider, and Voya Institutional Trust Company (the Trustee). Effective with the Plan's termination, all participants with account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. The Plan's termination also ceased employee and employer contributions into the Plan.

Eligibility

Prior to the Plan's termination eligible employees could enter the Plan quarterly on the first day of the Plan year and the first day of the fourth, seventh and tenth month of the Plan Year.

Participant Contributions

Participants were able to contribute 15% of pretax annual compensation, and as defined in the Plan to not exceed \$20,500 for the year ended December 31, 2022 and \$19,500 for the year ended December 31, 2021. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions of \$6,500 for both years ended December 31, 2022 and 2021.

Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants were able to direct the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds and a guaranteed interest option (GIO) as investment options for participants. The Plan included an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elected not to participate.

Company Contributions

Prior to the Plan's termination the Company made a discretionary matching contribution not to exceed a portion of the before-tax contributions. The percentage of contribution was determined by the employer on an annual basis. The matching Company contribution was invested directly into a portfolio of investments at the option of the Company's board of directors. Contributions were subject to certain limitations. For the years ended December 31, 2022 and 2021, the Company matched 10% of the employee's contribution to the Plan.

Participant Accounts

Prior to the Plan's termination, each participant's account was maintained separately within the Plan and was credited with their elective deferrals, employer contributions, and earnings. Participants were able to elect to have contributions invested in any or all of the funds of the Plan, subject to certain limitations. Investment income and losses and related management expenses were allocated to the participants' accounts regularly. Allocation of employer contributions, investment income and losses, and administrative expenses were based on participant's compensation or account balance. Forfeited balances of terminated, non-vested participant accounts were applied at the end of the Plan's year in which they occurred to reduce employer contributions or expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Participants achieved vesting in company contributions based on years of service with the Company as follows:

Participants were also fully vested upon reaching their normal retirement date, death or disability.

Forfeited Accounts

For the year ended December 31, 2022, forfeiture redemptions totaling \$14,852 were used to reduce employer contributions. At December 31, 2022 and 2021 the forfeiture account balance was \$0 and \$6,669, respectively.

Participant Loans

Loans were not available to participants.

Benefit Payments

Upon retirement, disability, death, termination of employment, or in the case of financial hardship, the participant could elect to receive a lump-sum amount equal to the participant's vested interest in their account.

Rollover Transfers

At the discretion of the Administrator, participants were permitted to deposit distributions received from other plans and Individual Retirement Accounts into the Plan. No rollover transactions were executed in 2022 and 2021.

Audit Year

The DDH Enterprise, Inc. 401(k) Profit Sharing Plan and Trust Plan ended on December 28, 2022 which the Company considered to be the year-end date for 2022.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, require management to make estimates and assumptions that could affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Plan investments were stated at fair value. If available, quoted market prices are used to value investments. Shares of registered investment companies are valued at quoted market prices, which represent the net value of shares held by the Plan at year-end.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded at the ex-dividend date. The realized gain or loss on investments was included with unrealized appreciation or depreciation in the current value of the pooled separate accounts.

Payment of Benefits

Benefits were recorded when paid.

Administrative Expenses

The tax compliance fees and administration costs of maintaining the Plan were paid by the Company, but brokerage services were borne by the participants.

Income Tax Status

The Internal Revenue Service determined the Plan was designed in accordance with applicable sections of the Internal Revenue Code, and therefore the related trust was not subject to tax under current law. The Plan administrator believed the Plan was designed and was being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that, more likely than not, would not be sustained upon examination by the IRS.

Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

Note 4 - Investment Contract with Insurance Company

In 2010, the Plan entered into an investment contract with Equitable Life Insurance Co., "Equitable", for a combined profit sharing and 401(k) plan. Equitable maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Plan provided for a participant-directed investment program, whereby the participant was able to select among available alternatives and periodically change their selection. Once a year the Plan's board of directors evaluated the Plan's assets and could change investments offered to the participants in the Plan.

Integrated with the Plan was a Guaranteed Interest Option (GIO). The GIO provided for a minimum guaranteed interest, the actual rate of interest credited during the time over which the funds were invested was declared periodically and was subject to change. The interest was credited daily with minimum interest rate guaranteed over the life of the contract. The GIO rate was 1.50% and the contract minimum interest rate was 1.0% as of December 31, 2022 and 2021. The value of the GIO, at any time, was equal to the contributions and transfers to the options, minus withdrawals and transfers out of the option and charges that were deducted by Equitable as specified in the contract.

As of December 31, 2022 and 2021, the guaranteed interest balance was \$0 and \$1,283,743, respectively. The managers of Equitable believed that this Plan was not a fully benefit-responsive investment contract as described in ASC 946-210-45-10 and should be reported at fair value.

Note 5 - Fair Value Measurement

The Plan accounts for certain assets and liabilities at fair value. The hierarchy below lists three levels of fair value based on the extent to which inputs used in measuring fair value are observable in the market. The Plan categorizes each of its fair value measurements in one of these three levels based on the lowest level input that is significant to the fair value measurement in its entirety. These levels are the following:

Note 5 - Fair Value Measurement (con't)

Level 1 - Unadjusted quoted prices in active markets for identical investments as of the reporting date.

Level 2 - Observable inputs to the valuation methodology are, other than Level 1 inputs, either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methods.

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The Plan's policy was to recognize significant transfers between the levels at the actual date of the event or circumstances that caused the transfer. For the year ended December 31, 2021, there were no transfers in or out of Levels 1, 2, or 3.

Note 7 - Excess Contributions/Distributions

During the years ended December 31, 2022 and 2021, the Plan distributed excess contributions in order to keep the plan in compliance under the Internal Revenue Service guidelines. These distributions resulted due to the Plan's failure of the test of Actual Deferral Percentage (ADP) over Actual Contribution Percentage (ACP) for highly compensated employees. For the years ended December 31, 2022 and 2021, the total amount of the distributions were \$92,056 and \$83,238, respectively, including tax withheld and cash paid to over-funded employees.

Note 8 - Related-Party Transactions and Party in Interest Transactions

Plan investments were managed by Equitable Life Insurance Company. Equitable Life Insurance Company was the trustee and record keeper of the Plan and, therefore, these transactions qualify as party in interest transactions.

Note 9 - Blackout Period

Due to the Sponsor's election to terminate the Plan, management selected a blackout period for the Plan from December 21, 2022 to December 28, 2022. During this period, participants and the company contributed \$12,685 and \$1,269, respectively. These contributions were remitted directly to the new PEP Plan, and have not been reflected in these financial statements.

Note 9 - Date of Management's Review of Subsequent Events

Subsequent events were evaluated through August 29, 2023, which is the date the financial statements were available to be issued. The management of the Plan is not aware of any other obligations, legal actions or other commitments not disclosed in these financial statements.
