Notes to Financial Statements

Note 1: Description of Plan

The following description of the Medical Graphics Corporation 401(k) Savings Plan (the "Plan") is provided for general information purposes. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Medical Graphics Corporation (the "Company"). Employees who are 21 or older and have obtained 30 days of service are eligible to join the Plan on the first day of the month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan has adopted certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") that was signed into law on March 27, 2020, which were immediately available for coronavirus-related distributions and suspended participant loan payments.

Plan Termination

On December 27, 2022 the Plan Sponsor elected to terminate the Plan. Upon termination, all participants became fully vested in employer contributions.

Contributions

Each year, participants may elect to contribute up to 97% of pre-tax annual compensation, as defined in the Plan, to a maximum amount determined annually by the Internal Revenue Service. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company matches 50% of the participant's first 6%, subject to certain limitations contained in the Plan and established by law. The Company may also make discretionary profit sharing contributions. The Company did not make any discretionary profit sharing contributions during 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the employer's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. All Plan investments are participant-directed. Participants are allowed to choose from various investment options including the ability to utilize a self-directed brokerage option for investments outside the Plan's core menu of investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their elective deferral, catch-up contributions, and rollover contributions, plus actual earnings thereon. Company discretionary matching and profit sharing contributions, and earnings thereon, vest in accordance with provisions of the Plan as follows:

1	0%
2	40%
3	60%
4	80%
5	100%

According to the Plan provisions, a year of service is credited when the participant completes 1,000 hours of service. Participants who leave the Plan because of death, normal retirement, or disability retirement, as defined in the Plan, are considered 100% vested.

Payment of Benefits

The Plan provides for payment of the entire vested balance in the participant's account upon retirement, death, disability, or termination of employment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also qualify for an in-service distribution when they attain age 59 1/2 but continue to work, or when they qualify on account of financial hardship.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to initially exhaust plan loans.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% - 7.25%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Forfeited Accounts

Forfeitures are used to reduce the Company's matching contribution and to offset expenses under the Plan that would otherwise be paid by the Company. During the year ended December 31, 2022, \$10,774 of forfeitures were used to offset Company matching contributions. Unapplied forfeitures as of December 31, 2022 and 2021, were \$2 and \$228, respectively.

Note 2: Summary of Significant Accounting Policies

Adoption of the Liquidation Basis of Accounting

The 2022 financial statements of the Plan are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP). This basis of accounting is considered appropriate when liquidation of the Plan is imminent. Under this basis of accounting, assets are valued at their net realizable values, which approximates the fair value, and liabilities are stated at their estimated settlement amounts. The conversion from the going concern basis of accounting required management to make significant estimates and judgments.

The 2021 statement of net assets available for benefits of the Plan was prepared on the going concern basis of accounting in accordance with GAAP.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to the Plan participants based on their respective account balances and are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2023, which is the date the financial statements were available to be issued.

The Plan Sponsor elected to terminate the Plan on December 27, 2022. Subsequent to December 31, 2022, all Plan assets were either rolled into the CAIRE Inc. 401(k) Plan, distributed to participants, or had their remaining balances rolled into an Individual Retirement Account on their behalf on March 16, 2023.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

Note 3: Fair Value Measurements (Continued)

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2022 and 2021.

Mutual funds: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts consist primarily of interest bearing cash, mutual funds, and common stocks that are valued on the basis of readily determinable market prices.

Stable value collective trust fund: Morley Stable Value Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business matter. This investment seeks preservation of principal and income while maximizing income.

Note 4: Information Certified by the Plan Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 5: Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2016 that the Plan is qualified and that the trust established under the Plan is tax-exempt under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

Certain of the Plan's investments are managed by the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity Management Trust Company for trustee and recordkeeping services, and fees paid to RBC Wealth Management for investment advisor services totaled \$46,267 for the year ended December 31, 2022. Additionally, the Plan issues loans to participants, which are secured by the participants account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by offices or employees of the Company. No such officer or employee receives compensation from the Plan.
