Management has obtained certifications from a qualified institution as of January 1, 2023 and December 31, 2022, and for the one day period ended January 1, 2023 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Emphasis of Matter—Plan Merger

As discussed in Note 9 to the financial statements, the Board of Directors of Ag Trucking, Inc., the Plan's Sponsor, voted on November 17, 2022, to merge the Plan into The Kenan Advantage Group, Inc. 401(k) Plan effective January 1, 2023. All plan assets were transferred to The Kenan Advantage Group, Inc. 401(k) Plan on January 18, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management of the Financial Statements

Note 1. Plan Description

The following description of the Ag Trucking, Inc. Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all full-time employees of Ag Trucking, Inc. (the Company) who have one year of service (1,000 hours of service). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2023, the Plan was amended to merge the Plan into The Kenan Advantage Group, Inc. 401(k) Plan, which is disclosed in Note 9 to the financial statements. Plan Sponsor management communicated the plan termination to participants in 2022.

Contributions: Participants may contribute a percentage of their annual compensation, as defined by the Plan, up to the maximum annual Internal Revenue Service (IRS) limitation. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants' contributions are directed by the trustee into various investment options offered by the Plan based on a risk profile form completed by the participant.

The Company may, at its discretion, make a matching contribution to the Plan, as well as an additional discretionary contribution. The Company made a matching contribution of 75% of the employee deferrals up to 4% of employee compensation and a discretionary contribution of 2% of each participant's annual compensation for the year ended December 31, 2022. The Company's matching and discretionary contributions are invested into the various investment options in a manner that is consistent with the participant contributions. Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, if any, (b) Plan earnings and (c) forfeitures of terminated participants' non-vested accounts, and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting: Participants are immediately vested in their voluntary contributions and the Company's matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits: Upon retirement or termination of service, participants or beneficiaries may elect to receive installment benefit distributions or a lump sum distribution in an amount equal to the value of the participant's vested account. Benefit payments are recorded when paid.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts are reallocated to participants based on participant compensation. At January 1, 2023, December 31, 2022 and 2021, forfeited non-vested accounts totaled approximately \$1,000, \$1,000 and \$2,000, respectively. During the period ended January 1, 2023 and year ended December 31, 2022 approximately \$0 and \$1,000 of forfeitures were reallocated to participants.

Administration of plan assets: Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 2. Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with the accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Fair value measurements: Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 2. Significant Accounting Policies (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 1, 2023, December 31, 2022 and 2021.

Shares of registered investment companies: Valued at the closing price reported on the active market on which the individual securities are traded.

Shares of common trust funds: Valued based on the net asset value (NAV) of units of the common trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent events: The Plan has evaluated subsequent events for potential recognition and/or disclosure through October 11, 2023, the date the financial statements were available to be issued.

Note 3. Information Certified by Reliance Trust Company (Reliance)

The following is a summary of the Plan's asset information as of January 1, 2023, December 31, 2022 and 2021, and for the year ended December 31, 2022, included throughout the Plan's financial statements and ERISA-required supplemental schedules, obtained by management and agreed to or derived from information certified by Reliance, the trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

2. The fund seeks to maximize income while allowing for capital growth through moderate exposure to equity securities. The fund is invested primarily in bonds and U.S. stocks, with remaining assets invested in non U.S. stocks and cash.
3. The fund seeks to provide moderate income while maintaining the potential for capital growth through equity exposure. This fund typically has 20% to 50% of assets in equities and 50% to 80% of assets in fixed income and cash.
4. The fund seeks to balance income generation with capital growth potential by allocating approximately equal amounts to equity and fixed income securities.
5. The fund seeks a moderate approach to provide capital growth by allocating approximately equal amounts to equity and fixed income securities.
6. The fund seeks growth of capital while maintaining a modest amount in fixed income securities for income generation.
7. This fund seeks aggressive growth of capital as a primary objective while maintaining a small amount in fixed income securities to minimize big changes in the portfolio's value. The fund tends to invest across the spectrum of U.S. industries and owing to its broad exposure, the fund's return is often similar to the S&P 500 index.
8. The fund seeks aggressive growth of capital as a primary objective by investing entirely in equity securities. The fund tends to invest across the spectrum of U.S. industries and owing to its broad exposure, the fund's return is often similar to the S&P 500 index.

Note 5. Guaranteed Investment Contract with Insurance Company

The Plan entered into a benefit-responsive contract with The Standard. The Standard maintains the contributions in a general account. While The Standard declares rates periodically and backs the principal and interest, any guarantees are subject to the claims paying ability of the insurance company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The stable value fund issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. At January 1, 2023 and December 31, 2022, the value was \$39,373.

As described in Note 2, because the stable value fund contract is fully benefit-responsive, contract value is the relevant measurement attributable for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The stable value fund contract has a portfolio investment rate design in which all deposits in the particular investment choice are credited with the same interest rate on a daily basis. The effective credited interest rate is set quarterly and is effective on January 1, April 1, July 1 and October 1. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan, (2) changes to Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The stable value fund does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan is an adopter of a non-standardized form of a prototype plan sponsored by The Standard. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2019.

Note 8. Related-Party and Party-In-Interest Transactions

Certain Plan investments are managed by Reliance. RSM US LLP acts as external auditor for the Plan. Reliance and RSM US LLP performed services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid to Reliance and RSM US LLP by the Plan for the period ended January 1, 2023 and year ended December 31, 2022, were approximately \$110,000.

Note 9. Plan Merger

In November 2022, the Plan Sponsor elected to merge the plan with The Kenan Advantage Group, Inc. 401(k) Plan effective January 1, 2023.

Legal title and responsibility to the net assets available for benefits of \$9,057,021 were transferred to The Kenan Advantage Group, Inc 401(k) Plan on January 1, 2023. As a result, the statement of net assets as of January 1, 2023, reflects an amount due to The Kenan Advantage Group, Inc. 401(k) Plan for the full amount of the assets available for benefits as of January 1, 2023 and the statement of changes in net assets available for benefits for the period ended January 1, 2023, reflects this transfer to The Kenan Advantage Group, Inc. 401(k) Plan which took place on January 18, 2023.
