Opinion

We have audited the financial statements of CDChoices and Participating Employing Consumers Health Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2022 (in liquidation) and 2021 (ongoing), the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2022 (in liquidation) and 2021, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Notes 1 and 2 to the financial statements, the Board of Directors of Consumer Directed Choices, Inc., the Plan's sponsor, voted on November 9, 2022 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Note 1 - Description of the Plan

The CDChoices and Participating Employing Consumers Health Plan (Plan) was established effective October 1, 2015. The Plan is sponsored by Consumer Directed Choices, Inc. (Plan Sponsor). The Plan Sponsor is an enrolled provider within the New York Statewide Medicaid-funded program called Consumer Directed Personal Assistance. Through this program, eligible individuals (Consumers) directly employ and supervise personal assistants (Personal Assistants). The Plan covers eligible Personal Assistants as well as eligible employees of the Plan Sponsor (collectively, Employees).

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. Plan Termination

On November 9, 2022, the Company's Board of Directors adopted a resolution to terminate the Plan and the related Trust, effective as of December 31, 2022. As a result, management determined that liquidation was imminent as of November 9, 2022.

b. General

The Plan was a multiple employer welfare benefits plan providing for the payment of health, vision and dental insurance premiums for Employees and their eligible dependents. The Plan was also used as a funding vehicle for mandatory employee benefits, including workers' compensation and disability insurance. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan assets, prior to Plan termination (see Note 1a), were held by the Adirondack Trust Company, the Trustee of the Plan. The Plan Sponsor was responsible for administration of the Plan.

c. Benefits

The Plan provided for the payment of health, vision and dental insurance premiums for eligible Employees and their spouses and/or dependents.

Full-time employees of the Plan Sponsor were eligible to participate in the Plan on the first day of the month following their date of hire. Personal Assistants were eligible to participate in the Plan on the first day of the month following 60 days from the first day worked, provided that the Personal Assistant averaged 25 or more paid hours of service per week during the payroll month immediately preceding the entry date.

d. Contributions

The Plan was funded by Plan Sponsor contributions (with respect to eligible full-time employees of the Plan Sponsor), Consumer contributions via Medicaid (with respect to Personal Assistants) and Employees' pre-tax contributions. The percentage of health, vision and dental premiums paid by Employees range depending on the type of employee (employee of the Plan Sponsor versus Personal Assistant) and the type of coverage selected (single, single plus children, single plus spouse, or family). Premiums for workers' compensation insurance were funded by the Plan Sponsor. Premiums for disability insurance were funded by both the Plan Sponsor and the Employees.

d. Contributions - Continued

Contributions of the Employees and those funded by the Plan Sponsor and Consumers were deposited in the Trust and remitted to the insurance providers on a monthly basis.

Note 2 - Summary of Significant Accounting Policies

a. Basis of Accounting

Due to the decision to terminate the Plan during 2022 (Note 1a), the Plan has changed its basis of accounting from the going concern basis to the liquidation basis, in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for health and welfare benefit plans. For the periods before the decision to terminate the Plan was made, the financial statements were prepared using the going-concern basis of accounting in accordance with U.S. GAAP.

b. Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

c. Prepaid Health Insurance Benefits

Prepaid health insurance benefits represent insurance premiums paid to insurance providers in advance.

d. Deferred Contributions

Deferred contributions represent contributions made to the Plan in advance.

e. Interest Income Recognition

Interest income was recorded on the accrual basis.

f. Payment of Benefits

Benefits were recorded when paid.

g. Expenses

Expenses of the Plan were paid directly by the Plan Sponsor.

h. Subsequent Events

The Plan has evaluated subsequent events for potential recognition or disclosure through August 3, 2023, the date the financial statements were available to be issued.

Note 3 - Tax Status

The Trust established under the Plan to hold the Plan's net assets qualified as an exempt organization under Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the Trust's net investment income was exempt from income taxes under IRC Section 501(a). The Internal Revenue Service made a favorable determination in a letter dated May 13, 2016, that the Plan met the requirements of IRC Section 501(c)(9).

The Plan and Trust were required to operate in conformity with the IRC to maintain the tax-exempt status of the Trust. Although the Plan had been amended since receiving the determination letter, the Plan Sponsor believes that the Plan was being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax exempt through the date of termination (see Note 1a).

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more-likely-than-not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 4 - Related Party and Party-In-Interest Transactions

Administrative expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$25,600 and \$16,700 during the years ended December 31, 2022 and 2021, respectively. Certain Plan administrative functions were performed by employees of the Plan Sponsor who did not receive compensation for such functions from the Plan.


