**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Zix Corporation Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A - DESCRIPTION OF PLAN**

The following brief description of the Zix Corporation Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description. The Plan is sponsored by Zix Corporation (the “Company” or “Plan Sponsor”). In December 2021, the Plan Sponsor was acquired by Open Text Corporation.

***General***

The Plan was effective January 1, 1989, amended and restated effective July 20, 2021, and is a defined contribution plan administered by the Company. The Plan has retained Fidelity Management Trust Company as its Trustee (“Trustee” or “FMTC”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***Eligibility***

Active full-time employees of the Company who are a nonresident alien or are not members of a labor union or independent contractors are eligible to participate in the Plan immediately upon employment with the Company and attainment of age 18.

New employees of the Company are automatically enrolled in the Plan with a default salary deferral contribution of 5%. This percentage is increased by 1% per year up to a maximum of 10% if they do not opt out the automatic increase program.

Employees may select an alternative deferral amount or may elect not to participate in the Plan at any time by notifying the Plan administrator at which point their mandatory salary deferral contribution will be suspended.

***Contributions***

Participants are permitted to contribute between 1% to 80% of their compensation, as defined, subject to statutory limitations, to the Plan on a tax-deferred basis or an after-tax basis (e.g. ROTH 401(k)). The Plan also allows participants to make rollover contributions from other qualified plans.

The Company makes a discretionary per pay period matching contribution to the Plan of a percentage as determined by the Board of Directors. The Company match for the years ended December 31, 2022 and 2021, was made at the rate of 100% of participant contributions, up to a maximum deferral of the first 3% and 50% of the next 2%, respectively, of the participant’s eligible compensation. Matching contributions are determined separately each payroll period and are recalculated based on the ratio of participant contributions to eligible compensation and “true-up” contributions are made accordingly. The Company may also contribute an additional, discretionary amount as determined by the Board of Directors. Such discretionary contributions are allocated to all participants in proportion to their compensation. There were no additional discretionary contributions in 2022.

***Participants’ Accounts***

Under the Plan, participants may direct daily the investment of salary deferred contributions, discretionary Company match, additional discretionary contributions, and related earnings in one or more investment alternatives maintained by the Trustee.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participant's account comprising discretionary Company match and additional discretionary contributions plus actual earnings thereon is based on years of continuous service and vests at an equal rate per year over three years of credited service, defined as 1,000 hours of service during the Plan year. In the event of death, disability, or retirement, a participant's account becomes fully vested.

#### ***Notes Receivable from Participants***

Participants may borrow from their vested fund account balance a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear a fixed interest rate based on the prevailing interest rates charged by persons in the business of lending money. The interest rate for loans outstanding at December 31, 2022 and 2021 ranged from 4.25% - 6.50%. The period of repayment cannot exceed 5 years for a general purpose loan or 15 years for a primary residence loan. Principal and interest are paid ratably through regular payroll deductions for actively employed participants.

#### ***Payment of Benefits***

Distributions as a result of normal retirement (the later of attainment of age 65 or five years of participation in the Plan), early retirement (age 55 and five years of service), death, disability, or termination are paid upon request for distribution by the participant or beneficiary.

Terminated participants with vested account balances of less than \$1,000 are subject to an involuntary lump-sum distribution if they do not submit distribution instructions in a timely manner. The Plan also contains mandatory distribution provisions, which allow for the automatic rollover to an individual retirement account established in the name and for the benefit of the participant of a terminated participant's account if the vested account balance exceeds \$1,000, but is less than \$5,000. These automatic rollovers are completed only if the participant does not request a distribution from the Plan in a timely manner following their termination.

Terminating participants whose vested account balance exceeds \$5,000 and who are receiving their distribution before normal retirement age may elect to receive their distribution as a lump-sum payment in cash, in installments, or via ad-hoc requested distributions.

In-service withdrawals of a participant's vested account balance may be made by participants who have attained the age of 59½. Hardship withdrawals from a participant's deferral contribution account are permitted when certain criteria are met. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time. Per Internal Revenue Service ("IRS") regulations, participants are required to take a minimum required distribution by April 1 of the year following the year they reach age 72.

#### ***Forfeited Accounts***

Forfeitures of any Company contributions are first used to reduce the Company contributions for that year, if any, and/or to pay for administrative expenses incurred by the Plan, with the remainder being allocated among participants. The Company used forfeitures of \$74,733, to reduce employer matching contributions to the 2022 plan year. As of December 31, 2022 and 2021, unallocated Plan forfeitures outstanding were \$0 and \$34,453, respectively.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Method of Accounting***

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

***Investment Valuation and Income***

The investments of the Plan are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See also Note D for discussion of fair value measurements and investment valuation.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Under the terms of the Plan, expenses relating to the Plan may be paid by either the Company or the Plan, at the discretion of the Company. As noted above, forfeitures of any Company contributions may also be used to pay for administrative expenses incurred by the Plan. Administrative fees are paid by the Plan or Plan Sponsor, with the exception of participant fees, loan set-up and maintenance fees, overnight fees, short-term, and annual fees, which are paid by the participants.

**NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, FMTC, the Trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2021.
- Net investment loss and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.

#### NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Mutual funds are presented at fair value based on the net asset value (“NAV”) as of the close of each business day. This unadjusted quoted price is readily observable in active markets. As such, these are categorized as Level 1 within the fair value hierarchy.
- The Plan's investments in collective investment trust funds uses the NAV as a practical expedient to determine the fair value of the collective trust funds. The NAV for the trust funds are based on the fair value of the underlying investments held by the fund less their liabilities. Redemption for the trust funds is permitted daily with no other restrictions or notice periods and there are no unfunded commitments.

**NOTE E - FEDERAL INCOME TAX STATUS**

The Company has adopted a non-standardized prototype plan and trust document. The prototype plan received an IRS opinion letter dated June 30, 2020 in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator still

believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC and, as such, is exempt from Federal income tax.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE F - PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by the Trustee. These transactions and loans made to participants, qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. All of these related party and party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**NOTE G - PLAN MERGERS**

Effective December 30, 2022 all assets of this Plan were transferred into the Open Text, Inc. 401(k) Plan. On December 30, 2022, assets totaling \$48,479,787 were transferred and participants' accounts were mapped from existing fund options to the investment lineup of the Open Text, Inc. 401(k) Plan at FMTC. Participants began contributing to the Open Text Plan in January 2023.

**NOTE H - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**
