Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Plan Sponsor, Fusion Alliance, LLC, voted to terminate the Plan, effective August 31, 2022, and management determined liquidation is imminent. As a result, the Plan has used the liquidation basis of accounting as of December 31, 2022. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Fusion Alliance, LLC 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1: Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Fusion Alliance, LLC (Company) for the benefit of its employees who are age 21 or older and have completed one hour of service. Related employers who also participate in the Plan include Fusion Technologies, LLC; FusionSoft, LLC; and Fusion Technologies - East, LLC. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company (Principal) is the trustee of the Plan.

Effective August 31, 2022, the Company terminated the Plan. At that time, participants were 100% vested in all of their accounts. Final distributions to participants occurred in June 2023.

Contributions

Prior to August 31, 2022, the Plan permitted eligible employees through a salary deferral election to make annual contributions of up to 100% of eligible compensation. Employee Roth and rollover contributions were also permitted. The Plan Document allowed discretionary matching contributions of employee's salary deferral amounts.

Prior to August 31, 2022, the Company could also make profit-sharing contributions for those participants with one or more years of service if determined by the Company's Board of Directors. Associate employees who are defined as professional hourly employees were excluded from matching and discretionary contributions and forfeiture allocations. Contributions are subject to certain limitations. Forfeitures of matching contributions are used to reduce Company contributions.

Prior to August 31, 2022, the Plan included an automatic deferral feature whereby new participants were treated as electing to defer four percent of eligible compensation unless the participant made an affirmative election otherwise. Participants who were automatically enrolled had an automatic increase of 1% each January 1, up to a maximum automatic deferral contribution of 10%.

Participant Investment Account Options

Investment account options available include various funds. Prior to August 31, 2022, each participant had the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Prior to August 31, 2023, vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after five years of continuous service. The nonvested balance was forfeited upon termination of service. The Company had the option to use forfeitures first to reduce administrative expenses and then to reduce Company contributions. Effective August 31, 2022, as stated in General section of Note 1, participants were 100% vested in all of their accounts.

Forfeitures used to reduce Company contributions were \$138,774 and \$215,893 during 2022 and 2021, respectively. Forfeitures totaling \$48,080, \$909 and \$419 were used to pay Plan expenses during 2023, 2022 and 2021, respectively. The Company has approximately \$0, \$46,790 and \$4,588 in forfeited amounts at June 5, 2023, December 31, 2022 and 2021, respectively.

Payment of Benefits

Upon termination of service, a participant can elect to receive a lump-sum amount equal to the value of his account. Withdrawals may also be made when a participant attains age 59 1/2 or demonstrated financial hardship as defined by the Plan Document. An employee may withdraw all or portion of his account balance attributable to after-tax or rollover contributions at any time. Prior to a withdrawal of pre-tax deferrals, catch-up contributions or Roth contributions, a participant must withdraw all available after-tax contributions.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Note 2: Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in the collective trust is valued at NAV based on information using the financial statements of the fund at year-end. The NAV is used as a practical expedient to estimate fair value. The investment may be redeemed daily and has no unfunded commitments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a 401(k) Volume Submitter Plan sponsored by Principal Life Insurance Company. The Plan has not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the prototype plan document has a favorable opinion letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the employer or the Plan, at the employer's discretion.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021
- Investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the period ended June 5, 2023, and years ended December 31, 2022 and 2021
- Investment information and participant loans included in the accompanying schedule of assets (held at year end) as of December 31, 2022

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2022 or the period ended June 5, 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 investments.

Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan currently invests in a variety of funds related to the Plan trustee and custodians. The Plan paid \$128,899 and \$147,641 in recordkeeping fees to the trustee during 2022 and 2021, respectively. The 2022 amount includes \$65,329 of expenses accrued for 2023's expenses to be incurred in liquidation. The Company provides certain administrative services at no cost to the Plan.

The Plan has a revenue-sharing agreement with the Plan trustee. Revenue-sharing reimbursements recorded during 2021 totaled \$129,952 and is netted against administrative expenses. There were no revenue-sharing reimbursements recorded in 2022. The Plan uses the revenue-sharing to pay for the Plan expenses above. Funds not used to pay expenses are allocated to Plan participants.
