Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended December 30, 2022, and the related notes to the financial statements (collectively, the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 30, 2022 and December 31, 2021, and for the period ended December 30, 2022, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.



- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – PLAN DESCRIPTION

The following description of the Bachman Services, Inc. Savings and Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan Sponsor is Bachman Services, Inc. and other adopting employers are Bachman Drilling and Production Specialties, Inc., Bachman Production Specialties, Inc., Specialty Intermediates, Inc., and Strata Control Services, Inc., all of which are collectively hereafter referred to as “Employer” or “Company.”

The Plan was established on July 1, 1980 and is a defined contribution plan covering substantially all employees of the Company. The Plan was amended on June 1, 2022 to adopt a new prototype plan sponsored by Empower Retirement LLC (“Empower”).

On December 23, 2022, the board of directors approved the merger of this Plan into the Innospec 401(k) and Profit-Sharing Plan (“Innospec Plan”). Accordingly, all assets were transferred from the Plan on December 30, 2022 (the “Merger”).

In connection with the Merger, the Board of Directors voted to freeze the Plan effective December 23, 2022 (the “Freeze”). As a result, new participants were not allowed to enter the Plan and all contributions were ceased for existing participants from December 23, 2022 through December 30, 2022.

Prior to the Freeze, the purpose of the Plan was to provide employees with retirement benefits. The Plan was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As defined in the Plan Document, an employee is eligible to participate in the Plan upon being hired, the employee may enroll in the Plan on the first day of each payroll period following the date of hire unless the Company is notified otherwise by the employee.

Contributions

Prior to the Freeze, each year, participants could elect to defer 75% of their pretax annual compensation, as defined in the Plan, through salary deductions; however, annual contributions could not exceed the maximum allowed under the Internal Revenue Code. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“Rollover”).

Prior to the Freeze, the Plan included a Roth 401(k) feature which allowed Participants to contribute funds on a post-tax elective deferral basis, in addition to, or instead of pre-tax elective deferrals. The Roth 401(k) feature allowed for tax-free growth and distributions provided that the post-tax contributions had been vested for at least five years and the Participant has reached the age of 59 ½.

Prior to the Freeze, the Company’s safe harbor matching contributions are equal to 100% of the Participants’ salary deferrals up to 3% of their eligible compensation plus 50% of their salary deferrals between 3% and 5% of their eligible compensation. For the period ended December 30, 2022, the Company made safe harbor contributions of \$245,480. The Company has the option to make annual discretionary profit-sharing contributions which are allocated to participants based on the relative compensation of all participants eligible to receive a discretionary profit-sharing contribution. For the period ended December 30, 2022, no discretionary profit-sharing contributions were made.

NOTE 1 – PLAN DESCRIPTION - CONTINUED

Participant Accounts

Prior to the Merger, individual accounts were maintained for each participant. Participant accounts were credited with participant contributions, rollover contributions, an allocation of the Company's safe harbor matching and discretionary contributions, an allocation of investment earnings and losses, and charged with withdrawals and administrative fees. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

Vesting

Prior to the Merger, participants were immediately vested in their voluntary contributions, rollover contributions, Company's safe harbor matching contributions and actual earnings or losses thereon. Vesting in the Company's discretionary matching, and non-elective contributions portions of a participant's account plus actual earnings thereon was based on years of continuous service. A participant was 20% vested after one year of service, increasing 20% each year thereafter until becoming fully vested after five years of service as defined in the Plan Document. However, if a participant died, or became disabled prior to attaining the normal retirement age, or attained normal retirement age as defined by the Plan, the participant's account became 100% vested if still employed by the Company as of such date.

Investment Options

Prior to the Merger, upon enrollment in the Plan, participants directed the investment of their individual accounts among alternative investment funds provided under the Plan. Participants could change their investment elections at any time, as well as transfer existing balances between investment funds.

Notes Receivable from Participants

Prior to the Merger, participants could borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions were treated as a transfer between investment funds and the loan fund. Loan terms range from 1-5 years or up to 15 years for the purchase of a primary residence. The maximum number of loans that a participant could have at any one time is one. Loan repayments were made by check or payroll deduction. Loans were secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator.

Payment of Benefits and Withdrawals

Prior to the Merger, upon termination of service due to death, disability or normal retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's full account balance, regardless of years of credited service. For termination due to other reason, participants could receive the sum of their contributions and any earnings thereon, plus the vested portion of Company contributions. Payments of benefits were made, at the election of the participant, in the form of an annuity, a lump sum distribution, or installment payments.

Prior to the Merger, a hardship withdrawal, if approved could be made on employee deferral contributions to satisfy certain immediate and heavy financial needs, as defined, up to the amount of the participant's vested balance. Upon normal retirement age of 59 ½ or upon early retirement age of 55 and completing three years of service, an unrestricted withdrawal could be made on all or a portion of the participants' vested account.

Forfeitures

At December 31, 2021, there was no balance in the forfeited non-vested accounts. Prior to the Merger, forfeitures were retained in the Plan and must first be used to reduce the Plan's administrative expenses and then used to reduce Company matching contributions. During 2022, \$22,367 of forfeitures were used to pay administrative expenses. No forfeitures were used to reduce Company matching contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement for the portion of the net asset available for benefits attributable to fully benefit-responsive investment contracts. Contract value is the amount participants would receive if they were to initiate permitted transaction under the terms of the Plan. As described further in Note 4, the Plan's investment contract at December 31, 2021 is fully benefit-responsive and reported at contract value.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfers a liability in an orderly transaction between market participants at the measurement date. The net change in fair value of investments is reported in the statement of changes in net assets available for benefits in the period of the change.

Purchases and sales of securities are recorded on a trade-date basis. Expenses related to the purchase or sale of investments are added to cost or deducted from proceeds. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 30, 2022 and December 31, 2021. Prior to the Merger, if a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Payment of Benefits

Prior to the Merger, benefit payments to participants are recorded when paid.

Expenses

Prior to the Merger, certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net depreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Due to the Merger, the Plan did not hold any assets as of December 30, 2022. The following is a description of the valuation methodologies used for assets measured at fair value for the year ended December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

Prior to the Merger, the Plan held a fully benefit-responsive investment contract with Mass Mutual Life Insurance Company (“Mass Mutual”). Mass Mutual maintained the contributions in a guaranteed interest general account. The account was credited with earnings on the underlying investments and charged for participant’s withdrawals and administrative expenses. Mass Mutual was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. As described in Note 2, because the insurance contracts were fully benefit-responsive, contract value was the relevant measurement attributable for that portion of the net assets available for the benefits attributable to the insurance contract. Contract value, as reported to the Plan by Mass Mutual, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contracts had certain restrictions that impacted the ability to collect the full contract value for certain events. Mass Mutual could not terminate the Funds at any amount less than contract value.

NOTE 5 – ADMINISTRATION OF PLAN ASSETS

For the year ended December 31, 2021 and for the period from January 1 through May 31, 2022, the Plan’s assets were held by Reliance Trust Company (“Reliance”). For the period from June 1, 2022 through December 30, 2022, the Plan’s assets were held by Empower Trust Company, LLC (“ETC”).

Reliance and ETC are collectively hereafter referred to as the “Custodians”.

For the year ended December 31, 2021 and for the period from January 1 through September 9, 2022, the Plan’s administrative functions were performed by Mass Mutual. For the period from September 10, 2022 to December 30, 2022, the Plan’s administrative functions were performed by Empower.

Prior to the Merger, certain administrative expenses, including loan administration fees, were paid by the participants. Other administrative expenses, such as accounting and legal fees, were paid by the Company.

NOTE 6 – INFORMATION CERTIFIED BY THE CUSTODIANS (UNAUDITED)

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

For the year ended December 31, 2021 and prior to the Merger, the Plan had notes receivable from participants. As a result, these notes and all transactions related to these notes qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Prior to the Merger, the Plan’s investments were managed by the Custodians and, therefore, these transactions qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Prior to the Merger, the Plan incurred expenses related to general administrative, recordkeeping, and investment advisory services. Fees paid by the Plan for these services totaled \$58,879 for the period ended December 30, 2022. These transactions are exempt from being prohibited transactions by ERISA.

NOTE 8 – FEDERAL INCOME TAX STATUS

Prior to the Merger, the Plan was a Prototype Plan sponsored by Empower. Empower received a determination letter from the Internal Revenue Service (“IRS”), dated November 14, 2022, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code. The Prototype Plan has been amended since receiving the determination letter. The Plan itself had not received a determination letter from the IRS. However, the Plan’s management and tax counsel believed that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income tax has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s management believes it is no longer subject to income tax examinations for years prior to 2019.

NOTE 9 – RISKS AND UNCERTAINTIES

Prior to the Merger, the Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of the investment securities could occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
