Scope and Nature of the ERISA Section 103(a)(3)(C) Audits for the Financial Statements

We have performed audits of the accompanying financial statements of Engineered Controls International, L.L.C. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2022 and December 31, 2021, and for the period from January 1, 2022 to December 30, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Engineered Controls International, L.L.C. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Engineered Controls International, L.L.C. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued. As discussed in Note 1 to the financial statements, the Plan decided on January 31, 2022 to merge into the acquiring companies Plan effective January 1, 2023, and all assets were transferred into the acquiring plan on December 30, 2022.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Engineered Controls International, LLC Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger

On December 29, 2021 the Plan sponsor was acquired by the Dover Corporation. By resolutions adopted on January 31, 2022, the Board of Directors of Engineered Controls International, LLC voted to merge the Plan into the Dover Corporation Retirement Savings Plan effective January 1, 2023 and Plan participants became eligible to participate in the newly merged retirement plan. All net assets were transferred out of the Plan and into the Dover Corporation plan on December 30, 2022.

General

Prior to date of planned merger, the Plan was a defined contribution plan covering substantially all employees of Engineered Controls International, LLC and Superior Products, LLC (collectively, the "Company" or the "Sponsor"). Employees were eligible to enter the Plan on the first of the month after having completed three months of eligibility service. The Plan Committee was responsible for oversight of the Plan. The Plan Committee determined the appropriateness of the Plan's investment offerings, and monitored investment performance. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Prior to date of planned merger, participants were able to contribute up to 92% of their pretax annual compensation, as defined in the Plan. Participants were also able to make qualified Roth contributions to the Plan and were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan, including a common collective trust, a money market fund, and various mutual funds.

Until September 27, 2021, the Plan contained a discretionary match provision. After September 27, 2021 until date of planned merger, the Plan made qualified non-elective safe harbor contributions equal to 100% of the first 3% of the participant's compensation contributed to the Plan and 50% of the next 2% of the participant's compensation contributed to the Plan. The Company could also make discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions for the period January 1, 2022 to December 30, 2022. Contributions were subject to certain IRS limitations.

Prior to date of planned merger, the Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also included an auto-escalation provision whereby participants were subject to an annual automatic deferral rate increase of 1% until their deferral rate reached 7% of eligible compensation. Participants could elect to discontinue their participation in the automatic deferral rate increase at any time. All participant and employer contributions were participant-directed.

Participant Accounts

Prior to date of planned merger, each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, and the Sponsor's matching contributions, as well as allocations of any profit-sharing contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Prior to date of planned merger, participants were vested immediately in their contributions, including amounts rolled over from other qualified plans, plus actual earnings thereon. Participants were vested immediately in the Sponsor's matching contribution portion of their account plus earnings thereon. Vesting in the discretionary profit-sharing contributions and any actual earnings thereon was determined using a progressive schedule based on years of service. This contribution was subject to a six-year graded scale by which a participant was fully vested after six years of credited service. Participants also became fully vested at normal retirement age or due to death or disability while employed, as defined by the Plan.

Notes Receivable from Participants

Prior to date of planned merger, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The participant's available balance for loans was limited to the participant's vested employee portion of total account balance. The loans were secured by the balance in the participant's account and bore interest at the prime rate at the time of issuance, which was commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

Prior to date of planned merger, participants were entitled to receive lump-sum, installment, or partial payments of all or any portion of their vested account balance upon attainment of age 59½. If a participant's vested interest did not exceed \$5,000, a lump-sum distribution was made regardless of whether the participant consented to receive the payment. Participants were permitted to take hardship distributions from selected accounts, as defined by the Plan, upon demonstrations of financial hardship.

Forfeitures

Prior to date of planned merger, at December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$-0- and \$72,025, respectively. Forfeited nonvested accounts could be used to reduce future employer contributions or fees. In 2022, fees were reduced by \$1,081 from forfeited nonvested accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 30, 2022 or December 31, 2021.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included with the loan principal amount in notes receivable from participants. Expenses not paid by the Company are paid using the Plan's assets and will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 11, 2023, which is the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable held at December 30, 2022 and December 31, 2021, and net appreciation/depreciation in fair value of investments, and interest and dividends for the period from January 1, 2022 to December 30, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 - *Fair Value Measurement* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 30, 2022.

Money market and mutual funds: Valued at the daily closing price as reported by the fund. The money market and mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There are certain participant redemption restrictions for the investment with respect to exchanges in investment options. Transferred investment funds must be held in a non-competing investment option for 90 days before subsequent transfer to a competing fund can occur. There are no participant redemption restrictions over withdrawals for this investment; the redemption notice period is applicable only to the Plan.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of a common collective trust and mutual funds managed by Fidelity Management Trust Company, subsidiaries, and affiliated companies, therefore, these transactions qualified as party-in-interest transactions. Fees incurred by the Plan for the investment management services were included in net appreciation or depreciation in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. The Company paid directly any other fees related to the Plan's operations.

NOTE 7 - PLAN TERMINATION

The Board of Directors elected to merge the Plan as of January 1, 2023, and all Plan assets were transferred into the Dover Corporation Retirement Savings Plan on December 30, 2022.

NOTE 8 - TAX STATUS

The Plan adopted a prototype plan sponsored by FMR LLC. The Internal Revenue Service has issued an opinion letter to Fidelity dated June 30, 2020, that the prototype plan document was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since adopting the prototype plan, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 30, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits.
