Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Constellation Pharmaceuticals 401(k) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2022, and the related notes to the financial statements.

CONSTELLATION PHARMACEUTICALS 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of Constellation Pharmaceuticals 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General and Plan Merger: The Plan was a defined-contribution plan established on February 1, 2009, to provide retirement and other related benefits to substantially all employees of Constellation Pharmaceuticals. In August 2021, Constellation Pharmaceuticals was acquired by MorphoSys US, Inc which took over as Plan Sponsor. Employees became eligible to participate for purposes of salary reduction contributions immediately upon hiring. Employees who were leased employees, temporary employees, interns, and employees whose terms of employment were governed by a collective bargaining agreement were not eligible to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On December 30, 2022, the Plan Administrator executed the directive to merge the assets of the Plan into the MorphoSys US Inc 401(k) Plan (“MorphoSys Plan”). This triggered a blackout period in which Participants could not direct their investments. The assets were in transit on December 31, 2022 and posted to participant accounts in the MorphoSys Plan on January 3, 2023. Participants were notified that their account balances would be automatically transferred.

Plan Termination: The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Participant Contributions: Each year, participants could contribute an amount up to a certain percentage of their pretax annual compensation, as defined in the Plan. Participants who had attained the age of 50 before the end of the Plan year were eligible to make catch-up contributions as prescribed by Treasury regulations. Participants, with the consent of the Plan Administrator, could deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers.

Employer Contributions: The Company made matching employer contributions on behalf of the Plan's participants. For the year ended December 31, 2022, the Company made matching contributions equal to 50% of the first 6% of deferrals contributed by a participant into the Plan. Participants were 100% vested in these contributions when made.

The Company could also have made a discretionary non-elective matching contribution to the Plan. A participant must have been employed on the last day of the Plan year to be eligible to receive a non-elective discretionary matching contribution unless the employee was terminated due to death, disability or retirement. There was no discretionary employer contribution for the year ended December 31, 2022.

CONSTELLATION PHARMACEUTICALS 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts: Each participant's account was credited with the participant's contributions and an allocation of employer contributions and Plan investment earnings or losses and charged with an allocation of administrative expenses. Allocations of earnings or losses were based on account balances, as defined. Discretionary non-elective matching contributions were based on employee compensation amounts. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Investment Options: Participants directed the investment of their contributions into various investment options offered by the Plan. In addition to mutual funds, the Plan offered the ability to establish a self-directed brokerage account allowing participants to invest in a wide array of investment securities. Furthermore, the Plan also offered participants a voluntary managed account service that selected and managed the investment options in the Plan to create an approach based on one's time horizon for retirement and/or risk tolerance and financial situation.

Vesting: Participants were immediately vested in their voluntary contributions, employer contributions and any actual earnings thereon.

Notes Receivable from Participants: Participants could borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan transactions were treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Notes receivable terms could not exceed five years unless for the purchase of a primary residence. Loans were secured by the balances in the participants' accounts and were supported by a promissory note. Loans bore interest at rates based on the prevailing interest rates charged by persons in the business of lending money for loans that would be made under similar circumstances. Principal and interest were paid ratably usually through semimonthly payroll deductions.

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or periodic installment distributions. If a participant terminated employment for any reason, his or her account became 100% distributable if below \$5,000.

A participant could also request a withdrawal upon attainment of age 59 ½, or upon demonstration by the participant to the Plan Administrator that the participant was suffering from a hardship, as defined in the Plan document. The hardship withdrawals were subject to a minimum of \$500.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements were prepared using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("GAAP"). Under the modified cash basis of accounting, investments were recorded at fair value, contributions were recorded when received and benefits were recorded when paid. The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the Department of Labor ("DOL"). The financial statements and supplementary schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

CONSTELLATION PHARMACEUTICALS 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determined the Plan's valuation policies utilizing information provided by the investment advisers, Trustees and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net depreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting required Plan management to make estimates and assumptions that affected the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan utilized various investment instruments. Investment securities, in general, were exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities would occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefit payments to participants were recorded when paid.

Notes Receivable from Participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses has been recorded as of December 31, 2022, or 2021.

Uncertain Tax Positions: The modified cash basis required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan had taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator had analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

CONSTELLATION PHARMACEUTICALS 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 3: TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan had not received a determination letter specific to the Plan itself; however, the Plan Administrator believed that the Plan was designed and was currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

However, an operational failure was identified during the year ended December 31, 2021, in which participants' deferral percentage elections were not properly carried out through payroll withholdings or could not be substantiated. No provision for income taxes has been included in the Plan's financial statement as Plan management took the necessary corrective action in 2022 in accordance with applicable IRS and DOL regulations.

NOTE 4: CERTIFICATION OF TRUSTEE

The Plan Administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, the Trustee certified that the following data included in the accompanying financial statements was complete and accurate.

NOTE 5: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. There were no assets at fair value at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded. At December 31, 2021 all investments held in the self-directed brokerage accounts were in mutual funds.

Common stock: Valued at the closing price reported on the active market on which the individual securities were traded.

NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

There were no assets held for investment at December 31, 2022.

NOTE 6: RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments were shares of mutual funds advised by Fidelity Management & Research Company ("FMR"), an affiliate of Fidelity Management Trust Company ("FMTC"), the Trustee as defined by the Plan. Fidelity Investments Institutional Operations Company, the Plan's recordkeeper, is also an affiliate of FMR and FMTC. Commonwealth Financial Networks served as the Plan's investment advisor. Transactions with these entities qualified as party-in-interest transactions. Fees paid by the Plan to these parties for services in connection with the Plan were reported as administrative expenses in the statement of changes in net assets available for benefits. The Plan extended loans to participants who were considered parties-in-interest. These party-in-interest transactions were exempt from prohibitive transaction rules.

NOTE 7: LATE REMITTANCES

As reported on Form 5500, Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions - Modified Cash Basis, certain participant contributions were not remitted to the Plan within the time frame specified by the DOL's regulations, thus constituting nonexempt transactions between the Plan and the Company. The late remittances amounted to \$362 and \$4,703 for the years ended December 31, 2022 and 2021, respectively. The Company is in the process of correcting these late remittances in accordance with DOL regulations and participant balances will be made whole in the MorphoSys Plan.
