Note 1 – Description of Plan

The following description of the Visiting Nurse Association Community Healthcare, Inc. (the Company) 403(b) Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

The Company merged with Home Care Plus, Inc (Plus), on May 22, 2022 and as such the Company ceased to exist. The Board of Directors of the Company (on advice of counsel), collectively, continued their fiduciary responsibility for the Plan, along with assistance from Plus. The Plan has wound down the operations of the Plan by distributing the Plan assets in the form of taxable distributions or qualified rollovers, as instructed by participants. A final IRS Form 5500 along with a final audit was prepared for the year ended December 31, 2022.

General

The Plan was a defined contribution plan sponsored by the Company under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 403(b) of the IRC, for the benefit of substantially all employees of the Company and its affiliates, excluding employees covered under collective bargaining agreements, and nonresident aliens. Participants were eligible to enroll on the first date of employment. For employer contributions, eligibility required the completion of one year of service, as defined as twelve consecutive months during which an employee had at least 1,000 hours of service, provided they were at least 21 years of age. The entrance date for employer contributions was the first day of January, April, June, and September following an employee attaining the eligibility requirements. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

The Plan was administered by a Retirement Plan Committee, comprised of employees of the Company. The Retirement Plan Committee reported to the Finance Committee of the Board of Directors of the Company. The custodian, Reliance Trust Company, was responsible for the custody and management of the Plan's assets. StanCorp Investment Advisors provided management advisory services for the Plan investments, the Standard Insurance Company was the recordkeeper for the Plan, and PASI, LLC was the third-party Plan Administrator.

Contributions

Each year, participants could elect to contribute up to 100% of their annual compensation, as defined by the Plan, as voluntary, pretax and/or after tax Roth contributions to the Plan, not to exceed the permitted Internal Revenue Code (IRC) dollar limits. Participants who had attained age 50 before the end of the Plan year were eligible for catchup contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Contributions – Cont'd

The company could make discretionary nonelective contributions on behalf of each eligible participant in an amount equal to a percentage of each eligible participant's compensation at the option of the Company's Board of Directors. To share in the nonelective contribution, participants had to be employed on the last day of the plan year. No nonelective contributions have been made since June 2018. The Company could make discretionary matching contributions equal to a uniform percentage of elective deferrals, for each payroll period. Each year, the Company determined the formula for the discretionary matching contribution, which was at 2%, effective with pay period ended September 6, 2019. The participant contributions and the Company contributions were allocated to mutual funds or the stable value fund, as the participant directed.

Participant Accounts

Individual accounts were maintained for each of the Plan's participants to reflect the participant's contributions and related employer contributions, as well as the participant's share of the Plan's income and any related investment fund administrative expenses. Allocations of income and investment fund administrative expenses were based on the proportion that each participant's account balance bore to the total of all participant account balances. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were fully vested in their contributions and the Company's nonelective and matching contributions, and the earnings thereon.

Notes Receivable From Participants

A participant could borrow from his or her account a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must have had a definite repayment period, amortized on a level basis, not to exceed five years. The loans were secured by the balance in the participant's account and bore interest at a reasonable interest rate. Principal and interest were paid through payroll deductions, but participants could make additional payments directly to the Plan. The loans were classified as "Notes Receivable From Participants," and were measured at unpaid principal balance plus accrued, but unpaid, interest.

Payment of Benefits

Upon retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) could elect to receive a lump sum distribution equal to the participant's vested account balance. Participants may withdraw their account balances upon attaining age 59 ½. In addition, hardship distributions were permitted if certain criteria were met.

Investment Yield

The Stable Asset Fund crediting rates were 2.37% and 2.21% for the years ended December 31, 2022 and 2021, respectively, in accordance with the terms of the contract between the Company and the Standard Insurance Company. The minimum Guaranteed Interest Account yield was designed to produce a reasonable balance between rate responsiveness and rate stability, while allowing for normal benefit payments to be made. The rate could move up or down from quarter to quarter depending on economic conditions. Interest on the account balance was credited daily. A current interest rate was declared on each successive calendar quarter, and the announced rate stays in effect through the end of the following calendar year for contributions received during that calendar quarter. Quarterly, the Standard Insurance Company announced new rates to be credited to funds.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for a discussion on fair value measurement.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2021.

Payments of Benefits

Benefit payments were recorded when paid. There were no withdrawals approved but not paid as of December 31, 2022 and 2021.

Administrative Expenses

Certain expenses incurred maintaining the Plan were paid directly by the Company and are excluded from these financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Subsequent events were evaluated through September 15, 2023, which is the date the financial statements were available to be issued.

Note 3 – Information Prepared and Certified by the Plan's Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Reliance Trust Company is the custodian of the Plan. Accordingly, the custodian has certified to the Plan administrator that, as of December 31, 2022 and 2021, and for the years then ended, the following information is complete and accurate, which can be relied upon by the Plan administrator in preparation of the Plan's financial statements and related supplemental schedule.

**Investments**

- The cost, fair value and/or contract value; and
- The purchase and sale activity, including gains and/or losses.

**Investment Income**

- The amount of interest and dividend income received;
- Net appreciation (depreciation) in the fair value of investments credited to the Plan, in total and by fund; and
- The amount of income from guaranteed accounts.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2022 and 2021.

*Mutual Funds*

The fair value of mutual funds is based on the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 – Investment Contract with Insurance Company

The Plan had a benefit-responsive investment contract with The Standard Insurance Company ("The Standard"). The Standard maintained contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

As described in Note 2, because the stable asset fund was fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by The Standard, represents contributions made, plus earnings, less withdrawals and administrative expenses, plus interest credited. Daily liquidity was available for participant contributions and withdrawals regardless of market conditions.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the stable asset fund, as reported to the Plan by The Standard as of December 31, 2022 and 2021 was \$0 and \$2,060,944, respectively, which approximated fair value. The crediting interest rate was locked in and guaranteed not to change for an entire quarter and was never to be below 1% annually. Such interest rates were reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. The plan administrator believes it is improbable that any events would limit the Plan's ability to transact at contract value.

The stable asset fund permitted the insurance company to terminate the contract with 30 days advance notice for reasonable cause. Upon termination by The Standard, a market value adjustment or other withdrawal restrictions may have applied.

Note 6 – Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments were shares of a fund managed by The Standard Insurance Company. The Standard Insurance Company provides the record keeping for the Plan and, therefore, qualifies as a party-in-interest to the Plan.

The Company provided certain accounting and administrative services to the Plan, for which no fees were charged.

Note 7 – Plan Termination

The Plan was terminated effective December 31, 2022. The Company did have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. (See Note 2)

Note 8 – Tax Status

The Plan documents have been drafted in reliance on sample language provided by the Internal Revenue Service. The Plan administrator intended to apply for a determination on the Plan when the government opened such a program. The Plan was required to operate in conformity with the Internal Revenue code to maintain its tax exemption.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
