NOTE A - DESCRIPTION OF PLAN

The following description of the AXH Air Coolers 401(k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan. All employees of AXH Holdings, LLC (“the Company”) who have completed the applicable minimum level of service and who are age nineteen or older during the year are eligible to participate. Office employees must complete a minimum of six months of service. Shop employees must complete a minimum of twelve months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Participant Contributions

Participants may contribute a dollar amount or specific percentage of defined earnings subject to certain annual limitations set by the Internal Revenue Service (\$20,500 for 2022). Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants ages 50 and over as of year-end are eligible to make catch-up contributions to the extent permissible under law and regulations.

Employer Contributions

Effective May 1, 2021, the Plan was amended to add employer matching contributions equal to 100% of the employee’s salary-deferred 401(k) contributions, up to a maximum of 5% of the employee’s compensation. Effective January 1, 2022, the Plan’s safe harbor provisions were enacted. The Company may also make a discretionary profit-sharing contribution to participants who are eligible as of the end of the year. The profit-sharing contribution is allocated based on an integrated formula of participant’s compensation as a percentage of total compensation. The Company elected not to make discretionary profit-sharing contributions for the years ending December 31, 2022 and 2021.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Company’s contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

All deferred employee contributions and earnings thereon are 100% vested to the participants at all times. In addition, participants are 100% vested in the Company's matching contributions. Participants vest in any discretionary Company profit sharing contributions ratably from the second to sixth year of service. Participants may withdraw amounts that have been rolled into the Plan from other qualified retirement plans at any time.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or other qualified payments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Under certain circumstances, the Plan permits withdrawals while participants are still employed.

Hardship Withdrawals

Participants may make withdrawals in the event of financial hardship. Participants may take hardship distributions for payment of the following:

- expenses for medical care incurred by the participant, their spouse, their dependents, or certain beneficiaries,
- costs directly related to the purchase of a principal residence, excluding mortgage payments,
- tuition, related educational fees, and room and board expenses for the next twelve months of post-secondary education for the participant, their spouse, their dependents, or certain beneficiaries,
- amounts necessary to prevent eviction or foreclosure from the principal residence of the participant,
- payments for burial or funeral expenses for the parent, spouse, children, or other dependents or beneficiaries of the participant,
- expenses for the repair of damage to the principal residence that would qualify for the casualty deduction under the Internal Revenue Code.

Forfeited Accounts

Forfeited account balances may be used to pay Plan expenses or reduce employer contributions to the Plan. Forfeited accounts totaling \$7,890 and \$0 were used to fund additional employer contributions or offset Plan expenses for the years ending December 31, 2022 and 2021, respectively. At December 31, 2022 and 2021, unused forfeited non-vested accounts totaled \$79,577 and \$37,128, respectively.

Plan Expenses

The Company provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan Sponsor and include accounting and audit fees. Administrative expenses incurred by the Plan include investment management fees which are netted against investment returns.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value using quoted market prices. Shares of mutual funds are valued at the daily closing price, as provided by the fund, for shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Management Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, the reported amounts of additions and deductions to net assets available for benefits during the reporting period and the related disclosures. Accordingly, actual results could differ from those estimates.

NOTE C – TRUSTEE CERTIFICATION

The Plan Administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by Capital Bank and Trust Company, the trustee and record keeper, as of December 31, 2022 and 2021, and for the year ended December 31, 2022.

The information certified by the trustee was the annual report and accounting as of December 31, 2022 and 2021, and for the year ended December 31, 2022, which includes beginning and ending balances of investments, and a detailed listing of the transactions in the various funds, including investment earnings.

NOTE D - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The Plan has implemented FASB ASC 820-10-50-2, *Fair Value Measurements*. FASB ASC 820-10-50-2 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-50-2 are described below:

Basis of Fair Value Measurements

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following table presents by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2022 and 2021. As required by FASB ASC 820-10-50-2, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

NOTE E - TAX STATUS

The Plan has adopted a volume submitter plan. The Plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the Plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan's administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer contribution portion of their accounts.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

ERISA, Title I, Section 412, generally requires, unless there is an exception, every fiduciary and every person who handles funds or other property of a plan be bonded. The Department of Labor (DOL) requires the bond to be equal to 10% of the funds handled or \$500,000, whichever is the lesser with a minimum of \$1,000. The Plan was in compliance with Section 412 as of December 31, 2022 and 2021.

NOTE H - RELATED-PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by the trustee. Transactions from these investments qualify as party-in-interest transactions. The transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

NOTE I - SUBSEQUENT EVENTS

The Company has evaluated subsequent events and their related disclosures through October 11, 2023 which coincides with the financial statement issuance date and identified no such events.
