Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Eclipse Advantage, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 24, 2023, December 31, 2022 and December 31, 2021, the related statements of changes in net assets available for benefits for the period ended January 24, 2023, and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of January 24, 2023, December 31, 2022 and December 31, 2021, and for the period ended January 24, 2023, and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Merger

As discussed in Note 1 to the financial statements, the Board of Directors of Eclipse Advantage, LLC, the Plan's sponsor, voted on November 4, 2022, to merge the Plan into the Successwise Pooled Employer 401(k) Plan effective January 24, 2023. All plan assets and accumulated plan benefits were transferred to the control of Successwise Pooled Employer 401(k) Plan on January 24, 2023. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the Eclipse Advantage, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was adopted effective January 1, 2014. The Plan is a defined contribution plan covering all employees of Eclipse Advantage, LLC, Everclear Cleaning Solutions, LLC, OTS Solutions, LLC and PL Solutions Group, LLC (together, the Company) who are age 18 or older and have provided at least three months of employment. A minimum of 1,000 hours per year is required for part-time, temporary or seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides for automatic enrollment at a deferral rate of 2% of compensation, as defined, unless an eligible employee elects otherwise to affirmatively opt out of participation in the Plan.

Plan merger: On November 4 2022, the Board of Directors agreed to merge the Plan into a Successwise Pooled Employer 401(k) Plan. The effective date of the plan merger is January 24, 2023, when the plan assets were transferred to the Successwise Pooled Employer 401(k) Plan. Plan assets transferred to the Successwise Pooled Employer 401(k) Plan total \$5,912,911.

Financial statement presentation: These financial statements include the period ended January 24, 2023, and the year ended December 31, 2022. The plan elected to defer the filing of its financial statements with its Form 5500 for the year ended December 31, 2022, as permitted by 29 CFR 2520.104-50, since the following Plan year ended January 24, 2023, is a short year of seven months or less. Accordingly, the Plan has included statements of net assets available for assets as of January 24, 2023, December 31, 2022 and December 31, 2021, along with statements of changes in net assets available for benefits for the period ended January 24, 2023, and year ended December 31, 2022, as required by the Department of Labor (DOL) regulations when such election is made.

Contributions and rollovers: Each year, participants may elect to make contributions on a pretax basis or post-tax basis, as defined by the Plan, not to exceed the maximum amount allowed by law, as defined. Contributions are subject to Internal Revenue Service (IRS) pretax contribution limits. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). In addition, participants age 50 or older may also contribute catch-up contributions to the Plan. The Company may make a discretionary matching contribution equal to a uniform percentage of the participants' salary deferrals. Participants' contributions are recognized when withheld. The Company made no discretionary matching contributions during the period ended January 24, 2023, or year ended December 31, 2022.

Excess contributions payable is the result of participant contributions in excess of the Internal Revenue Code (IRC) limits, which are to be refunded to participants. As of December 31, 2022 and 2021, the Company has recorded a balance of \$83,010 and \$104,428, respectively.

Participant accounts: Each participant's account is credited with the participant's contribution, the Company discretionary matching contribution, if any, and an allocation of plan earnings/losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions plus actual earnings thereon is based on years of service. A participant vests 20% for each year of service beginning with the first year of service and is 100% vested after five years of service.

Note 1. Plan Description (Continued)

Investment options: Upon enrollment in the Plan, participants may direct their contributions in a variety of investment choices as more fully described in the Plan's literature. Participants may change their investment options at any time.

Payment of benefits: Upon termination of service for any reason, a participant may elect to receive a lump sum or periodic payments, or to leave the funds in the Plan's trust until a later date, providing the participant's account balance is greater than \$5,000.

Forfeited accounts: Upon termination of employment, a participant's nonvested portion of Company contributions and related earnings thereon are forfeited. At January 24, 2023, December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0, \$0, and \$4,349, respectively. Forfeited nonvested accounts are used to offset administrative expenses and future Company contributions. The Company utilized \$4,349 during the year ended December 31, 2022, to pay for administrative expenses.

Notes receivable from participants: Notes receivable from participants are not permitted by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in dividends.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Other income: The Plan may receive revenue-sharing payments from mutual funds in which the Plan's assets are invested. The administrative services agreement between the Plan and Newport Trust Company provides that to the extent revenue-sharing payments received by Newport exceed administrative fees charged to the Plan, the excess will be credited to the Plan. For the period ended January 24, 2023, and the year ended December 31, 2022, \$0 and \$617,855 was earned by the Plan under this agreement, respectively. As of January 24, 2023, and December 31, 2022, the Plan recorded a receivable in the amount of \$0 and \$183,341, respectively. During 2022, approximately \$240,000 was used to pay administrative fees and approximately \$252,000 was allocated to participants. As of January 24, 2023, December 31, 2022 and 2021, there was \$0, \$559,896 and \$246,357 reported in money market mutual funds on the statements of net assets available for benefits and unallocated to participants. The other income is available to pay future administrative expenses or to allocate to participants as determined at the discretion of management.

Payment of benefits: Benefits are recorded when paid.

Note 3. Information Certified or Provided by Newport Trust Company, the Plan Trustee

Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets and income:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at January 24, 2023, December 31, 2022 and 2021.

Shares of registered investment companies, including money market mutual funds: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

There were no assets held at fair value as of January 24, 2023.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the period ended January 24, 2023, and the year ended December 31, 2022, there were no transfers in or out of Level 3.

Note 5. Related-Party Transactions

Certain plan investments are shares of registered investment companies managed by Newport Trust Company, the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Newport Trust Company for investment management and administrative services totaled \$270 and \$295,770 for the period ended January 24, 2023, and the year ended December 31, 2022, respectively.

Certain employees of the Company provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Company on behalf of the Plan and are not included in these financial statements.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7. Income Tax Status

The Plan is qualified under the appropriate section of the IRC and intends to continue as a qualified plan. The IRS has determined and informed the Plan sponsor, by a letter dated November 30, 2020, that the Plan, as designed, is qualified under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Late Deposits

During 2022, the Plan sponsor inadvertently failed to deposit \$257,166 of participant deferrals within the required time frame as stated by the United States DOL regulations. The Plan sponsor reimbursed the Plan for lost interest. The Plan sponsor intends to file Form 5330 and intends to pay the applicable excise tax in 2023. The excise tax payments will be made from the Plan sponsor's assets and not from assets of the Plan.
