### Note 1: Description of the Plan

#### **General**

The following description of McCombs Enterprises Flexible Benefits Cafeteria Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document and summary Plan description for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan provides health and other benefits covering all employees of McCombs Enterprises (Company) and affiliated companies who have completed 60 days of service. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

#### **Benefits**

The Plan provides health, life, dental, and vision insurance to full-time employees and their dependents. In addition, certain benefits are offered under Section 125 of the Internal Revenue Code (IRC), whereby employees are allowed to exclude contributions to the Plan for such benefits from their personal taxable income.

#### **Stop-Loss Coverage**

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

#### **Self-Insured Benefits**

The claims for self-insured benefits, medical, and prescription benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's Voluntary Employees' Beneficiary Association (VEBA) trust or the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

### ***Contributions***

Contributions for employee health benefits are made by the participating employers and employees. Contributions for all other benefits, including those offered to dependents, are made by the employees. The health insurance benefits offered to both employees and their dependents are self-funded, whereby all contributions are held in trust specifically for the payment of medical claims. Contribution requirements are evaluated and revised as necessary on at least an annual basis at the discretion of the Company. All other benefits are insured or offered through third-party insurance carriers.

### ***Plan Expenses***

Plan fees and expenses are paid from Plan assets.

### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **Note 2: Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. See discussion of estimates related to claims incurred but not reported under the heading of "Other Plan Benefits" within this note.

### ***Payment of Benefits***

Premiums paid by either the Plan sponsor or the VEBA trust are recorded as insurance premiums and other participant benefits in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due, if any, to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits and benefit obligations. The third-party claims processor processes health, medical, and prescription claims of active employees and dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. These payments are recorded as health claims paid in the accompanying statements of changes in net assets available for benefits.

### ***Administrative Expenses***

Administrative expenses may be paid by the Plan sponsor or the Plan, at the Plan sponsor's discretion.

### ***Other Plan Benefits***

Plan liabilities for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end, and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

### ***Stop-Loss Policy***

The Plan is covered under an aggregate and specific excess reinsurance policy. This policy pays 100% of claims in excess of \$150,000 per person, per year, with no lifetime individual maximum.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Interest income is recorded on the accrual basis.

### ***Concentration of Credit Risk***

At December 31, 2022, the Plan had cash deposits representing a concentration of credit risk since the accounts were in excess of federally insured limits. At December 31, 2022, the Plan's cash accounts exceeded federally insured limits by approximately \$5,206,000.

### Note 3: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan has a number of service providers. Such providers are parties in interest under ERISA. For the year ended December 31, 2022, approximately \$1,763,000 was paid by the Plan to administrators for premiums and administrative expenses.

The Company provides certain administrative services to the Plan for which fees of \$240,000 were paid to the Company by the Plan during the year ended December 31, 2022.

### Note 4: Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full-term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

#### ***Recurring Measurements***

The tables on the following page presents the fair value measurements of assets recognized in the accompanying statements of net assets available for benefits and benefit obligations measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at December 31, 2022 and 2021.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits and benefit obligations, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

### ***Investments***

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows.

Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 investments as of December 31, 2022 and 2021.

**Note 5: Tax Status**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated April 24, 1991, stating that the trust, as then designed, was tax-exempt under the provisions of Section 501(c) 9 of the IRC. The Plan has been amended since receiving the determination letter. As a result of the Plan's funding policy, from time-to-time the trust may be subject to income taxes. No federal or state income taxes have been recorded in the financial statements. The Plan Administrator believes that the Plan and related trust are currently being operated in compliance with the applicable requirements of the IRC.

**Note 6: Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and benefit obligations.

**Note 7: Litigation**

The Plan is subject to other claims and lawsuits that arose primarily in the ordinary course of its activities. It is the opinion of management that the disposition or ultimate resolution of such claims and lawsuits will not have a material adverse effect on the change in net assets available for benefits of the Plan. Events could occur that would change this estimate materially in the near term.

**Note 8: Subsequent Events**

Subsequent events have been evaluated through September 21, 2023, which is the date the financial statements were available to be issued.
