Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the accompanying financial statements of South Shore Hospital, Inc. Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 (Liquidation) and 2021 (Ongoing), and the related statements of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of December 31, 2021 (Ongoing), and the related statement of changes in accumulated plan benefits for the year ended December 31, 2021 (Ongoing), and the related notes to the Financial Statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of South Shore Hospital, Inc. Pension Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. 

NOTE 1 DESCRIPTION OF THE PLAN

The following brief description of the South Shore Hospital, Inc. Pension Plan (the Plan) is provided for general information purposes only. The Plan members (Members) should refer to the Plan document for more complete information.

General

The Plan, established on October 1, 1966, is a noncontributory, defined benefit pension plan that covers certain employees of South Shore Hospital, Inc., and certain affiliated corporations (collectively, the Hospital) and provides for retirement and death benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 21, 2005, the board of directors (the Board) of the Hospital voted to freeze participation in the Plan effective January 1, 2007, so that no new participants are permitted, and to freeze future service credits. As a result, the trust was liquidated upon distribution of all assets in accordance with the provisions of the respective plan.

Plan Termination

Approval for plan termination was voted on and passed by the Board on June 30, 2021, with an effective date of August 31, 2021 (also see Note 7). As part of the plan for liquidation, the Plan was amended to allow for a lump sum distribution or purchase of an annuity. The Plan administrator notified eligible participants of their options, subject to amended provisions.

Pension Benefits

Members are entitled to pension benefits, as defined by the Plan, upon retirement. Pension benefits are provided to Members under several types of retirement options based upon years of continuous service and age. Retirement benefits are paid to Members or beneficiaries in various forms of joint and survivor annuities, including a lump-sum payment option.

Death Benefits

A death benefit is payable to the Member's beneficiary as a 50% joint and survivor annuity (upon age 65), or in a lump-sum payment, equal to the actuarial present value of the accrued plan benefit.

Eligibility

Employees became eligible to enter as Members of the Plan after completion of one year in which the employee was credited with 1,000 or more hours of service.

Vesting

Benefits under the Plan, which relate to earnings and length of service, vested after five years of service, are subject to the break-in-service provisions of the Plan. Effective March 31, 2018, all actively employed participants became 100% vested.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The board authorized the termination of the Plan effective August 31, 2021 and management determined liquidation was imminent in 2022 when distributions under the plan of liquidation commenced. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of account would include any expected costs of the disposal of asset and other costs expected to be incurred during the liquidation process. Investments are stated at fair value, which approximates the amount the Plan expects to collect.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Risks and Uncertainties

The Plan invests in common collective trusts and various mutual funds and short-term investment funds which hold securities including corporate stocks. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Investment Transactions and Income Recognition

Purchases and sales of investment securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Differences between the cost and the fair value of investments are included in net appreciation (depreciation) in fair value of investments on the statements of changes in net assets available for benefits.

The Plan presents, on the statements of changes in net assets available for benefits, the net appreciation (depreciation) in fair value of investments, which consists of realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Investment Transactions and Income Recognition (Continued)

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Costs

Administrative costs relating to the Plan are paid by the Plan in accordance with the Plan document. Personnel and facilities of the Hospital are used by the Plan for its accounting and other activities at no charge to the Plan.

Payment of Benefits

Benefit payments are recorded when paid. Distributions will be paid in a lump-sum or in installments over a number of years, based upon election of the participant or as defined in the Plan or Internal Revenue Code (the Code). Accrued benefits whose present value is less than \$5,000 are automatically paid out as a lump-sum. Vested active participants who terminate on or after January 1, 2017, are allowed to receive their benefit in the form of a lump-sum or actuarially equivalent annuity (if commencing prior to age 55) within twelve months of termination.

Subsequent Events

Management has evaluated events occurring subsequent to year-end through September 29, 2023, the date the financial statements were available for issue.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and schedules as of December 31, 2022 and 2021, and for the years then ended for investments and investment income was derived, without audit, from information certified to be complete and accurate by State Street Bank and Trust Company (State Street), the trustee, as permitted by the election made by the Plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FUNDING AND ACCUMULATED PLAN BENEFITS

Employer Contributions

Contributions to provide benefits under the Plan are made solely by the Hospital. The Hospital's funding policy is to make contributions to the Plan in such amounts as determined by the Plan's independent actuary. The Hospital met the minimum funding requirements of ERISA for the years ended December 31, 2022 and 2021. Board-approved hospital contributions are recorded in the financial statements in the year the contribution is allocated.

The Hospital did not approve or allocate a contribution towards the 2022 or 2021 Plan year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable under the Plan's provisions for the service Members have rendered. Accumulated plan benefits include benefits expected to be paid to retired, disabled or terminated Members or their spouses in addition to present employees or their beneficiaries. Benefits under the Plan are based on Members' compensation during their years of service prior to the freeze date. The accumulated plan benefits for active Members are based on the estimated average of the highest five consecutive calendar years of compensation on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances (retirement, disability, death, and termination of employment) are included to the extent they are deemed attributable to Members' service rendered to the freeze date.

Benefits to be provided via annuity contracts excluded from plan assets are excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by the Plan's independent consulting actuary, and is that amount which results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The plan terminated effective August 31, 2021 and all benefits were fully settled during 2022. The present value of accumulated benefits as of December 31, 2021 was developed by discounting the benefit payments made for lump sum payments and for an annuity purchase premium along with annuities and lump sums paid during the normal course of plan operations during 2022 back to the measurement date of December 31, 2021 using a discount rate of 2.70%.

Subsequent to the benefit information date, under the plan of liquidation, all obligations of the Plan were satisfied via distribution to Plan participants or transfer to an insurance company (See Note 7).

NOTE 5 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

Common Collective Trusts: The common collective trusts are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of the units held of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

Money Market, Mutual Funds, and Short-term Investment Funds: Money market, mutual funds, and short-term investment funds are valued at the quoted price of shares held by the Plan at year-end.

There have been no changes in the methodologies used at December 31, 2022 and 2021.

NOTE 5 FAIR VALUE MEASUREMENTS (CONTINUED)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of funds managed by State Street, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management, custodial and benefit payment services to State Street were \$37,216 and \$53,873 for the years ended December 31, 2022 and 2021, respectively. In addition, the Plan paid fees for actuarial, advisory, and audit services of \$829,739 and \$822,355 for the years ended December 31, 2022 and 2021, respectively.

NOTE 7 PLAN TERMINATION

Upon termination of the Plan, the net assets of the Plan would be allocated among the participants and beneficiaries of the Plan in the order provided for in ERISA as follows:

- a. Benefits attributable to employee contributions, taking into account those paid out before termination.
- b. Annuity benefits former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
- c. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. governmental agency) up to the applicable limitations (discussed below).
- d. All other vested benefits (that is, vested benefits not insured by the PBGC).
- e. All nonvested benefits.

Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's benefits. However, the PBGC does not guarantee all benefits under the Plan and there are limitations on some of the guaranteed benefits. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, subject to some limitations. Benefit improvements attributable to Plan amendments are not automatically fully guaranteed. PBGC guarantees only benefits or benefit increases in effect for 60 months or more prior to the date of termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits and may also depend on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC.

NOTE 7 PLAN TERMINATION (CONTINUED)

In 2021, the board resolved to terminate the Plan. The Plan filed a notice with the Internal Revenue Service (IRS) to fully terminate the Plan effective September 2021, the Plan received a favorable determination letter from the IRS for the termination. The Plan then proceeded with the termination by distributing each participant's beneficial interest in the Plan pursuant to participant elections as soon as administratively feasible.

Options were given to participants to receive a lump sum payment or have an annuity purchased on their behalf from an insurance company. In May 2022, approximately \$35,700,000 in lump sum payments were paid out to participants who elected this option.

In June 2022, the Plan entered into agreements to purchase annuity contracts with an insurance company for \$99,228,311 to satisfy all remaining obligations of the Plan. As of the September 29, 2023, the Plan is currently still in the process of liquidation.

In December 2022, the Plan transferred \$5,000,000 to the Plan Sponsor.

NOTE 8 TAX STATUS OF THE PLAN

The Plan obtained a determination letter in which the Internal Revenue Service (IRS) stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the determination letter, however, the Plan's management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been recorded on the accompanying financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
