#### 1. Plan Description

The following description of the Salson Logistics Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all non-union employees of Salson Logistics Inc. (the "Company") who have completed 12 months of service, or 1,000 hours, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Contributions* – Each year participants may contribute to the Plan up to 90% of their pre-tax or post-tax (Roth) annual compensation, subject to certain IRS limitations. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans ("rollover contributions").

The Company, at its discretion, may also make profit sharing contributions and/or matching contributions based on participant's elective deferrals. The Company did not make any discretionary contributions in 2022 or 2021.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

- c) *Participants Accounts* – Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- d) *Vesting* – Participants are vested immediately in their voluntary contributions, plus earnings thereon. Participants are 100% vested in both nonelective profit sharing contributions and matching contributions after attaining three years of service.
- e) *Notes Receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above the prime rate, as published in the Wall Street Journal on the 14<sup>th</sup> day of the month (or the first business day preceding it). Principal and interest is paid ratably through weekly payroll deductions.
- f) *Payment of Benefits* – The benefit to which a participant is entitled is that which can be provided from the participant's vested account. The Plan provides retirement benefits for participants at the normal retirement age or later if the participant desires to continue employment. Benefits are also payable to participants or their designated beneficiaries upon death, disability or other limited circumstances of the participant. The Plan also allows for in-service withdrawals of Company matching and fully vested profit sharing contributions after the attainment of the normal retirement age.
- g) *Forfeited Accounts* – Forfeitures attributable to terminated participants' non-vested accounts are allocated to a forfeiture account and are to be used to either pay for certain plan expenses or reduce employer contributions. No forfeitures were used to fund employer matching contributions and plan expenses during the year ended December 31, 2022 and 2021.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. No such liabilities were noted at year ended 2022. The Plan distributed the 2021 excess contributions to the applicable participants prior to March 15, 2022.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### 3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2022 through October 11, 2023, which is the date the financial statements were available to be issued.

The governing body of Salson Logistics Inc. 401(k) Profit Sharing Plan and Trust approved a plan of termination as of March 31, 2023. As of May 31, 2023, all assets were distributed to participants or transferred to a successor plan.

#### 5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets; and level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Investments are measured at net asset value provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is not a publicly traded quoted price in an active market but is used as a practical expedient to estimate fair value. In accordance with the Fair Value Measurements topic 820-10, certain investments that are measured at NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy.

## 6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## 7. Related Party and Party in Interest transactions

The Company, participants, and the trustees have all been identified as parties in interest. ADP is the Plan's recordkeeper and Reliance Trust Company is the trustee of the Plan. Recordkeeping and transaction fees of \$17,631 were paid to ADP in 2022.

## 8. Plan Termination

The governing body of Salson Logistics Inc. 401(k) Profit Sharing Plan and Trust approved a plan of termination as of March 31, 2023. Upon Plan termination, participants are 100% vested in their employer contributions. As of May 31, 2023, all assets were distributed to participants or transferred to a successor plan.

### 9. Tax Status

The Internal Revenue Service has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Plan management has evaluated tax positions taken by the Plan and recognizes a tax liability if the Plan has taken uncertain positions that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

### 10. Reconciliation of Financial Statements to Form 5500

The following is a reconciliation of net assets available for benefits per the financial statements to the Form 5500:
