Basis for Opinion

Note 1. Description of the Plan

The following description of the Table 301, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Soby's, Soby's on the Side, No Walls, Two Daughters, Riverplace Restaurant, Southern Pressed Juicery, Jones Oyster Co., and Table 301 Catering (collectively, the "Company") who have completed at least 6 months of service and are at least 21 years old. The inception date of the Plan was January 1, 2019. Employees hired prior to the date of plan inception became immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The custodians of the Plan are Principal Life Insurance Company and Principal Life Insurance Company as agent for Principal Global Investors Trust Company (collectively, "the custodian").

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a safe harbor matching contribution equal to 100% percent of participant salary deferrals that do not exceed 3% of participant eligible compensation plus 50% of participant salary deferrals between 3% and 5% of participant eligible compensation. Additional discretionary matching and profit sharing amounts may be contributed at the option of the Company's management. The Company did not make any discretionary matching or profit sharing contributions applicable to the year ending December 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions, Company safe harbor contributions, and rollover contributions plus actual earnings thereon. Vesting in the Company discretionary matching as well as discretionary profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 2 years of credited service.

Payment of benefits

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of a financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59^{1/2}.

Forfeited accounts

There were no forfeited nonvested accounts as of December 31, 2022 and 2021, and no forfeitures were utilized during the year ending December 31, 2022. If there are forfeited nonvested accounts in future years they will be used to reduce administrative expenses or reduce Company matching contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Note 2. Summary of Significant Accounting Policies, ContinuedExpenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 29, 2023, the date that the financial statements were available to be issued.

Recently issued accounting pronouncements

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Note 3. Custodian Certifications

The following is a summary of the Plan's asset information as of December 31, 2022 and 2021, and for the year ended December 31, 2022, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the custodian and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that the information provided to the plan administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, such as;
- Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Collective trust funds:

Valued at net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount differing from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust fund, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Valued at NAV. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount differing from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Note 5. Related-party and Party in Interest Transactions

Certain Plan investments are managed by the custodian and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third party administrator totaling \$9,138 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary matching as well as discretionary profit sharing contributions.

Note 7. Tax Status

Effective January 1, 2021, the Plan adopted a non-standardized pre-approved plan sponsored by Nova 401(k) Associates Inc, the pre-approved plan provider. The pre-approved plan provider has received an advisory letter from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan's advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2022 statement of net assets available for benefits.

Note 10. Plan Errors

The Company has initiated corrective measures to remedy the Plan under the IRS's Employee Plan Compliance Resolution System (EPCRS) Self Correction Program. EPCRS is a voluntary program in which the Company may correct certain plan qualification failures to preserve favorable tax treatment of their employees' retirement benefits. Management believes that the Company's qualified tax status has not been jeopardized due to these actions.

During 2022, the Company had deferral election errors and missed deferral opportunities on manual checks, as such, employees were not give the opportunity to make deferrals on eligible plan compensation. In addition, the related Company contributions were incorrectly made or not made as a result of these errors and missed deferral opportunities. Such amounts to be contributed totaling \$3,192 have been recorded and included in Company contributions receivable in the accompanying statements of net assets available for benefits. The Company will make the above-mentioned corrections during 2023.

During 2021, the Company had deferral election errors and missed deferral opportunities on manual checks, as such, employees were not give the opportunity to make deferrals on eligible plan compensation. In addition, the related Company contributions were incorrectly made or not made as a result of these errors and missed deferral opportunities. Such amounts to be contributed totaling \$1,853 have been recorded and included in Company contributions receivable in the accompanying statements of net assets available for benefits. The Company will make the above-mentioned corrections during 2023.

During 2022, the Company inadvertently failed to make deposits of \$27,021 of participant deferrals within the timeframe as required by the DOL. As of December 31, 2022, \$8,117 was corrected outside of VFCP and \$18,904 remained uncorrected. The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Company remit withheld employee 401(k) deferrals to the Plan as of the earliest date on which such amounts can be reasonably segregated from the Company's general assets, but in no event later than 15 business days after the end of the month in which the contributions were withheld. Management believes that assets can be reasonably segregated within three business days; therefore, any amounts remitted after three days is considered late. The Company made deposits ranging from nine days to over a year after the date in which the contribution was withheld and intends to file Form 5330 with payment of the applicable excise tax. The excise tax payments will be made from the Company's assets and not from assets of the Plan. In addition, participant accounts will be credited with the amount of investment income which would have been earned had participant contributions been remitted on a timely basis.

During 2021, the Company inadvertently failed to make deposits of \$8,015 of participant deferrals within the timeframe as required by the DOL. As of December 31, 2022, the entire \$8,015 was corrected outside of VFCP. The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Company remit withheld employee 401(k) deferrals to the Plan as of the earliest date on which such amounts can be reasonably segregated from the Company's general assets, but in no event later than 15 business days after the end of the month in which the contributions were withheld. Management believes that assets can be reasonably segregated within three business days; therefore, any amounts remitted after three days is considered late. The Company made deposits ranging from five to twenty-three days after the date in which the contribution was withheld and intends to file Form 5330 with payment of the applicable excise tax. The excise tax payments will be made from the Company's assets and not from assets of the Plan. In addition, participant accounts will be credited with the amount of investment income which would have been earned had participant contributions been remitted on a timely basis.
