To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Whitestone Transportation, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A—PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following description of the Whitestone Transportation LLC (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description to the Plan’s provisions.

General. The Plan is a defined contribution plan covering all full-time employees of the Company who have three (3) months of service and are age 21 or older. The Plan is subject to the provisions of ERISA. The Trustee is responsible for oversight of the Plan. The Plan administrator determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Trustee.

Contributions. Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not include an auto enrollment provision. Participants must elect to participate once eligibility is met. Whitestone Transportation LLC does not match employee contributions.

Participant Accounts. Each participant’s account is credited with the participant’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contributions. At the time the employer exercises their matching contribution, participant vesting schedule will be based on years of continuous service.

Participant Loans. Participants may request loans from their accounts.

Payment of Benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts. All participants are fully vested; therefore, no non-vested portions of the accounts are considered forfeitures.

NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting.

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates.

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits.

Benefits are recorded when paid.

Excess Contributions.

When a participant exceeds the contribution limit for the year, this is considered an excess contribution, or excess elective deferral. The Plan shall not allocate gains and losses on distributions of excess contributions for the period after the end of the Plan year which such excess contributions arose. At the end of the Plan year, to correct excess contributions, corrective distributions are made. As of December 31, 2022, there were no corrective distributions to be made.

Expenses.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events.

The Plan has evaluated subsequent events through October 10, 2023, the date the financial statements were available to be issued.

NOTE C—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to un-observable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.
Level 2	<p>Inputs to the valuation methodology include</p> <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset of liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: Polled separate accounts (PSA’s) invest mainly in mutual funds. All of the underlying securities have observable level 1 quoted pricing inputs. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date. Therefore, the Company believes that these investments have a “Readily Determinable Fair Value”. The NAV is calculated in a manner consistent with generally accepted accounting principles for investment companies. Because it is valued similarly to mutual funds, the Company believes its PSA’s should be level 1 assets to allow for consistent disclosure. PSA’s typically can be redeemed on a daily basis.

NOTE D—GROUP ANNUITY CONTRACT WITH AMERICAN NATIONAL INSURANCE COMPANY

In 2022, the Plan entered into an investment contract with American National Insurance Company (ANIC). ANIC maintains the contributions in pooled separate accounts. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. The Company may terminate the contract at anytime by requesting a withdrawal of the balance of all accounts subject to the provisions in the contract. This contract is not a fully benefit responsive contract, therefore it is not recorded at contract value.

NOTE E—INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2022 and investment income for the year ended December 31, 2022, including investment information that is disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustee of the Plan.

NOTE F—PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by American National Insurance Company. The Plan administrator of the Plan contributes to the Plan as an employee of Whitestone Transportation, LLC. These transactions qualify as party in interest transactions under ERISA.

NOTE G—PLAN TERMINATION

It is the intention of the Plan sponsor, that this Plan will be permanent. However, the Plan sponsor reserves the right to terminate the Plan at any time for any reason. Upon termination of the Plan, participant accounts shall be distributed in a single lump sum payment.

NOTE H—TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that is more than likely would not be sustained upon examination by the Mississippi Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available benefits.
