### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the accompanying financial statements of the Chase Grant Billing, PC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 30, 2022 and the related statement of changes in net assets available for benefits for the period then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from, Empower Trust Company, LLC and Massachusetts Mutual Life Insurance Company, both qualified institutions, as of December 30, 2022 and for the period then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Report on the 2021 Financial Statement***

The 2021 financial statement of the Chase Grant Billing, PC 401(k) Profit Sharing Plan and Trust was audited by Comiskey & Company, PC. Comiskey & Company, PC expressed an unmodified opinion on those financial statements dated October 17, 2022.

NOTE A – DESCRIPTION OF PLAN

The following description of the Chase Grant Billing, PC (the “Company”) 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Summary Plan Description has been made available to all participants in the Plan, and a copy of the Plan agreement is available from the Plan Administrator.

1. *General*

The Plan is a defined contribution plan covering all full-time employees of the Company and affiliated employers who are age 18 or older, except for certain union employees and non-residential aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustee is responsible for oversight of the Plan. The Trustee and investment advisors determine the appropriateness of the Plan’s investment offerings, and monitors investment performance.

The Plan was amended and restated effective January 1, 2022, as part of the Post Pension Protection Act cycle to reflect recent law changes, such as the CARES Act.

Chase Grant Billing, PC was acquired on June 11, 2021, by Alpine Physician Partners, LLC.

2. *Participants’ Contributions*

Each year, participants may contribute up to 70 percent of pre-tax and post-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$6,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all eligible employees without an existing deferral election are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferred rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants with deferral rates less than 6 percent will have their deferral rate automatically increased by 1 percent each Plan year up to 6 percent of compensation unless they affirmatively elect not to participate in the auto escalate feature. The Plan currently offers various mutual funds and an investment contract with an insurance company as investment options for participants. Employee contributions are subject to certain Internal Revenue Service (IRS) limitations.

A discretionary qualified non-elective contribution to the Plan is determined annually by the Directors of the Company for participants that have over one year of service. The contributions are allocated to the participants’ accounts in the proportion that each participant’s compensation bears to the total participants’ compensation. The Company did not make a qualified non-elective contribution to the Plan for the period ended December 30, 2022.

3. *Participant Accounts*

Each participant's account is credited with the participant's contributions, as well as allocations of (a) the Company's discretionary non-elective contributions and (b) plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting for the employer non-elective contributions is based on years of continuous service. Participants vest 20 percent each year after the first year of service and are 100 percent vested after six years of credited service.

5. *Notes Receivable From Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance for all accounts except for Roth elective deferrals. The loans are secured by the vested balance in the participant's account. Participants may have up to two loans outstanding at any time. The loans bear interest rate is determined by at the date the loan is made and is set at the prime rate plus two percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

6. *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount, partial withdrawals, or installments equal to the value of the participant's vested interest in his or her account or roll over the account balance to an IRA or to another qualified retirement plan. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or roll over the account balance to an IRA or to another qualified retirement plan. Accounts for terminated participants with balances in excess of \$5,000 are maintained in the Plan until the participant requests a distribution. As of December 30, 2022 and December 31, 2021, no amounts were required to be allocated to accounts of persons who had elected to withdraw from the Plan, but had not yet been paid.

7. *Forfeited Accounts*

At December 30, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$27, respectively. These accounts are used to reduce future employer discretionary contributions or allocated to participant accounts. Also, in 2022 and 2021, employer discretionary contributions were reduced by \$0 from forfeited nonvested accounts.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

1. *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. *Use of Estimates*

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies by utilizing information provided by the investment advisor. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as transaction fees and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 30, 2022 or December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

5. *Payment of Benefits*

Benefits are recorded when paid.

6. *Administrative Expense*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid directly by the Company are excluded from these financial statements. Contract administrator fees are included in administrative expenses. Investment related expenses are included in net (depreciation) of fair value of investments.

7. *Subsequent Events*

Plan management has evaluated subsequent events from the statement of net assets available for benefits date through October 11, 2023, the date the financial statements were available to be issued.

Effective January 1, 2023, the Chase Grant Billing, PC 401(k) Profit Sharing Plan and Trust merged with the Alpine Physician Partners, LLC 401(k) Retirement Plan, which uses Fidelity for recordkeeper services and is a multiple-employer plan.

On January 26, 2023, the Alpine Physician Partners, LLC 401(k) Retirement Plan accepted a transfer of \$4,152,928 from the Chase Grant Billing, PC 401(k) Profit Sharing Plan and Trust.

NOTE C – SUMMARY OF INFORMATION CERTIFIED BY THE TRUSTEE

The following information, which is included in the financial statements, has been certified as complete and accurate by Empower Trust Company, LLC (ETC) and Massachusetts Mutual Life Insurance Company (MMLIC) as of December 30, 2022 and December 31, 2021, and for the period ended December 30, 2022, and has not been audited:

NOTE D – PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower Retirement, LLC (ER). ETC is the custodian and MMLIC is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

MMLIC provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the employer and MMLIC. MMLIC receives revenue from mutual fund service providers. This revenue is used to offset certain amounts owed to EAIC for its administrative services to the Plan. Fees paid by the Plan for recordkeeping services totaling \$1,134 for the period ended December 30, 2022, are included in net (depreciation) in fair value of investments.

If revenue received by EAIC from such mutual fund service providers exceeds the amount owed under the MSA, EAIC remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to accounts of the

participants. During 2022, there was \$7,071 in excess amounts remitted to the Plan and is included in other income. The Plan or Plan Sponsor may make a payment to EAIC for administrative expenses not covered by revenue sharing.

The Plan uses the investment advisory services of HFG Colorado, Inc. and contract administration services of Ascensus Holdings, Inc. DBA FuturePlan by Ascensus. As service providers to the Plan, fees paid for investment advisory and contract administration services from Plan assets qualify as party-in-interest transactions. The Plan made direct payments to HFG Colorado, Inc. totaling \$5,626 for the period ended December 30, 2022. The Plan made indirect payments to Ascensus Holdings, Inc. DBA FuturePlan by Ascensus totaling \$1,420 for the period ended December 30, 2022 and are included in net (depreciation) in fair value of investments.

**NOTE E – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 30, 2022 and December 31, 2021.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE F – TAX STATUS**

The IRS has informed the Plan by an opinion letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Thus, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Federal and State of Colorado taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G – PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Plan was terminated on December 30, 2022, which was the date of last contribution. Participants were 100% vested in their contributions and any discretionary non-elective contributions, plus actual earnings thereon.

The Plan had no liabilities to settle other than participant accounts. Participant assets were fully distributed by December 30, 2022 and the Plan was dissolved as of that date.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
