## INDEPENDENT AUDITOR'S REPORT

### Opinion

We have audited the accompanying financial statements of U.A.W. Office Employees Supplemental Unemployment Benefit Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of U.A.W. Office Employees Supplemental Unemployment Benefit Fund as of December 31, 2022 and 2021, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


### Basis for Opinion



### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2022 AND 2021

#### NOTE 1. DESCRIPTION OF THE PLAN

The following description of the U.A.W. Office Employees Supplemental Unemployment Benefit Fund (the Plan) provides only general information. Participants should refer to the bargaining agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a single employer plan established effective July 1, 1955, as a result of collective bargaining between the United Automobile, Aircraft and Agricultural Implement Workers of America (U.A.W.), as employer and the Office and Professional Employees International Union 494. The Plan covers all office and maintenance employees of the International Union - U.A.W. Benefits are payable to employees after one year seniority and if they are eligible for unemployment compensation. The entire cost of the Plan is funded by the U.A.W.

**Funding** - The U.A.W. is to contribute eight cents per hour until the fund reaches a maximum of \$500,000. At that point, the eight cents is paid to the employees. If at any point the fund needs replenishment, the eight cents or a portion thereof will be used until the fund again reaches its maximum.

In March 2021, the U.A.W. committed to provide benefits as set forth in the Plan for all current employees regardless of funding level and the \$1.5 million cap, for the entirety of the March 31, 2021 to March 31, 2025 Collective Bargaining Agreement.

**Payment of Benefits** - Total benefits will be 74% of gross pay less benefits received in unemployment compensation. Transition Support Program benefits will be 50% of gross pay less benefits received in unemployment compensation.

**Administrative Expenses** - Substantially all administrative expenses are paid by the employer.

#### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized as incurred.

**Use of Estimates** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.



## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Payment of Benefits** - Benefits are recognized when paid.

## **NOTE 3. TERMINATION OF THE PLAN**

The Plan and related Trust may be terminated at any time by the U.A.W., and upon termination or dissolution or liquidation of the U.A.W., the Trust Fund shall be paid out as directed by the U.A.W. in accordance with the Plan. The assets, if any, remaining after satisfaction of all liabilities under the Plan, shall be disposed of as directed by the U.A.W. and OPEIU Local 494 in writing or by a court of competent jurisdiction.

## **NOTE 4. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is qualified pursuant to Section 501(c)(17) of the Internal Revenue Code (IRC) as a tax-exempt organization. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service (IRS) dated March 5, 2021. The Plan sponsor believes that the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. As of December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. At December 31, 2022, the Plan is no longer subject to income tax examinations for years prior to the fiscal year ended December 31, 2019.

## **NOTE 5. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 27, 2023, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
