Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ed's Supply Co., Inc. of Nashville 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefit for the year then ended (in liquidation), and the statement of net assets available for benefits as of December 31, 2022 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ed's Supply Co., Inc. of Nashville 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We are required to be independent of Ed's Supply Co., Inc. of Nashville 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As described in Note 1 to the financial statements, the governing body of Ed's Supply Co., Inc. of Nashville 401(k) Plan approved the Plan to be terminated effective on December 31, 2022. As a result, the plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ed's Supply Co., Inc. of Nashville 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Note 1 - Description of Plan

The following description of the Ed's Supply Co., Inc. of Nashville 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement and amendments for a more complete description of the Plan's provisions.

General

The Plan, as amended, is a defined contribution plan maintained for substantially all eligible employees of Ed's Supply Co., Inc. of Nashville (the Plan Sponsor). The Plan covered substantially all full-time employees who had completed one year or 1,000 hours of service, whichever occurred first. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

In April 2022, the Plan Sponsor was acquired by Gryphon Investors, a leading middle market private equity firm. Effective December 31, 2022, the Plan Sponsor terminated the Plan. All assets were distributed from the Plan as of December 31, 2022.

Contributions

Until December 31, 2022, Participants could elect to make pre-tax contributions, subject to the annual additions limitations per the Internal Revenue Code (IRC). Participants directed the investment of their contributions into various investment options offered by the Plan. Participants who had attained age fifty before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation subject to certain Internal Revenue Service (IRS) limitations.

The Plan Sponsor could contribute and allocate a matching contribution equal to a discretionary percentage of each eligible participant's salary deferrals. During 2022 and 2021, the employer match was 50% of participant deferrals up to a maximum matching amount of 6% of participant compensation, which totaled \$380,178 and \$347,949, respectively.

The Plan Sponsor could also make non-elective contributions to participants with a minimum of 501 service hours during the Plan year to the Plan each year, but was not required to do so in any particular year. Non-elective contributions to the Plan were out of its net profits or accumulated net profits and were determined by appropriate action of the Board of Directors of the Employer. During 2022 and 2021, the Plan Sponsor did not make non-elective contributions.

Participant Accounts

Each participant's account was credited (charged) with the participant's contributions and Plan Sponsor employer matching and profit sharing contributions, as well as allocations of investment earnings (losses), and administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their elective salary deferral plus actual earnings (losses) thereon on the termination date. Vesting in the Plan Sponsor's discretionary contributions were based on years of continuous service. Participants vested 20% after two years of service, and 20% each year thereafter until they became 100% vested after six years of service. Upon Plan termination, participants became 100% vested in their discretionary contribution balances.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant would be entitled to receive only the vested interest in his or her account as a lump-sum distribution. Vested account balances less than \$5,000 were distributed to the participant as a lump-sum distribution.

Forfeited Accounts

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduced the Plan Sponsor's contributions and administrative expenses to the Plan. At December 31, 2022 and 2021, there were \$0 and \$238 of forfeitures available as a result of participant activity, respectively. During 2022 and 2021, Plan Sponsor matching contributions and administrative expenses were reduced by \$4,481 and \$6,273, respectively, from forfeited nonvested accounts.

Hardship Withdrawals

The Plan permitted distributions in the event of a hardship, as defined in the Plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective account balance.

Administrative Expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and were excluded from these financial statements. Fees related to the processing of distributions were included in administrative expenses and charged directly to the participant's account. Investment related expenses were included in net appreciation (depreciation) in fair value of investments.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

As described in Note 1 of the financial statements, the Plan Sponsor terminated the Plan effective December 31, 2022. In accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), the 2022 financial statements of the Plan have been prepared under the liquidation basis of accounting. Amounts related to 2021 have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividend income was recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits were recorded when paid.

Events Occurring After Reporting Date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2022 and October 4, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

Note 3 - Certified Information

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments from participants held at December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (John Hancock).

Note 4 - Investments Measured at Fair Value

The Plan's investments in pooled separate accounts were measured at net asset value (NAV) as a practical expedient to estimate fair value and, therefore, were not classified in the fair value hierarchy. The NAV was based on the market value of the underlying investments held by the pooled separate accounts at year end. The NAV as a practical expedient would not be used if it is determined to be probable that an account will sell the underlying investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may have occurred daily. If the Plan initiated a full redemption of the pooled separate accounts, the issuer reserved the right to temporarily delay withdrawal from the pool in order to ensure that securities liquidations would have been carried out in an orderly business manner.

The following table summarizes investments for which the fair value was measured using the NAV per share practical expedient as of December 31, 2022 and 2021, respectively. There were no participant redemption restrictions for these investments; the redemption notice period was applicable only to the Plan.

Note 5 - Income Tax Status

The Plan Sponsor adopted a pre-approved 401(k) plan, as amended, which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the pre-approved Plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan administrator believes that the adopted pre-approved Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and is, therefore, qualified and exempt from taxation.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by John Hancock and, therefore, these transactions qualified as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers which also qualified as party-in-interest transactions. During the years ended December 31, 2022 and 2021, the Plan Sponsor incurred investment advisory services from Wilshire Associates, Inc, payroll related service fees from Lackoff & Co., PC., and audit services from Puryear & Noonan, CPAs, which are deemed to be parties-in-interest.
