Independent Auditor's Report

Opinion

We have audited the financial statements of San Diego Transit Local 465 Security Fund Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2022 (in liquidation) and 2021 (ongoing), and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years ended December 31, 2022 (in liquidation) and 2021, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of San Diego Transit Local 465 Security Fund Health and Welfare Plan as of December 31, 2022 (in liquidation) and 2021, and the changes in its net assets available for benefits and benefit obligations for the years ended December 31, 2022 (in liquidation) and 2021, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of San Diego Transit Local 465 Security Fund Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 7 to the financial statements, the Board of Trustees of San Diego Transit Local 465 Security Fund Health and Welfare Plan approved a plan liquidation on September 14, 2022, and management determined liquidation is imminent. As a result San Diego Transit Local 465 Security Fund Health and Welfare Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1 - Description of the Plan

The following description of San Diego Transit Local 465 Security Fund Health and Welfare Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

General

The San Diego Transit Local 465 Security Fund Health and Welfare Plan is a health and welfare plan established by and between International Brotherhood of Electrical Workers, Local Union 465, A.F.L.-C.I.O. and San Diego Transit Corporation through a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan is the responsibility of the Board of Trustees (the Trustees) and is governed by a joint board consisting of equal representation from the participating employers and the Union.

Benefits

The Plan currently provides benefits for employees and former employees of San Diego Metropolitan Transit System (the “Employer”).

The Plan provides health, dental, and vision benefits to eligible members of the Plan and/or their beneficiaries, through the purchase of insurance or memberships in a health maintenance organization (“HMO”). Payments made to insurance companies, or the HMO are treated as a deduction from Plan assets and no liability is recognized for claims payable under the contracts as the insurance provider or the HMO assumes payment responsibility.

In addition, effective March 2002, the Plan provided certain participants outside the Kaiser service area, coverage under the San Diego Transit Corporation’s Health Plan.

Eligible members and their dependents are entitled to coverage under the prepaid Kaiser Permanente medical Plan provided they live or work within the Kaiser service area. Member residing outside of the Kaiser Permanente service area will have no medical, dental or vision benefits with a few exceptions. Active members can be covered for dental benefits under the prepaid DHMO dental plan, retired and actives will only be provided for urgent care.

An employee is eligible for coverage under the Plan if (a) he/she is not a temporary Employee; and (b) he/she is a full-time employee. Coverage begins on the first day of the month following sixty (60) days of full-time employment.

An employee will remain eligible in each month for which the employee and the Employer have contributed on the employees' behalf for that month of coverage.

Active employees are eligible for the benefits in the same month that contributions are remitted. Retiree contributions are made through automatic deductions of the retired participant's monthly pension check.

Retirees are eligible if their employer remitted contributions to the Plan, the retiree is receiving benefits from the San Diego Transit Pension Fund and are at least 55 years of age, they apply for coverage, and make monthly required contributions to the Plan.

Disabled participants are eligible if the disabled participant is receiving a disability pension from the San Diego Pension Fund.

Effective April 1, 2022, employer and employee contributions have ceased due to the Plan's termination.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The 2022 financial statements were prepared under the liquidation basis of accounting. The 2021 financial statements were prepared on the accrual basis of accounting; or, in other words, the ongoing plan basis of accounting. Application of liquidation basis for this Plan does not materially differ from accrual basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Employer Contributions and Contributions Receivable

The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement. Contributions from the employer are based on a rate per hour for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. Management of the Plan evaluates the participating employer's contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection. As of December 31, 2022 and 2021 there was no allowance taken.

Retiree contributions receivable represent the total of amounts received subsequent to December 31 which were deducted from the participant's December pension check.

Payment of Benefits

Claims and premiums are recorded when paid. Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan for reimbursement.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies and procedures. See Note 3 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

The classification of investment earnings reported in the statements of changes in the net assets available for benefits may differ from the classification of earnings on the Forms 5500 due to different reporting requirements on the Form 5500.

Administrative Expenses

Expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Postretirement Benefit Obligations

Postretirement benefit obligations were recognized for retiree health benefits for eligible participants and their beneficiaries and dependents. The amount reported as the postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the plan to employees' service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants and retirees. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the plan sponsor and from existing plan assets, and from self-payments by the participants.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

As of December 31, 2022 there are no postretirement benefit obligations due to the Plan termination.

The following are other significant assumptions used in the valuations as of December 31, 2021:

The contributing employers make contributions to the Plan as needed to fund claims in excess of participants' contributions. The Plan's unfunded benefit obligations at December 31, 2021, relate primarily to the portion of postretirement benefit obligations not covered by participant contributions. Any deficiency of the Plan's net assets over the benefit obligations is funded by the contributing employer on a pay-as-you-go basis.

Concentration of Risk

The Plan maintains its cash balances at high credit quality financial institutions. Accounts at these institutions are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit. At December 31, 2022 and 2021, the Plan had approximately \$0 and \$427,588, respectively, in excess of FDIC-insured limits.

Note 3 - Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

Money market deposit accounts – valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Mutual funds – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consisted with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

Note 5 - Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated January of 1975, that the trust is tax exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan’s funding policies, from time to time the trust may be subject to income taxes. In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan’s Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore believes that the related trust is tax-exempt. No federal or state income taxes have been recorded in 2022 and 2021 for unrelated business taxable income.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of a money market deposit account managed by Lincoln Investment, the broker and manager as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

San Diego Metropolitan Transit System is a contributing employer and administrative service for the plan. Due to them being a contributing employer qualifies them as a related party to the plan. For the years ended December 31, 2022 and 2021, San Diego Metropolitan Transit System administrative service fees were \$32,989 and \$34,776, respectively.

Note 7 - Plan Termination

On September 14, 2022, the Board of Trustees voted to terminate the IBEW Local 465 Security Fund Health and Welfare Plan effective December 31, 2022. All assets were transferred to a commercial custodial account on December 31, 2022. All claims for benefits which have not been submitted as of the date of termination, but which would have been paid had the Plan continued, would be paid in accordance with the Plan’s provisions.



