Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bancsource 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bancsource 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

Note 1: Description of the Plan

General

The following description of Bancsource 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document and *Summary Plan Description* for a more complete description of the Plan’s provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Tecniflex, LLC, d/b/a Bancsource (Company), for the benefit of its nonunion employees who have completed two months of service and have attained twenty-one years of age. Eligible participants can then enter the Plan on the first day of the month following the month in which they meet the eligibility requirements. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (FMTC) serves as plan trustee and custodian.

Effective December 30, 2022, the assets of the Bancsource 401(k) Savings Plan transferred into the TSG Cennox, LLC 401(k) Plan. The transfer from the Bancsource 401(k) Savings Plan totaled \$5,848,834, and is included in transfer to successor plan on the 2022 Statement of Changes in Net Assets Available for Benefits.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make regular contributions of up to 100 percent of eligible pretax annual compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The plan document includes an automatic deferral feature whereby a participant is treated as electing to defer 3 percent of eligible compensation unless the participant made an affirmative election otherwise. Employee rollover contributions are also permitted. The Company may, at the discretion of the Company’s Board of Directors, make matching and profit-sharing contributions for participants. For 2022 and 2021, the Company made matching contributions of 25 percent of participants’ contributions up to 6 percent of compensation. No profit-sharing contributions were authorized for 2022 and 2021. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant’s account is credited with participant and Company contributions and is charged with an allocation of administrative expenses. Investment income is allocated daily based on the balance of each participant’s account in each investment fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. A participant may have three loans outstanding from the Plan at one time. The minimum amount of the loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest rates are set by the plan administrator at prime plus 1 percent.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan is considered to be in default if any scheduled payment remains unpaid beyond 90 days after each due date. Upon default, the participant can repay the loan, resume current status by paying any missed payment plus interest, or request distribution of the note. If the loan remains in default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested in the matching contributions described above after six years of continuous service. The nonvested portion is forfeited when a participant terminates employment.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or upon attainment of age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period. For termination of service for other reasons, a participant may receive the value of the vested balance in his or her account as a lump-sum distribution. If the participant's account balance is less than \$5,000, the plan administrator can make an automatic rollover of the account balance to a qualified individual retirement account. Distributions of a participant's 401(k) account balance may be authorized at any time by the plan administrator under certain hardship conditions.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$86,616, respectively. These accounts will be used to reduce employer-matching contributions and/or to pay administrative expenses. In 2022 and 2021, \$88,964 and \$17,790 forfeited nonvested accounts were used to reduce employer-matching contributions, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and money market funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3: Certification of the Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2022 and 2021.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4: Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50 percent or more of such an employer association or relatives of such persons.

Certain plan investments are shares of mutual funds managed by FMTC. FMTC serves as plan trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for investment management services amounted to \$26,492 and \$23,113 for the years ended December 31, 2022 and 2021, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2022, the Plan had reportable delinquent remittances of \$25,225 attributable to 2022.

Note 8: Tax Status

The Plan operates under a volume submitter adoption agreement in connection with a volume submitter plan sponsored by FMTC. This volume submitter plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the volume submitter constitutes a qualified plan under Section 401 of the Internal Revenue Code. The plan administrator believes the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 9: Plan Merger

On December 30, 2022, Bancsource 401(k) completed a merger into TSG Cennox, LLC 401(k) Plan and transferred all assets of the Plan on that date to Empower Retirement, the new record-keeper. This transaction initiated a "Black Out" period that continued through January 18, 2023. During this period, participants had limited access to their accounts until the record-keeper and custodian had time to accurately complete the transfer. During this period, employee contributions continued to be made through payroll deductions and the contributions were transferred to the successor plan and invested in funds as requested by each participant.

Note 10: Subsequent Events

Subsequent events have been evaluated through October 6, 2023, which is the date the financial statements were available to be issued.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. A participant may have three loans outstanding from the Plan at one time. The minimum amount of the loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest rates are set by the plan administrator at prime plus 1 percent.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. A loan is considered to be in default if any scheduled payment remains unpaid beyond 90 days after each due date. Upon default, the participant can repay the loan, resume current status by paying any missed payment plus interest, or request distribution of the note. If the loan remains in default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested in the matching contributions described above after six years of continuous service. The nonvested portion is forfeited when a participant terminates employment.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or upon attainment of age 59½, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a future period. For termination of service for other reasons, a participant may receive the value of the vested balance in his or her account as a lump-sum distribution. If the participant's account balance is less than \$5,000, the plan administrator can make an automatic rollover of the account balance to a qualified individual retirement account. Distributions of a participant's 401(k) account balance may be authorized at any time by the plan administrator under certain hardship conditions.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0 and \$86,616, respectively. These accounts will be used to reduce employer-matching contributions and/or to pay administrative expenses. In 2022 and 2021, \$88,964 and \$17,790 forfeited nonvested accounts were used to reduce employer-matching contributions, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and money market funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3: Certification of the Plan Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2022 and 2021.
- Investment income (loss) and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

Note 4: Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50 percent or more of such an employer association or relatives of such persons.

Certain plan investments are shares of mutual funds managed by FMTC. FMTC serves as plan trustee and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for investment management services amounted to \$26,492 and \$23,113 for the years ended December 31, 2022 and 2021, respectively. The Company provides certain administrative services at no cost to the Plan.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially adversely affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2022, the Plan had reportable delinquent remittances of \$25,225 attributable to 2022.

Note 8: Tax Status

The Plan operates under a volume submitter adoption agreement in connection with a volume submitter plan sponsored by FMTC. This volume submitter plan document has been filed with the appropriate agency and has obtained an opinion letter from the Internal Revenue Service stating that the volume submitter constitutes a qualified plan under Section 401 of the Internal Revenue Code. The plan administrator believes the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 9: Plan Merger

On December 30, 2022, Bancsource 401(k) completed a merger into TSG Cennox, LLC 401(k) Plan and transferred all assets of the Plan on that date to Empower Retirement, the new record-keeper. This transaction initiated a "Black Out" period that continued through January 18, 2023. During this period, participants had limited access to their accounts until the record-keeper and custodian had time to accurately complete the transfer. During this period, employee contributions continued to be made through payroll deductions and the contributions were transferred to the successor plan and invested in funds as requested by each participant.

Note 10: Subsequent Events

Subsequent events have been evaluated through October 6, 2023, which is the date the financial statements were available to be issued.
