## **Note 1 - Description of Plan**

The following brief description of the Oklahoma Temporary Service, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of Oklahoma Temporary Service, Inc. and related entities: Express Ranches, Inc.; Express UU Bar Ranch LLC; Funk Companies, LLC; Express Oil & Gas, LLC; and Tyler Personnel Services (collectively, the Company, Employer, and Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA).

The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed three months of service and are 21 years of age. Service need not be continuous and there is no minimum number of hours of service required.

### **Entry Date**

Employees may enter the Plan on the first day of January, April, July, or October coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan allows for employer discretionary matching contributions. From January 1, 2022 through June 30, 2022, the contribution was 50% of the first 6% of the employee's salary deferred for a maximum matching contribution of 3%. Beginning on July 1, 2022, the matching formula changed to 50% of the first 20% of the employee's salary deferred for a maximum matching contribution of 10%. In addition, the Plan allows for employer discretionary non-elective contributions. During the year ended December 31, 2022, there were no discretionary non-elective contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated American Funds Target Date (TD) fund until changed by the participant.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions (if any), allocations of the Company's discretionary non-elective contributions (if any), and Plan earnings. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3 years of credited service.

### **Forfeitures**

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$31,166 and \$21,148, respectively. These amounts will be used to reduce future employer discretionary matching contributions or offset plan expenses. During the year ended December 31, 2022, employer contributions were reduced by \$33,490 from forfeited non-vested accounts.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. Any terminated participants with a balance between \$1 and \$5,000 may be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½, hardship, or deemed severance due to military service as defined in the Plan document.

If a participant attains age 50 and is credited with at least 10 years of service while still employed by the company, he or she may elect to withdraw the vested portion of employer contributions in his or her account.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in the ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

## Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

## Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 and 2021.

Pooled separate accounts - Valued at fair value based on the net asset value (NAV) of the units held in the account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the account less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The pooled separate accounts consist of various investment options (i.e. common stock, mutual funds, short-term securities, real estate) and are valued based on the investments held. While the majority of the underlying asset values are quoted prices, the net asset value of the pooled separate accounts are not publicly quoted.

The following is a brief description of the nature and significant investment strategies of the major categories of pooled separate accounts:

(a) Asset allocation funds – These funds seek long term growth of capital by investing in alternative strategies and alternative asset classes.

(b) Aggressive growth funds – These funds aggressively seek capital appreciation and are designed primarily for aggressive investors seeking capital growth over the long-term. Investors should be willing to assume the substantial risks of short-term price fluctuations and losses that are typical for an aggressive fund focusing on stock investments in developing and emerging markets.

(c) Growth funds – These funds seek capital appreciation and invest primarily in common stocks and securities convertible into common stock. They may also invest in preferred stocks, warrants, and other debt securities.

(d) Conservative funds – These funds seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

(e) Income funds – These funds primarily seek to realize maximum total return, consistent with preservation of capital and prudent investment management.

(f) Growth & income funds – These funds seek to produce income and to provide an opportunity for growth of principal consistent with common stock investing. These funds strive to accomplish this objective through fundamental research, careful selection and broad diversification.

**Note 4 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments held at December 31, 2022 and 2021, and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by Nova 401k Associates, Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020 stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

During the year ended December 31, 2021, the Plan remitted certain participant contributions to the custodian later than required by Department of Labor Regulations. In order to prevent the Plan from incurring a qualification defect, the Plan's Sponsor has taken the necessary corrective action as further detailed in Note 8. The Plan Sponsor believes the Plan has maintained its tax-exempt status; therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are units of pooled separate accounts managed by John Hancock Asset Management. John Hancock Asset Management is an entity related to John Hancock Life Insurance Company, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

Certain fees incurred by the Plan for recordkeeping services are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than as a direct payment.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Delinquent Participant Contributions**

It was noted in 2021 that there was a delay by the Company in submitting employee contributions to the custodian of \$5,301. The Company has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays in submitting the contributions.

**Note 9 - Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The amount of excess contributions was \$0 and \$4,021 as of December 31, 2022 and 2021, respectively.

**Note 10 - Subsequent Events**

Effective January 1, 2023, the Plan was restated using a preapproved Plan sponsored by Nova 401(k). The restated Plan also included the following changes:

- The Plan entry date changed to the first day of the month coinciding with or next following date requirements are met.
- The Plan name was changed to The Funk Companies 401(k) Plan

The Plan Sponsor has evaluated subsequent events through October 10, 2023, the date which the financial statements were available to be issued.
