## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of WLC Architects, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of plan

The following description of the WLC Architects, Inc. 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan, which was established on January 1, 1989, is a defined contribution retirement plan under section 401(k) of the Internal Revenue Code (the “Code”). The plan was restated and effective August 1, 2012. The Plan is administered by WLC Architects, Inc. (the “Sponsor”, “Company”, or “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and is in conformance with all subsequent tax law changes.

#### *Eligibility*

The Plan is a defined contribution 401(k) profit sharing plan covering all employees of WLC Architects, Inc. Employees are eligible to participate in the Plan upon completing ninety days of eligible service. The ninety-day service requirement also applies to employer matching and discretionary contributions. However, participants must be employed by the Company as of the end of the Plan year to be eligible for an allocation of discretionary contributions. Former and inactive participants are entitled to contribute to the Plan upon completing an hour of eligible service.

Employees may make contributions to the Plan beginning on the first day of the month following eligibility. Participation continues until retirement, disability, termination of employment, or death, at which time the participant's vested account balance becomes subject to distribution.

#### *Contributions*

Participants may make contributions to the Plan in an amount not to exceed their compensation, subject to maximum annual legal limits. Participants may also make rollover contributions from other retirement plans. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers several investment options, including mutual funds, pooled separate accounts, common/collective trusts, and a fixed income guaranteed option. Participants may elect to change their investment options and transfer their account balances among the different investment options at any time.

The Sponsor matches at a rate of 10% for each \$1 contributed, up to a maximum of 6% of the participant's pretax compensation. Discretionary contributions may be contributed at the discretion of the Company's Board of Directors. The Company made discretionary contributions totaling \$0 and \$175,000 for the years ended December 31, 2022 and 2021, respectively.

#### *Participant accounts*

Participant accounts are credited with elective deferrals, employer matching contributions, allocation of discretionary contributions, investment income, and gains or losses as described in the Plan agreement. Allocations are based on participant deferrals and other factors, as defined by the Plan.

#### *Vesting and forfeitures*

Employee contributions are immediately vested and non-forfeitable. Company matching and discretionary contributions vest over a five-year period as described in the Plan agreement. Forfeitures of non-vested balances may be applied to reduce employer contributions.

#### *Notes receivable from participants*

Participants may borrow against their vested balance at a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested balance. The notes receivable are secured by the vested balance in the participant accounts. Interest is determined by the Sponsor based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Participants' notes receivable are for fixed terms, not to exceed five years, except for residential loan purposes, requiring regular periodic repayment by payroll deductions. A note receivable becomes immediately due and payable upon a participant's termination of employment, death, or disability. The notes receivable are valued at their outstanding balance plus accrued interest.

#### *Benefit payments*

The Plan provides for the payment of benefits to the participant, or their designated beneficiary, at retirement, death, disability or termination of employment. Participants terminating their employment with the Sponsor or attaining age 65 are entitled to withdraw all or a portion of their vested account balance. Hardship distributions, as outlined in the Plan, are permitted subject to the approval of the Sponsor. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum cash distribution or in installments in the form of a life annuity. Benefits under the Plan shall be distributed solely from the assets of the trust. Participants who separate from service and have vested account balances of less than \$5,000 are subject to an involuntary lump sum distribution at the discretion of the Sponsor.

#### *Plan administrative expenses*

Certain expenses are paid from Plan assets. All other expenses are paid by the Company. For the years ended December 31, 2022 and 2021, the Company paid \$12,000 for administrative costs relating to the Plan for each year.

### 2. Summary of significant accounting policies

#### *Basis of accounting*

The financial statements have been prepared using the accrual basis method of accounting.

#### *Use of estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### *Contributions*

Employee deferrals and employer matching contributions are recognized in the period in which the related compensation is earned. Discretionary employer contributions are recognized in the period they are determined or declared.

#### *Notes receivable from participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

#### *Payment of benefits*

Benefits are paid directly by the custodian and recorded when paid.

#### *Investment valuation and income recognition*

The Plan's mutual fund investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

The Plan's common collective trust is stated at fair value. The trust consists of Principal Lifetime Target Date Funds valued based on the underlying unit value of investments. Funds include affiliated open-ended mutual funds, insurance company separate accounts, unaffiliated mutual funds, and unaffiliated collective trust funds.

The Plan's pooled separate account is stated at fair value. The pooled separate account consists of the Principal Small Cap S&P 600 Index Fund. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

The Guaranteed investment contract is stated at contract value. See Note 5 for detail.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### 4. Fair value of investments

FASB ASC 820, *Fair Value Measurements and Disclosures* established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 4. Fair value of investments (continued)

Following is a description of the valuation methodologies used for assets measured at fair value:

- *Mutual funds*: Valued at the NAV of shares held by the plan at the close of business of the New York Stock Exchange (NYSE). Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Pooled separate accounts*: Valued and traded daily based on the net asset value (“NAV”) of the underlying assets (mutual funds) in each separate account. The fair value of shares of the underlying assets equals the number of shares of the respective underlying fund multiplied by the closing NAV per share quoted by that fund.
- *Common/collective trust*: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 5. Guaranteed investment contract

In 2012, the Plan entered into a fully benefit-responsive group annuity contract with Principal Life Insurance Company (Principal). The Principal Fixed Income Guaranteed Option is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value fund. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at fair value. As most participant transactions are executed using contract value without adjustment, the group annuity contract value is considered fair value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the group annuity contract at December 31, 2022 and 2021 was \$2,652,858 and \$2,431,828, respectively. The composite crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than the Guaranteed Minimum Interest Rate. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The average yields earned by the guaranteed investment contract are as follows:

Certain Plan investments are shares of mutual funds or are in a guaranteed interest fund managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the investment management services are included in the fund management fees.

### 7. Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

As a result of COVID-19, there has been heightened market risk and volatility associated with the pandemic, and this could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits, as mentioned above. Because of the uncertainty of the markets during this time, Plan management is unable to estimate the total impact the pandemic will have.

### 8. Tax status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for the years prior to 2019.

### 9. Plan termination

The Plan agreement provides that the Company may discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In August 2022, the Company merged \$18,620,469 of Plan assets into its parent company 401(k) Plan. The final merger of the remaining Plan assets was made in August 2023. The Company will begin the process to terminate the Plan subsequent to the final transfer of Plan assets to its parent company.
