INDEPENDENT AUDITORS' REPORT

To the Participants of

Viscofan USA Inc. Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Viscofan USA Inc. The following description of the Viscofan USA, Inc. Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined-contribution plan with a 401(k) savings option established on April 29, 1991, to provide retirement benefits for substantially all the employees of Viscofan USA Inc. (the “Sponsor”). Union employees of the Sponsor become participants in the Plan upon employment with the Sponsor and completion of a 90-day probation period. Non-union employees are eligible to participate upon hiring.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and Internal Revenue Code (“IRC”).

Contributions

Non-union participants may contribute to the Plan, on a pre-tax basis or after-tax basis, any percentage of his or her compensation and union participants may contribute to the Plan, on a pre-tax basis or after-tax basis, up to 20% of his or her compensation, as defined by the Plan, subject to Internal Revenue Code (“IRC”) limitations, in the form of a salary deferral (Elective Deferral Contribution). Participants who have attained or will attain age 50 by the end of a Plan year may also contribute to the Plan in such years, on a pre-tax basis, “catch-up” contributions, subject to IRC limitations, in the form of a salary deferral. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

Employees of the Sponsor who do not elect otherwise are automatically enrolled to contribute 3% of their compensation to the Plan. If the participant does not elect otherwise, contributions automatically increase 1% each year up to a maximum of 8%.

For union employees, prior to October 1, 2021, the Sponsor makes matching contributions for union employees equal to 90% of participants’ pre-tax salary deferral contributions (excluding catch-up contributions), up to 8% of participants’ annual compensation. Effective October 1, 2021, union employees hired after October 1, 2021, the Sponsor will make matching contributions in an amount equal to 100% of elective deferral contributions that are not over of 3% of compensation, plus 50% of elective deferral contributions that are over 3% of compensation but are not over 5% of compensation.

For non-union employees, the Sponsor makes matching contributions in an amount equal to 100% of elective deferral contributions that are not over 3% of compensation, plus 50% of elective deferral contributions that are over 3% of compensation but are not over 5% of compensation.

Investment options

The Plan’s investment assets are held by Principal Trust Company (the “Custodian”), the custodian of the Plan’s investment assets. Under an arrangement with the Custodian and upon enrollment in the Plan, participants direct all contributions in any whole percentage increments to any of the available funds. Participants may change their allocation among the various investment options at any time via telephone or the internet.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant, and (c) the earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Each participant is immediately fully vested in the entire balance of his or her account.

Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for purchase of a principal residence, in which case it may be 10 years. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. The interest rate on loans outstanding at December 31, 2022 was 4.25% - 8.00% and the rate was 4.25%-6.50% at December 31, 2021. A participant may only have two loans outstanding at a time.

Payment of benefits

Upon termination of employment, attainment of normal retirement age or for reasons of death or disability, participants may request a distribution in the form of a lump sum or partial installment. Participants still employed with the Sponsor may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose account balance does not exceed \$1,000 upon termination will receive a lump sum distribution of the account balance as soon as administratively feasible following termination of employment with the Sponsor. A participant whose account balance exceeds \$1,000 but does not exceed \$5,000 will have his or her account balance rolled over into an individual retirement account outside of the Plan in his or her name as soon as administratively feasible following termination of employment with the Sponsor.

Administrative expenses

Administrative fees associated with participant loans and certain distributions are paid by the Plan and charged to the accounts of the participants initiating the transactions. Also, participants who have separated from service with the Plan Sponsor and choose to maintain a balance in the Plan are charged an annual fee.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments includes realized and unrealized gains and losses on investments purchased and sold, as well as held, during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent events

The Sponsor has evaluated subsequent events through October 10, 2023, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedules.

The following information included in the accompanying financial statements was prepared and certified to be complete and accurate by the Custodian as of December 31, 2022 and 2021, and for the year ended December 31, 2022:

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

There were no changes in the methodology used during the year ended December 31, 2022.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price, and are deemed to be actively traded.
- Collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.
- Pooled separate accounts: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As disclosed in Note 10, the Plan's assets were held as cash and in the process of being transferred to another custodian as of December 31, 2022. The following tables set forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2021:

5. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for insurance, administration and professional services. Recordkeeping and administrative services are also provided by the Sponsor at no cost to the Plan.

The Plan offers, as investment options, certain funds managed by the Custodian. Accordingly, transactions in these investments qualify as party-in-interest transactions as defined by ERISA.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. RECONCILIATION TO FORM 5500

8. INCOME TAX STATUS

The Plan utilizes a volume submitter plan document sponsored by Principal Life Insurance Co., who was informed by the Internal Revenue Service ("IRS") by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the Sponsor believes that the Plan, as amended, is designed and is being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress. The plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2019.

9. PLAN TERMINATION

Although they have not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

10. PLAN AMENDMENTS

On August 15, 2022, the Plan document was restated to bring the Plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e., the 6-year pre-approved plan restatement cycle).

Effective January 1, 2023, the Sponsor terminated its agreement with Principal Trust Company and entered into a new trust and recordkeeping agreement with Charles Schwab Trust Bank ("Charles Schwab"). As of December 31, 2022, the Plan's assets were in the process of being transferred to Charles Schwab and are included as noninterest-bearing cash on the accompanying financial statements.

11. SUBSEQUENT EVENTS

Effective January 1, 2023, the Plan was merged into Viscofan USA, Inc. Retirement Savings Plan, another defined contribution plan maintained by the Sponsor. There have been changes in some of the provisions of the new plan. Participants should refer to the new plan document for a complete description of the plan's provisions.
