To the Plan Administrator and Participants of

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**1. Description of Plan**

**General**

The Quemetco, Inc. 401(k) Plan (the “Plan”) was initiated effective January 1, 1996. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more detailed information.

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019 was signed into law. Applicable provisions of the SECURE Act, effective January 1, 2021, include eligibility for long-term part-time employees. In December 2022, SECURE 2.0 was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions of SECURE 2.0 will become effective in 2024 and beyond. Therefore, there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

Effective February 2, 2022, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes. In addition to the restatement, the definition of compensation was changed to exclude unused leave, reimbursements or other expense allowances, fringe benefits, moving expenses, all deferred compensation, and welfare benefits.

Effective July 1, 2022, the Plan was frozen resulting in a temporary suspension of contributions.

**Transfer Out**

In conjunction with a resolution by the Company’s Board of Directors, the Plan was merged with the Eco-bat Technologies 401(k) Plan and all assets were transferred out of the Plan. Assets totaling \$2,057,575, were transferred on November 1, 2022. This transaction is reflected as “Transfer Out” on the Statement of Changes in Net Assets Available for Benefits.

**Eligibility**

The Plan was a defined contribution plan covering substantially all hourly employees of Quemetco, Inc. (the “Company”) located in Indianapolis, Indiana, and who are members of the United Steelworkers of America Local Union No. 1999, sub-district 3, District 7, as defined in the Plan document, upon completion of three months of service. Prior to the plan merger with the Eco-bat Technologies 401(k) Plan, employees who had satisfied the eligibility requirements could begin participating on the first day of the following month.

**Contributions**

Prior to the plan merger with the Eco-bat Technologies 401(k) Plan, participants could elect to contribute a pre-tax contribution of up to 60% of covered compensation, subject to annual limits established by the Internal Revenue Service. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified retirement plans. The Plan allowed the employer to make a Qualified Non-elective Employer Contribution ("QNEC") at its option. Participants are immediately vested in any QNEC made. QNEC contributions of \$520 were made for the period from January 1, 2022 to November 1, 2022. The CBA required the Company to make matching employer contributions to eligible employees equal to 20% of the employee's contributions, up to a maximum of 5% of the employees' eligible compensation. The Plan permitted the Company to make such matching contributions to participants that had completed three months of service. Participants direct the investment of their contributions and the Company's contributions into various mutual fund investments offered by the Plan.

Contributions from Plan participants and the associated matching contributions from the Company were recorded in the year in which the employee contributions are withheld from compensation.

**Participant Accounts**

Each participant's account was credited with the participant's contributions, matching contributions, QNEC, and actual earnings thereon. Earnings were allocated to each participant's individual fund account based on the earnings of the individual investment options chosen by the participant and as defined by the Plan document. Participants may make changes to their investment allocation at any time. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting and Forfeitures**

Participants were vested immediately in their contributions plus actual earnings thereon. A participant was also immediately vested in any QNEC made by the Company. Participants become 100% vested in any Employer matching contributions upon completion of three years of service. Forfeitures resulting from terminations could be used to reduce future Employer matching contributions. For the period from January 1, 2022 to November 1, 2022, employer matching contributions of \$520 were forfeited. As of November 1, 2022 and December 31, 2021, an unallocated forfeiture balance of \$0 and \$188, respectively, was available to reduce future employer contributions.

**Notes Receivable from Participants**

Participants could borrow up to the lesser of \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior twelve month period, or 50% of their vested account balance. The minimum participant loan amount was \$1,000. Loans were secured by the balance in the participant's account and bore interest at a reasonable fixed rate as determined by the plan administrator at the inception of the loan. Loans were repaid ratably through after-tax payroll deductions on at least a quarterly basis over a five year period, unless the loan was used to purchase the principal residence of the participant, in which case it may not exceed ten years. Participants may not have more than one loan outstanding at any given time.

**Payment of Benefits**

A participant or designated beneficiary was entitled to his or her employee contributions and any earnings thereon in the event of death, disability, termination of employment or attainment of normal retirement age. Participants could elect to receive their benefit in a lump sum distribution, as a series of installment payments, or as a direct rollover.

The Plan also permits in-service distributions and hardship distributions, in certain circumstances, as defined by the plan document.

**2. Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan’s investments in registered investment companies (mutual funds) are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. Refer to Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants represent loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized on an accrual basis. No allowance for credit losses has been recorded as of November 1, 2022 and December 31, 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

**Subsequent Events**

Subsequent events have been evaluated through the date of the report of independent auditors, which is the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

**3. Information Prepared and Certified by the Trustee (unaudited)**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at November 1, 2022 and December 31, 2021, and net depreciation in fair value of investments and interest and dividends for the period from January 1, 2022 to November 1, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

**4. Fair Value Measurements**

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 1, 2022 and December 31, 2021.

*Money market fund:* Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end money market fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (“NAV”) and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

*Mutual funds:* Valued at the NAV of shares held by the Plan at year end. When calculating a fund’s NAV, Fidelity uses the last quoted sales price at the time of valuation for securities for which market quotations are readily available. When there are no readily available market quotations for a security, Fidelity typically values it at the amount which the fund might reasonably expect to receive for the security upon a current sale.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related Party and Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee and, therefore, these transactions qualify as party in interest transactions. All of these transactions are exempt from the prohibited transaction rules.

**5. Related Party and Party-In-Interest Transactions (continued)**

Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to the third-party administrator totaling \$1,014. These costs incurred by the Plan are included in administrative expenses on the statement of changes in net assets available for benefits. The plan sponsor pays directly any other fees related to the Plan's operations.

**6. Merger of the Plan**

Effective November 1, 2022, in conjunction with a resolution by the Company's Board of Directors, the Plan was merged with the Eco-Bat Technologies, 401(k) Plan. Plan assets totaling \$2,057,575 were transferred on November 1, 2022.

**7. Income Tax Status**

The Company adopted a prototype plan sponsored by Fidelity Management & Research Company ("Fidelity") effective June 30, 2020. Fidelity received an opinion letter dated June 30, 2020 from the Internal Revenue Service ("IRS"), which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan itself has not received a determination letter from the IRS and has been amended since receiving the letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits taken by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

**8. Risks and Uncertainties**

The Plan offers a number of investment options to participants that are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

On March 11, 2020, the World Health Organization declared the novel strain of coronavirus ("COVID-19") a global pandemic and recommended containment and mitigation measures worldwide. The pandemic and these containment and mitigation measures have led to economic uncertainties which have resulted in significant volatility in the financial markets, impacting some of the investments held by the Plan. The duration of these uncertainties and volatility, and the ultimate financial effects of COVID-19 on the national and global economies and investment markets, cannot be reasonably estimated at this time.

**9. Administrative Failures**

*Delinquent Participant Contributions*

During the year ended December 31, 2021, the Company failed to remit certain participant contributions to the Plan within the time frame required by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting a non-exempt (prohibited) transaction between the Plan and the Company. Delinquent remittances of participant contributions and loan repayments amounted to \$14,734. Effective February 10, 2023, plan management has corrected this administrative failure by calculating and contributing the lost earnings through the IRS Voluntary Fiduciary Correction Program ("VFCP"). Lost earnings of \$10 were contributed to the successor plan, the Eco-bat Technologies 401(k) Plan.

*Supporting Documentation*

Per the Plan document, upon proper notice and approval from the employer, a participant may elect to not contribute on bonus compensation. During the Plan year ended December 31, 2021, the Company failed to retain employee elections to exclude bonuses from eligible compensation which is in violation of the terms of the Plan document. Plan management has implemented procedures to help prevent such an error from occurring in the future.
