#### **Note 1: Description of the Plan**

The following description of Frasca International, Inc. Employee 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General and Plan Merger***

The Plan is a defined contribution plan sponsored by Frasca International, Inc. (Company) for the benefit of its full-time employees who are at least age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Bank of America, N.A., serves as Plan trustee.

On November 23, 2022, the Company's Board of Directors (Board) approved to merge the Plan into the FlightSafety Employees' 401(k) Retirement Plan (FlightSafety) effective as of December 31, 2022. The merger initiated a "Blackout" period beginning December 28, 2022 through January 22, 2023. During this blackout period, participants were unable to change contribution rates, investment elections, or request a loan distribution from the Plan. At the conclusion of the blackout period, the participants' Plan accounts were reflected in their FlightSafety plan account. Plan investments were liquidated on December 30, 2022 and proceeds are held in a money market fund as of December 31, 2022. Legal title of all Plan assets transferred to the FlightSafety plan on December 31, 2022. All plan assets were transferred to the FlightSafety plan by February 14, 2023.

#### ***Contributions***

The Plan permits employee contributions through a salary deferral election up to the maximum allowable amount per the limitations of the Internal Revenue Code. Employees are automatically enrolled to contribute 3 percent of eligible wages to the plan upon eligibility, with annual increases of 2 percent until the contribution percentage equals 11 percent of the Participant's eligible compensation. The Company's contribution is at the discretion of the Company's Board of Directors, which for the years ended December 31, 2022 and 2021, was 50% of employees' salary deferral amounts on the first 2 percent to 5 percent of eligible compensation. Contributions are subject to certain limitations. The Plan also allows Roth elective deferral and rollover contributions.

#### ***Participant Investment Account Options***

Participants directed the investment of their contributions, as well as the Company's contribution, into various investment options offered by the Plan. The Plan offered various mutual funds and a common collective trust fund as investment options for participants. Each participant had the option of directing their contributions into any of the separate investment accounts and could change the allocation daily.

The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Currently, the automatic deferral feature is set at 3 percent with automatic annual increases.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution, Plan earnings and forfeitures of terminated participants' nonvested accounts and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after 6 years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are first used to offset Plan administration expenses and then to reduce employer contributions under the Plan. Effective with the merger to the FlightSafety plan, participants' became 100% vested in any previously nonvested Company contributions.

#### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his account or a joint and survivor annuity. At December 31, 2022 and 2021, there were no assets allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

#### ***Notes Receivable from Participants***

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50 percent of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on the Wall Street Journal Prime Rate plus one percent as of the last business day of the previous month from the loan date.

#### ***Forfeited Accounts***

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$2,598 and \$4,077, respectively. These accounts were used to reduce Plan expenses or reduce future employer contributions under the Plan. In 2022 and 2021, there were no forfeitures from nonvested accounts used to reduce Plan expenses or employer contributions.

#### ***Plan Termination***

The Company had the right under the Plan to discontinue its contributions and terminate the Plan subject to ERISA.

## **Note 2: Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments. The money market fund is stated at fair value. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan's interest in the common collective trust fund was valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document. Notes receivable from participants of \$128,184 were transferred out of the Plan to the FlightSafety plan during December 2022.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invested in certain funds managed by Merrill Lynch Bank & Trust Company, FSB, a subsidiary of Bank of America, N.A., the trustee of the Plan. Fees paid by the Plan to the trustee for administrative services amounted to \$1,425 and \$12,032 for the years ended December 31, 2022 and 2021, respectively. The Plan incurs expenses related to general administration and record keeping. The Company pays these expenses and certain accounting and auditing fees relating to the Plan.

#### **Note 6: Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype plan and trust/custodial document sponsored by Merrill Lynch Pierce Fenner & Smith, Inc. This prototype plan document has been filed with the appropriate agency and obtained a determination letter dated March 31, 2008 from the Internal Revenue Service stating that the prototype constitutes a qualified plan under section 401 of the Internal Revenue Code and that the related trust was tax exempt. The Plan has been amended since adopting the prototype plan. However, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

#### **Note 7: Reconciliation of Financial Statements to Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the IRS and the accompanying financial statements include reporting total assets held as investments in a money market fund of \$16,293,286 with a related liability of these investments held on behalf of the FlightSafety Plan of \$16,288,318 (net of excess contributions payable of \$4,968) in the accompanying statement net assets available for benefits and supplemental schedule of assets (held at end of year).

#### **Note 8: Subsequent Events**

Subsequent events have been evaluated through October 10, 2023 which is the date the financial statements were available to be issued.
