INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrators of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Auxiant 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Auxiant 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended, December 31, 2022 and 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

INDEPENDENT AUDITOR'S REPORT, CONTINUED

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Auxiant 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Auxiant 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Auxiant 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS
December 31, 2022 and 2021

1. Description of the plan

The following brief description of the Auxiant 401(k) Retirement Plan (the “Plan”), a defined contribution plan, is provided for general information purposes only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

The Plan covers any employee of Alliance Benefit Group Medical Services, LLC, Auxiant, Inc. (f/k/a Employee Group Services, Ltd.), and Midwest Health Partners, LLC (collectively the “Company” or “Plan Sponsor”) who is at least nineteen years of age and has completed six months of service. Employees become participants the first day of the month immediately following meeting the age and service requirements. The Plan allows participants to designate all or a portion of their elective deferrals as Roth elective deferrals. Roth elective deferrals are accounted for separately in the respective participant’s account. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

On March 27, 2020, The Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was passed by Congress. The CARES Act provided fast and temporary relief for retirement plan sponsors and their participants. The provisions of the CARES Act were allowed to be effective and implemented immediately, prior to amending the plan document. The Plan implemented the following relief provisions, which did not have a significant impact on the Plan’s net assets available for benefits. Impacted participants were allowed to make Coronavirus-related distributions of up to \$100,000 before December 31, 2020. In addition, impacted participants could borrow up to \$100,000 or 100% of their vested account balance for 180 days starting March 27, 2020 through September 23, 2020 as well as defer loan payments on notes receivable for one year and required minimum distributions were waived for the 2020 calendar year. The Plan was formally amended in 2022 for these provisions.

Contributions

The Plan is funded by contributions from participants in amounts up to 60% of eligible compensation, limited to the maximum amount deductible under the Internal Revenue Code. Participants are automatically enrolled with a 3% deferral rate on the first day of the month immediately following meeting the age and service requirements, if no election is made by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan is also funded by safe-harbor matching contributions and discretionary non-elective contributions. During 2022 and 2021, the Company made matching contributions equal to 100% of each participant’s elected salary deferral up to 3% plus 50% of each participant’s deferrals in excess of 3% but not to exceed 5% of the participant’s compensation for the Plan year, also limited. There were no discretionary non-elective contributions made during 2022 or 2021. Participants may also rollover or transfer amounts representing distributions from other qualified retirement plans.

1. Description of the plan, continued

Participant accounts

Each participant's account is credited with the participant's contributions, employer safe-harbor contributions, Plan earnings, and charged with an allocation of any administrative expenses. Allocations are based on participants' compensation or account balances, or specific participant transactions, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary deferrals, safe-harbor matching contributions, and rollover contributions, plus earnings thereon. Vesting in discretionary non-elective contributions is based on years of continuous service. Participants vest 15% after one year of service, 45% after two years of service, becoming 100% vested after three years of service or upon the participant's death, disability, or attaining normal or early retirement age, as defined in the Plan Agreement.

Investment options

Upon enrollment in the Plan, participants direct the investment of their contributions into various investment options offered by the Plan. For participants who are automatically enrolled, their contributions are invested in default investments as defined in the Plan Agreement. Participants may change their investment options at their discretion; changes become effective the same business day or the next business day.

During 2022 and 2021, Plan management made changes to the Plan's investment options. Any assets invested in a fund removed from the Plan were transferred to a corresponding new fund, unless otherwise directed by the participant. These investment changes were made to achieve better long-term performance and decrease costs.

Forfeited accounts

During 2022 and 2021, there were no forfeited nonvested accounts. Forfeitures, to the extent available, may be used to pay Plan expenses or allocated to participants as additional discretionary non-elective contributions. No forfeitures were used during 2022 or 2021. Effective January 1, 2023, forfeitures, to the extent available, may be used to pay Plan expenses, be allocated to participants as additional employer contributions or be used to offset employer contributions. As of December 31, 2022 and 2021, there were no unallocated forfeitures available for future use.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These limits were temporarily changed under the CARES Act, as previously disclosed. Loan terms cannot exceed five years, unless used to purchase a personal residence. The loans are secured by the balance in the participant's account and bear interest at 2% above the Wall Street Journal prime rate. Principal and interest are paid ratably through payroll deductions.

1. Description of the plan, continued

Payment of benefits

Upon retirement, death, disability or termination of service, participants may elect to receive either a lump-sum amount equal to the value of their vested benefit or installment payments if the participant is subject to required minimum distributions. Participants with an account balance of less than \$5,000 automatically have balances rolled into an individual retirement account. Benefit payments for account balances greater than \$5,000 are made at the election of the participant.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their discretionary non-elective contributions.

2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Concentrations of investment risk

As of December 31, 2022 and 2021, 10% of the Plan's investments were in one mutual fund. In addition, approximately 46% and 37% of the Plan's investments were held by three and two mutual fund families as of December 31, 2022 and 2021, respectively. Each mutual fund family as well as the mutual fund held in excess of 10% of the Plan's total investments.

Investment valuation and income recognition

Investments are reported at fair value. Collective investment trust is valued at net asset value ("NAV") which is used as a practical expedient to estimate fair value. Fair value is defined as the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

2. Summary of significant accounting policies, continued

Notes receivable from participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

Payment of benefits

Benefits are recorded when paid.

Income tax status

The Plan is a nonstandardized prototype plan. The Internal Revenue Service (“IRS”) has determined and informed the custodian by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been restated and amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events

Management has evaluated subsequent events through September 27, 2023, the date the financial statements were available to be issued.

3. Information prepared and certified by Alerus Financial, N.A. (“Alerus”), a party-in-interest

All assets of the Plan were held by Alerus, a party-in-interest discussed at Note 7, as of December 31, 2022 and 2021. All transactions during the years ended December 31, 2022 and 2021 were executed under formal custody agreements between the Plan and Alerus. All securities bought, sold, or exchanged were executed under these agreements. Such financial information has not been audited by independent auditors.

3. Information prepared and certified by Alerus Financial, N.A. (“Alerus”), a party-in-interest, continued

In accordance with the provisions of section 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, Alerus has certified the following unaudited financial information to be complete and accurate with respect to the Plan’s assets held by them as of December 31, 2022 and 2021, and the activity for the years then ended, respectively:

4. Risks and uncertainties

The Plan invests in various investment securities, which in general, are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

5. Fair value measurements, continued

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Collective investment trust: Valued at the net asset value ("NAV") of units of a common collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions, including redemptions, may occur daily. Were the Plan to initiate a redemption, the investment adviser reserves the right to temporarily delay withdrawal from the trust up to 12 months in order to ensure securities liquidations will be carried out in an orderly business manner. The trust does not have a finite life and the Plan has no unfunded commitments.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held no investments in Levels 2 or 3 of the fair value hierarchy as of December 31, 2022 and 2021.

The Plan's policy is to recognize transfers between Levels as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2022 and 2021, there were no transfers between Levels.

6. Administrative expenses

Administrative expenses for the maintenance of investments, contributions and distributions records, and the processing of related transactions are paid to Alerus, a party-in-interest. Total fees paid to Alerus are reduced by 12b-1 payments and similar compensation ("revenue sharing credits") received by Alerus. During 2022 and 2021, revenue sharing credits of \$3,429 and \$16,151, respectively, were used to pay fees. Net administrative fees of \$39,347 and \$25,775 were paid to Alerus during 2022 and 2021, respectively. Effective January 2022, fees paid to Alerus are no longer reduced by revenue sharing credits; rather the Plan receives revenue sharing credits directly. During 2022 and 2021, the Plan received revenue sharing credits totaling \$8,557 and \$-0- and are included in other income on the Statement of Changes in Net Assets Available for Benefits. Loan processing fees and distribution fees are charged directly to the respective participant's account when incurred and are included in administrative expenses. The Plan Sponsor pays all other administrative expenses of the Plan, including audit fees.

7. Related party and party-in-interest transactions

The Company has an agreement with Alerus to provide record-keeping, administrative, custodial, and transaction processing services for the Plan's investments. Other party-in-interest transactions are described in Notes 3 and 6.

During the 2022 and 2021 plan years, the Company failed to remit employee contributions and loan payments of \$-0- and \$37,253, respectively, to the trust within the time frame required by the Department of Labor under the plan asset rules.
