## Independent Auditors' Report

### The Plan Administrator of Pioneer Bank 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed audits of the accompanying financial statements of Pioneer Bank 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 29, 2022 (liquidation basis) and December 31, 2021 (accrual basis), and the related statement of changes in net assets available for benefits (liquidation basis) for the period from January 1, 2022 to December 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 29, 2022 and December 31, 2021 and for the period from January 1, 2022 to December 29, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### **Basis of Accounting**

As discussed in Note 1 to the financial statements, liquidation of the Plan was approved effective March 31, 2022, and the Plan ceased to exist on December 29, 2022. As a result, the Plan has changed its basis of accounting from the ongoing basis to the liquidation basis as of that date. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. ### **1. Plan Description**

The following description of the Pioneer Bank 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Pioneer Bank SSB (the "Company" or "Employer"). Employees are eligible to participate in the Plan on the first day of each month upon attainment of 20 years of age and completion of 1 month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective March 31, 2022, the Plan was approved for termination. All participants become fully vested in their account balance as of March 31, 2022. All Plan assets related to plan participants have been distributed as of December 29, 2022.

#### ***Contributions***

Each year, eligible employees may contribute up to 100% of their eligible compensation on a pre-tax or Roth basis, as defined in the Plan, subject to certain Internal Revenue Code ("IRC") limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

The Employer will make a fully vested safe-harbor matching contribution to each participant's account in the amount of 100% of each dollar a participant defers up to 3% of eligible compensation and 50% of each dollar a participant defers to the Plan for an additional 2% of eligible compensation. This contribution is intended to satisfy a safe harbor contribution formula permitted by the IRC.

The Employer may make a discretionary matching and/or a discretionary nonelective contribution. For the 2022 plan year, no discretionary matching or a discretionary nonelective contribution were made to the Plan.

#### ***Vesting***

Participants are 100% vested in their salary reduction contributions, Employer safe-harbor matching contributions plus account earnings thereon at all times. Employer discretionary matching and discretionary nonelective contributions are subject to a graduated vesting schedule. A participant vests at 20% after one year of eligible service and an additional 20% for each additional year of service. Participants become 100% vested after five years of service.

Former Employees of FC Holdings, Inc. hired prior to January 1, 2017 are 100% vested in discretionary matching contributions.

Effective March 31, 2022, all participants became 100% vested in the employer contribution portion of their Plan accounts as a result of the Plan termination.

### 1. Plan Description (*continued*)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

#### ***Forfeitures***

All forfeitures are used to pay Plan administrative fees and recordkeeping expenses. If forfeitures are not sufficient to pay these fees and expenses for the year, the remaining amounts will be paid by the Company. In any year when forfeitures exceed expenses, the excess may be used to reduce future Employer contributions or reserved to cover future Plan expenses. At December 29, 2022 and 2021, forfeited non-vested accounts totaled \$0 and \$47. In 2022, \$3,396 were used to reduce Plan expenses and no forfeitures were used to reduce Employer contributions.

#### ***Notes Receivable from Participants***

Loans of up to 50 percent of a participant's vested account balance that are not less than \$1,000 or no more than \$50,000 are permitted subject to the approval of a loan application. Participants may not have more than one loan outstanding at any time. The notes receivable from participants will bear a reasonable interest at rate as determined by the Plan Administrator. Loans are repaid through payroll deductions over a period of between one and five years, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a 10 period.

#### ***Payment of Benefits***

Upon termination of service for any reason a participant may receive the value of the vested interest in their account as a lump-sum distribution. In-service distributions are available to participant who have reached age 59 ½. Benefits can also be distributed in the event of a participant's immediate and heavy financial need.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

As a result of the decision to terminate the Plan effective March 31, 2022, and in accordance with U.S. generally accepted accounting principles ("U.S. GAAP"), the Plan's financial statements for the period January 1, 2022 through December 29, 2022 are presented using the liquidation basis of accounting. For periods prior to the decision to terminate the Plan, the financial statements were prepared using the ongoing basis of accounting. Under the liquidation basis of accounting, assets are stated at their estimated net realizable cash value and liabilities are stated at their anticipated settlement amounts. As final plan distributions were made through December 29, 2022, there are no material changes to the 2022 financial statements as a result of the change under the liquidation basis of accounting. The preparation of financial statements in conformity with U.S. GAAP requires the Plan sponsor or plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. These estimates are based on information available at the time the estimates are made. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As a result of the distribution of all Plan assets, no investments were held by the Plan at December 29, 2022. At December 31, 2021, the Mutual funds were valued using level 1 inputs and the Stable value fund was valued at Net Asset Value ("NAV").

#### ***Investment Valuation and Income Recognition***

All investments are stated at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Morley Stable Value Fund is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2022 to December 29, 2022.

### **2. Summary of Significant Accounting Policies (continued)**

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2023.

### **3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 29, 2022 and December 31, 2021, and net depreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the period from January 1, 2022 to December 29, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### **4. Related Party Transactions**

Certain investments of the Plan are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

### 5. Morley Stable Value Fund

The Plan invested in a fully benefit-responsive investment contract called the Morley Stable Value Fund (the "Fund"). The Fund is a collective investment trust maintained by Principal Global Investors Trust Company and Morley Capital Management is the investment manager of the Fund. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile and liquidity for benefit responsive plan or participant payments. The Fund does not have a set interest rate since it owns several investment contracts with varying rates and maturity dates. Withdrawals from the Fund for benefit payments and participant transfers to noncompeting options may be made within 30 days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the trustee's approval. Were the Plan to initiate a full redemption of the Fund, the investment manager reserves the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund had no unfunded commitments at December 31, 2021. The Fund represents approximately 0% and 2% of the Plan's net assets available for benefits as of December 29, 2022 and December 31, 2021.

### 6. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the volume submitter preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.
