We have performed audits of the financial statements of Sound Plastics, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 1, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period ended December 1, 2022 and the related notes to the financial statements.

**Note 1 - Plan Description**

The following description of Sound Plastics, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was a defined contribution plan covering substantially all employees of Sound Plastics, LLC dba Cascadia Custom Molding (the "Company") who had completed six consecutive months of service and were not represented by a bargaining unit that has bargained with the Company on the subject of retirement benefits, certain nonresident aliens who have no earned income from sources in the United States, leased employees, or independent contractors. Participation by eligible employees is voluntary. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan's sponsor and serves as plan administrator.

**Contributions**

The Plan provided for employee salary deferral contributions up to 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). The Plan allowed participants to contribute up to 100 percent of their compensation on an after-tax basis subject to legal limits set by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company was able to make discretionary matching contributions. Participants contributing to the Plan were eligible to receive an allocation of the Company discretionary contribution. The discretionary contributions were made on the first 100 percent of employee contributions, up to 3 percent. The Company was also able to make a discretionary profit-sharing contribution to those participants employed on December 31 of the plan year with at least 1,000 hours of service in the plan year. The Company made matching contributions of approximately \$109,000 and made no profit-sharing contribution for the period ended December 1, 2022.

**Participant Notes Receivable**

Participants were able to borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, and notes receivable were collateralized by the participants' account balances. All loans had to be repaid within a period of five years. Plan loans bore an interest rate of 1 percent above the prime rate of interest published in *The Wall Street Journal* as of the date the loan documents were prepared. Principal and interest were paid ratably through payroll deductions.

**Participant Accounts**

Each participant's account was credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations were based on participants' compensation or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account. Participants could direct the investments of their account balances into various investment options offered by the Plan.

**Vesting**

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon was based on years of continuous service.

***Benefit Payments***

Benefit payments were made to a participant (or the participant's beneficiary in the case of death) under the following circumstances: termination of service due to death, disability, or retirement. A participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals of at least \$1,000, or installments if the vested interest exceeds \$5,000. For termination of service for other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants could request in-service distributions if a participant reached age 59½ and hardship distributions, as defined in the plan document.

***Forfeitures***

If a participant was not fully vested on his or her termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future company contributions or to pay administrative expenses of the Plan.

***Party-in-interest Transactions***

Certain plan assets were in investment funds managed by Charles Schwab Trust Bank or its affiliates. Charles Schwab Trust Bank was the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

The Company had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments were stated at fair value except as noted below. The fully benefit-responsive unallocated contract was valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. All other investments were valued based on quoted market prices reported in active markets. Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded as earned. Dividends were recorded on the ex-dividend date.

See Note 5 for additional information.

***Participant Notes Receivable***

Participant notes receivable were recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable were written off when deemed uncollectible.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Benefit Payments***

Benefits were recorded when paid.

***Excess Contributions Payable***

Corrective distributions could be required in the event that employee contributions exceed contribution limitations of the Plan. These amounts were recorded as a liability in the year in which they were initially contributed to the Plan.

***Administrative Expenses***

Various administrative costs were paid by the Company. These transactions qualified as party-in-interest transactions.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 6, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Charles Schwab Trust Bank (the "Custodian") held the Plan's investments and executed all related investment transactions during the periods under audit. The investment balances and related investment income and losses included in the accompanying financial statements were based solely on information certified by the Custodian.

**Note 4 - Tax Status**

The Plan used a preapproved plan. The preapproved plan had received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan had not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value was based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 5 - Fair Value Measurements (Continued)**

Fair values determined by Level 2 inputs use other inputs that are observable either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures mutual funds at fair value on a recurring basis. The fair value of the mutual funds is based primarily on Level 1 inputs at December 31, 2021.

**Note 6 - Investment Contracts**

The Plan had a fully benefit-responsive investment contract (FBRIC) with Standard Insurance Company (Standard). Standard maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Interest was credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate was applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates were reviewed on a quarterly basis for resetting but may not be less than 1 percent. When establishing interest crediting rates for this product, Standard considered many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limited the ability of the Plan to transact at contract value with the issues. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events were probable that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreements without the consent of the issuer.

**Note 7 - Plan Merger**

Effective December 1, 2022, the Plan merged into the VRC Intermedco, Inc. 401(k), a defined contribution plan sponsored by VRC Intermedco, Inc. (owner of the Plan's plan sponsor). Accordingly, all of the participants' assets in the Sound Plastics, Inc. 401(k) Plan totaling approximately \$5,362,000 were accounted for in the VRC Intermedco, Inc. 401(k) on December 1, 2022. This amount is included in the transfers out of the plan line item on the statement of changes in net assets available for benefits. The Sound Plastics, Inc. 401(k) Plan was terminated subsequent to the merger.
