Note A – Description of Plan

The following description of the Anomaly Communications 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement plan covering all employees of Anomaly Partners, LLC and its participating employers: Ace Content, LLC and 7thfl, LLC (collectively, the “Employer” or “Company”). The Plan was formed and adopted on September 1, 2006, and was most recently amended and restated effective April 1, 2022, to bring the Plan into compliance with the legislative and regulatory changes in IRS Notice 2017-37. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

All employees, excluding freelance employees, are eligible to participate in the Plan upon their date of hire. Entry into the Plan is then possible on the date requirements for eligibility met.

The Plan was merged into the Stagwell Global 401(k) Plan (“Stagwell”) and was effectively terminated on December 31, 2022 with Stagwell as the surviving plan.

Administration

The Plan is administered by the Company. The Plan’s assets are held and managed by T. Rowe Price Trust Company (the “Trustee”). Contributions are held by the Trustee, who invests cash received, interest and dividend income, as directed by the participant, and makes distributions to participants.

Contributions

The Plan allows eligible participants to make contributions up to 85% of compensation per payroll period, as defined by the Plan agreement, limited by requirements of the Internal Revenue Code (“IRC”). The maximum participant deferral for December 31, 2022 was \$20,500. A participant who has attained the age of 50 may also make catch up contributions, subject to IRS limitations of \$6,500 for December 31, 2022. Participants may also contribute amounts representing distributions from other qualified plans as well as Roth 401(k) deferrals.

The Company may make matching contributions at its discretion as a percentage of the participant’s elective deferrals to the Plan. For the year ended December 31, 2022, the Company matched contributions at a rate of 100% for the first 6% of participant deferrals.

Participants direct the investment of their contributions and Employer contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account reflects the participant’s contributions as well as an allocation of the Company’s contributions and Plan earnings and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the aggregate total of such contributions and allocations. This benefit is subject to the application of the Plan’s vesting schedule.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's matching contribution portion of their accounts is based on years of continuous services. A participant is 100% vested upon death, disability, or after three years of credited service as follows.

Forfeitures

Under the Plan, forfeitures are first used to pay Plan administrative expenses. Any remaining forfeitures may be used to reduce future Employer contributions. As of December 31, 2022 and 2021, forfeited non-vested accounts totaled approximately \$8,000 and \$11,000, respectively. For the year ended December 31, 2022, approximately \$86,000 of forfeitures were used to reduce Employer matching contributions.

Distribution of Benefits

Upon retirement, reaching age 59 ½ or due to hardship, a participant may elect to either receive their benefit as a lump-sum amount equal to the value of their account, or in annual installments over a ten-year period. If an employee becomes disabled while a participant, they will become fully vested and entitled to receive benefits as if they had retired. If a participant dies while employed by the Company their account becomes fully vested and the designated beneficiary of their death benefits may elect to obtain the amount as a single lump-sum payment, in installment payments over the beneficiary's assumed life expectancy or by making partial withdrawals. If a participant is terminated from employment, the balance of their account's vested interest will be distributed to them in a lump-sum payment. Participants with account balances in excess of \$5,000 may elect to postpone distribution of benefits until required by law.

Notes Receivable from Participants

Participant loans are not permitted by the Plan.

Plan Termination

All Plan assets were merged into the Stagwell as the surviving plan and effective December 31, 2022, all participants became 100% vested. Participants were notified in writing that they have 30 days to request distribution of funds contributed to the Plan or were given the option to roll over the assets to an eligible retirement plan. The actual transfer of funds was date January 10, 2023.

Note B – Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and the changes in net assets available for benefits and disclosure of contingent assets and liabilities during the reporting period. Actual results could differ from these estimates.

Valuation of Investments

The Plan's investments are stated at fair value. If available, quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. The Plan's interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Money market funds: These are open-ended money market mutual funds valued at a \$1.00 stable net asset value (“NAV”) for reporting purposes, and transact at \$1.00 for subscription and redemption activity. However, on a daily basis the funds NAV is calculated using the amortized cost (not market value) of the securities held in the fund.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at NAV provided by the Trustee. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments to purchase investments at December 31, 2022 and 2021. Participant-directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution. For the year ended December 31, 2022, the Plan Administrator instructed the auditors not to perform any auditing procedures with respect to the information certified by the Trustee, except for comparing such information to the related information included in the financial statements, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note D – Party-In-Interest Transactions

Fees paid during the year for accounting and other services rendered by parties-in-interest were based on customary and reasonable rates for such services. Certain Plan investments and the related transactions as of December 31, 2022 and 2021, and for the year ended December 31, 2022, were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid to parties-in-interest by the Plan for services amounted to approximately \$24,000 during the year ended December 31, 2022.

Note E – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note F – Income Tax Status

The IRS has determined that the prototype profit sharing plan is designed in accordance with applicable sections of the IRC and informed the Trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan and related trust are currently being operated in compliance with the applicable requirements of the IRC.

Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2020.
