We have performed audits of the financial statements of GenMark Diagnostics 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## 1. Description of Plan

The following description of the GenMark Diagnostics 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### *Plan Merger*

Effective April 23, 2021, the Company was acquired by Roche Holdings, Inc. (Roche). In connection with the acquisition, the Plan was frozen to new participants and new participant contributions, as well as new loans effective January 1, 2022. Former eligible employees of the Company who became employees of Roche on January 1, 2022 became eligible to participate in the US Roche 401(k) Plan (Roche Plan) effective on that date.

Effective October 28, 2022, the Plan was merged into the US Roche 401(k) Plan. See Note 4.

### *General*

The Plan was a defined contribution plan established effective April 1, 2003, as restated effective July 21, 2021. The Plan covered all employees, excluding resident of Puerto Rico or leased employees, of GenMark Diagnostics Inc. (the Company) who were age 18 or older. Full time employees of the Company who had completed 60 days of service and were age 18 or older were eligible to receive employer matching contributions, as defined. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The 401(k) Plan Oversight Committee was responsible for oversight of the Plan. The Plan 401(k) Oversight Committee determined the appropriateness of the Plan's investment offerings, and monitoring of investment performance.

### *Contributions*

Prior to the Plan being frozen, participants could contribute 100% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants were also able to designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions and were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 2% of eligible compensation and their contributions invested in Fidelity Freedom Funds, a target date fund, until changed by the participant. The Company contributed 100% of the first 2% of base compensation that a participant contributed to the Plan. The Company could also make additional discretionary contributions to the Plan. For the period ended October 28, 2022, there were no discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### *Participant Accounts*

Each participant's account was credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

### *Vesting*

Participants were vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

### *Notes Receivable From Participants*

Prior to January 1, 2022, participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at the Prime rate, as defined. Principal and interest were paid ratably through monthly payroll deductions. Loan terms ranged up to five years or greater for the purchase of a primary residence.

### *Payment of Benefits*

On termination of service due to death, disability, retirement or other reasons, a participant received a lump-sum distribution equal to the value of the participant's vested interest in their account. In addition, the Plan allowed for hardship distributions if certain criteria are met.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's losses on investments bought and sold as well as held during the year.

### *Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

### *Subsequent Events*

Subsequent events were evaluated through October 12, 2023, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 28, 2022 and December 31, 2021.

*Money market funds:* Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts include interest-bearing cash, money market funds, mutual funds and exchange traded funds and are valued based on quoted market prices of the underlying securities reported on the active market on which the securities are traded.

#### 4. Transfers Out of the Plan

Effective April 23, 2021, the Company was acquired by Roche Holdings, Inc. (Roche). In connection with the acquisition, the Plan was frozen to new participant contributions, as well as new loans effective January 1, 2022. Effective October 28, 2022, the Plan was merged into US Roche 401(k) Plan (See Note 1) and Plan Assets totaling \$20,258,066 were transferred into the Roche Plan.

As of October 28, 2022, total investments of \$28,012 held in self-directed brokerage accounts remained in the Plan due to a delay in settlement. These investments were liquidated and transferred to the Roche Plan on November 9, 2022.

## 5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participants' account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

## 6. Tax Status

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

As of October 28, 2022 all plan investments were held in self-directed brokerage accounts. As of December 31, 2021, the Plan had investments of \$4,437,026 that were concentrated in one fund which exceeded 10% of the Plan's net assets available for benefits.
