Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1: DESCRIPTION OF THE PLAN

General

THE NATIONAL FOOTBALL LEAGUE CAPITAL ACCUMULATION PLAN (the "Plan") was established April 1, 1984 as a defined contribution plan covering all non-player employees of National Football League member clubs. The Tennessee Titans' employer (the "Company," or "Plan Sponsor") adopted the Plan on January 1, 1985. The Plan is a qualified plan as defined by Section 401(a) of the Internal Revenue Code and contains a provision for salary reduction contributions under Section 401(k) of the Internal Revenue Code. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility

Non-player employees of the Company are eligible to participate in the Plan on the first day of the first month beginning after the later of six months following the date of their start of employment or after the completion of 1,000 hours of service. A participant must complete 1,000 hours of service within a 12-month period.

Contributions

Participants may elect to contribute a portion of their annual compensation to the Plan, subject to Internal Revenue Service limitations, and may direct their contributions to various investment alternatives. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. For 2022, the maximum contribution allowed for any employee was \$20,500. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions of up to \$6,500 for 2022. Participants may also contribute rollover amounts representing distributions transferred from other qualified plans.

For each Plan year, the Company will contribute to the Plan on behalf of each eligible employee the lesser of (a) 50% of the employee's contributions, (b) 2.5% of the employee's compensation, as defined in the Plan document, or (c) \$3,750.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) the Company's contribution and (b) investment income (less expenses). Income for each of the investment choices is allocated to the participants' accounts on a monthly basis and is based on the relative units of participation. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

NOTE 1: DESCRIPTION OF THE PLAN (*Continued*)

Vesting

Participants are immediately vested in both participant contributions and employer contributions.

Payment of Benefits

Normal retirement under the Plan is at age 65. Retiring participants will receive a lump sum distribution in cash. During employment, certain benefits may be paid from the Plan under hardship provisions, or to participants that are between the ages of 59 ½ and 70 ½. Employees who attain the age of 70 ½ must receive annual distributions to meet the minimum distribution requirements of Internal Revenue Code regulations. Distributions for non-retiring separated employees will be paid as a lump sum in cash, and they may elect to rollover their account into another plan. Upon death or disability, participants, or their beneficiaries, are entitled to receive the full value of their account.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and expenses during the reporting period. Actual results could differ from those estimates.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses, net of reimbursements. Other investment-related expenses are included in net appreciation of investments.

Distributions

Benefit payments are recognized when paid.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES *(Continued)*

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Investment income is recorded as earned.

NOTE 3: TAX STATUS

The Plan received a favorable determination letter regarding the tax-exempt status of the Plan on August 20, 2013. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 4: ADMINISTRATION AND INVESTMENTS

The Plan has entered into a custodial arrangement with PNC Bank ("PNC"), the trustee. Among other duties, the trustee receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the Administrative Committee for the Plan. Certain administrative functions are performed by the Plan Sponsor. The Plan does not compensate the Plan Sponsor for these services or other expenses paid for by the Plan Sponsor.

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, PNC certified that the accompanying investment balance as of December 31, 2022 and 2021, and income information for the year ended December 31, 2022, was complete and accurate. Accordingly, the Plan's independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 5: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 6: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investments in securities, and are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 7: FAIR VALUE OF FINANCIAL INSTRUMENTS

ASC 820-10 provides standards and disclosures for assets and liabilities that are measured and reported at fair value. As defined in ASC 820-10, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price).

ASC 820-10 requires disclosure that establishes a framework for measuring fair value and expands disclosure about fair value measurements. The statement requires fair value measurements be classified and disclosed in one of the following categories:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2: Measured based upon inputs that are observable, either directly or indirectly, for the asset or liability other than quoted market prices included in Level 1. These inputs include: a) quoted prices for similar asset or liabilities in active markets b) quoted prices for identical or similar assets or liabilities in markets that are not active c) inputs other than quoted market prices that are observable and d) inputs that are derived primarily from or corroborated by observable market data by correlation or other means.

Level 3: Measured based on unobservable inputs for the asset or liability for which there is little, if any, market activity for the asset or liability at the measurement date. This input includes management's own assumptions about the assumptions that market participants would use in pricing the asset or liability. The inputs are developed based on the best information available in the circumstances, which might include management's own data.

As required by ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 7: FAIR VALUE OF FINANCIAL INSTRUMENTS *(Continued)*

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Determined based on quoted market prices (“fair value”) on the last business day of the plan year as reported by the investment trustee of the Plan’s assets. Investments are generally subject to the volatility of the major stock markets in which the underlying investments are held.

Common Collective trusts: These funds are valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported net asset value.

The Plan recognizes transfers between the levels as of the ending of the reporting period. Gross transfers between the levels were not significant for the year ended December 31, 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 8: UNCERTAIN TAX POSITIONS

The Plan did not have unrecognized tax benefits as of December 31, 2022 and 2021 and does not expect this to change significantly over the next 12 months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2022 and 2021, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 9: SUBSEQUENT EVENTS

Management evaluated the period from January 1, 2023 through October 10, 2023, which was the date the financial statements were available to be issued. The Plan noted no significant subsequent events.
