Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of FlightAware 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

As discussed in Note 1 to the financial statements, the FlightAware 401(k) Plan merged into the United Technologies Corporation Employee Savings Plan effective December 31, 2022.

Responsibilities of management for the financial statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTE 1 - DESCRIPTION OF THE PLAN

General. The FlightAware 401(k) Plan (the "Plan"), is a defined contribution plan, which is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), covering the employees of FlightAware LLC ("FlightAware"), an indirect subsidiary of RTX Corporation ("RTX" or "Employer").

On December 31, 2022, the Plan merged into the United Technologies Corporation Employee Savings Plan ("legacy ESP") (the "Plan Merger"). Effective January 1, 2023, the name of the legacy ESP was changed to the Raytheon Technologies Corporation Savings Plan. Effective July 17, 2023, the name of the Raytheon Technologies Corporation Savings Plan was changed to the RTX Savings Plan ("RTX Savings Plan").

This report contains Plan information as of December 31, 2021, and for activity that occurred during the year ended December 31, 2022. Asset balances were \$0 at December 31, 2022 for the Plan.

The following is a brief description of the Plan. A complete description of the provisions of the Plan can be obtained by referring to the summary plan description as well as the Plan document, which are available from FlightAware.

Trustee and Recordkeeper. Ascensus Trust Company is the Trustee and Custodian for the Plan and holds all Plan assets. Vanguard Group, Inc. has retained Ascensus, Inc. as a sub-contractor to provide certain account recordkeeping and administrative services on behalf of the Plan.

Contributions and Vesting. Participants may elect to contribute up to 100% of eligible compensation, as pre-tax or Roth deferral contributions, subject to statutory and Plan limits. Participants direct the investment of their contributions into various investment options offered by the Plan. As of December 31, 2022 and 2021, the Plan offered twenty-three investment options to participants: ten target date retirement funds, six stock market index funds, two international stock index funds, a specialty U.S. stock fund, three bond funds and a money market fund.

Participant contributions, plus actual earnings thereon, are fully vested under the Plan. New participants are automatically enrolled at a pre-tax deferral rate of 3% of eligible compensation immediately following hire. Participants may opt out of automatic enrollment at any point. Automatic contributions are invested in an age-based target date retirement fund. Participants can direct automatic contributions into other available investment options at any time. Employer matching contributions and profit-sharing contributions, plus actual earnings thereon, are always vested under the Plan.

The Employer's matching contribution is 100% of the participant's contributions, up to 6% of eligible compensation, as defined by the Plan. Employer and participant contributions are deposited into the investment options in accordance with the participants' elections. Active participants are also eligible for discretionary profit-sharing contributions based on a percentage of eligible compensation, as compared to the compensation of all eligible participants. As of December 31, 2022, no profit-sharing contributions have been made to the Plan.

Participant Accounts. Each participant's account is credited with (a) the participant's contributions, (b) employer matching contributions, (c) employer profit sharing contributions, and (d) Plan earnings and losses reduced by expense allocations. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants. Under the terms of the Plan, participants are allowed to borrow up to the lesser of 50% of their vested account balance or \$50,000 (reduced by the current outstanding loan balance, if any), with a minimum loan amount of \$1,000, and must repay their loan within 60 months for a general-purpose loan and up to 360 months for the purchase of a primary residence. Participants may only have one loan outstanding at a time. New loans are collateralized by the balance in the participant's account and bear interest at the prime rate plus one percent per The Wall Street Journal/Reuters, which stood at 8.50% and 4.25% at December 31, 2022 and December 31, 2021, respectively. Principal and interest are paid ratably through payroll deductions by active participants. Outstanding loans are considered due and payable upon separation. The loan will not be treated as a taxable distribution until 60 days following separation from service.

Payment of Benefits. Generally, on termination of service, benefits may be left in the Plan or paid in a lump sum or in ad hoc partial payments. In the case of death of a participant, benefits may be paid to beneficiaries in a lump sum or in annual installment payments beginning in the year following the participant's death (or the year in which the participant would have reached age 70 ½, if the beneficiary is a spouse). Participants are also eligible for in-service withdrawals for reasons of hardship or attainment of normal retirement age (i.e., age 65), in accordance with the Plan document.

NOTE 2 - SUMMARY OF ACCOUNTING PRINCIPLES

Basis of Accounting. The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value as determined by the Plan Trustee, typically by reference to published market data. See Note 4 for further discussion of how the fair values of the Plan's investments were determined.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date.

Net depreciation in the fair value of investments includes realized and unrealized gains and losses.

Notes Receivable from Participants. Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the Plan.

Plan Expenses. Administrative expenses, such as trustee, custodial, legal, audit, and recordkeeping fees, were paid directly by the Employer in 2022. Investment management fees are included within plan expenses on the statement of changes in net assets available for benefits.

Payments of Benefits. Benefit payments to participants or beneficiaries are recorded when paid.

Use of Estimates. The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the dates of the financial statements, and changes therein during the reporting period, and, when applicable, disclosures of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties. The Plan provides for various investment options in any combination of mutual funds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. These risks can be adversely impacted by shifts in the market's perception of the issuers, changes in interest rates, and global economic conditions. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events. In preparing the accompanying financial statements, the Plan evaluated events occurring from December 31, 2022 through October 12, 2023, the date the financial statements were available to be issued. Effective July 17, 2023, Raytheon Technologies Corporation changed its name to RTX Corporation.

Accounting Standards. New pronouncements issued but not effective until after December 31, 2022 are not expected to have a material impact on the Plan's financial statements or disclosures.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S TRUSTEE

The Plan sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the Trustee of the Plan through the time of the merger, certified the following data included in the financial statements is complete and accurate:

- Investments at fair value of \$10,775,724 and notes receivable from participants of \$77,653 as of December 31, 2022, included in the Net transfer to United Technologies Corporation Employee Savings Plan shown in the statement of changes of net assets available for benefits for the year ended December 31, 2022 as a result of the merger described in Note 1.
- Investments at fair value and notes receivable from participants as shown in the statement of net assets available for benefits as of December 31, 2021
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022

At the request of the Plan sponsor, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements.

NOTE 4 - FAIR VALUE OF INVESTMENTS

The Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") establishes a valuation hierarchy for disclosure of the inputs to the valuations used to measure fair value. A financial asset's or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. This hierarchy prioritizes the inputs into three broad levels as follows:

Level 1 – quoted prices in active markets for identical assets or liabilities;

Level 2 – inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly;

Level 3 – unobservable inputs based on our own assumptions used to measure assets and liabilities at fair value.

The following is a description of the valuation methodologies used for the Plan's investments measured at fair value, including the general classification of those investments:

Mutual funds – Shares held in mutual funds are stated at fair value using the closing market price on the last business day of each period presented.

NOTE 5 - RELATED-PARTY TRANSACTIONS

The Trustee manages certain Plan investment options. These transactions qualify as exempt party-in-interest transactions. Subject to the terms of the Plan document, the Plan makes certain loans to participants who are employees of FlightAware, and who are therefore parties-in-interest with respect to the Plan. These transactions qualify as exempt party-in-interest transactions.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, RTX has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - FEDERAL INCOME TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed FlightAware by an opinion letter dated January 1, 2018, that the form of the Plan is designated in accordance with applicable sections of the Internal Revenue Code ("IRC"). FlightAware believes that the current design and operation of the Plan are consistent with the preservation of the qualification of the Plan and exemption of the Trust in the context of applicable IRS procedures.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan may, from time to time, hold investments that give rise to certain tax liabilities. Based upon management's assessment, the Plan did not recognize any tax liabilities at December 31, 2022 or 2021. The Plan is subject to examinations by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.
