We have performed audits of the accompanying financial statements of Mid-Coast Electric Supply, Inc 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note A - Description of Plan

The following description of Mid-Coast Electric Supply, Inc. 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was formed on November 1, 1975 by Mid-Coast Electric Supply, Inc. 401(k) Plan (the "Employer" and "Plan Sponsor") and is a defined contribution plan with a 401(k)-provision covering all employees, as defined in the Plan document, who are 21 years of age or older. Employees are eligible after three months of service to make salary deferrals. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for participant contributions, including catch-up contributions, a safe harbor employer matching contribution and a discretionary employer profit sharing contribution. Discretionary employer contributions are subject to approval by the Board of Directors of the Company and limitations established by the Internal Revenue Code (IRC).

Participant Accounts

Each participant's account is credited with the participant's contribution and employer-provided matching contributions, Plan earnings (losses), and charged with management or service fees and allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan. Additional administrative fees are charged by the custodian upon fund withdrawal. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions and related account earnings are immediately 100% vested. The Plan's matching contributions, profit-sharing contributions and related account earnings follow a vesting schedule. Less than one year is 0%, two years is 20%, three years is 40%, four years is 60%, 5 years is 80% and at six years these contributions are vested at 100%.

Investment Options

Participants may direct contributions to any of the investment options offered by the Plan. The investment options include money market, mutual, and exchange traded funds. The fund values are computed daily by the custodian and reflect changes in the unit values of the investments.

Notes Receivable from Participants

Participants can borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Note terms range from one to five years or up to 15 years for the purchase of a principal residence. Participants can only have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at rates that approximate those of third-party lenders in the same geographic region as the Company, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive a lump sum distribution amount equal to the value of the participant's vested account. Hardship distributions or disability distributions may also be granted in accordance with the plan document.

Hardship Withdrawal

A participant can withdraw from the Plan part or all of the participant's contributions for a financial hardship. Plan management shall determine what portion of such account balance is necessary to alleviate the hardship. A financial hardship must be one of the reasons specified in the Plan document.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts were \$15,363 and \$7,886, respectively. These accounts will be used to pay plan administration fees or may be used to reduce employer matching or discretionary contributions.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Withdrawals and Exchanges

Withdrawals and exchanges between investment fund options by participants are recorded based upon the specific proceeds and cost of the investment at the date of withdrawal or exchange.

Participant Contributions Receivable

Participant contributions receivable represent participant deferrals withheld prior to December 31, 2022 and 2021. The balance is based on actual collections subsequent to year end. There were no participant contributions receivable at December 31, 2022 and 2021.

Employer Contributions Receivable

Employer contributions receivable represent employer matching contributions related to participant deferrals withheld prior to December 31, 2022 and 2021, as well as a discretionary profit-sharing contribution which was approved during the years then ended, respectively. The balance is based on actual collections subsequent to year end. There were no employer contribution receivable as of December 31, 2022 and 2021.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as of December 31, 2022 and 2021. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Valuation and Income Recognition (continued)

Assets of the Plan are held in separate accounts of a trust administered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2022 and Massachusetts Mutual Life Insurance Company as of December 31, 2021, representing investments in variable annuities, a guaranteed investment contract, and self-directed brokerage accounts.

Investments of participant's voluntary 401(k) contributions and the Company's contributions into these funds are at the direction of each participant. The accounts are credited with actual earnings or losses on the underlying investments and charged for Plan withdrawals and administrative expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed to participant accounts when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expense of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expense are included in net appreciation and depreciation of fair value of investments.

Note C - Information Prepared and Certified by the Custodians

The December 31, 2022 and 2021 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022 and 2021, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustee in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's investments were held in custodial accounts maintained by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) for the year ended December 31 2022 and Massachusetts Mutual Life Insurance Company (Mass Mutual) for the year ended December 31, 2021 and Charles Schwab Trust Company (Charles Schwab) for the year ended December 31, 2022 and 2021.

Plan management obtained certifications from Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower) for the year ended December 31, 2022 and from Massachusetts Mutual Life Insurance Company (Mass Mutual) for the year ended December 31, 2021 and from Charles Schwab Trust Company (Charles Schwab) for the years ended December 31, 2022 and 2021.

For the years ended December 31, 2022 and 2021, these certified investment amounted to \$5,621,505 and \$7,597,950 as of December 31, 2022 and 2021, respectively. Included in investments at fair value from self-directed brokerage accounts totaling \$0 and \$2,557,133 as of December 31, 2022 and 2021, respectively. Net investment income (loss) certified by the trustee was (\$1,075,493) and \$1,058,199 for the year ended December 31, 2022 and 2021, respectively. Also, included in net investment income (loss) for the years ended December 31, 2022 and 2021 was (\$155,456) and \$654,551, respectively, from self-directed brokerage accounts.

Note D - Fair Value Measurements

FASB ASC Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are delivered principally from or corroborated by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used to maximize the use of observable inputs and minimize the use of unobservable measurements.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Money Market Funds: Valued at the closing price reported on an actively traded exchange and are valued as level 1.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are reported as level 1.

Pooled Separate Accounts (PSA): The fair value of investment contracts held in pooled separate accounts are measured based on significant observable inputs other than quoted prices in active markets. PSA investments are reported at net asset value and generally can be redeemed on a daily basis and thus they are reported at level 2.

Equities: Valued at the closing price reported on the active market on which the individual securities are traded and they are reported at level 1.

The preceding method described may produce fair value calculations that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date.

Note E - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note F - Income Tax Status

The master prototype plan from which the Plan was drafted has received a favorable determination from the Internal Revenue Service on June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes the Plan is designed and currently being operated in compliance with all applicable provisions of the Internal Revenue Service Code. Therefore, management believes that the Plan is qualified and that the related trust is exempt from taxation under the Internal Revenue Code.

Note G - Risks and Uncertainties

Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
