Note 1: Description of the Plan

The following description of T2 Systems, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan was a defined-contribution plan sponsored by T2 Systems, Inc. (Company) for the benefit of its employees who had completed one month of service and were age 18 or older. The Plan was subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Trust Company (Principal Trust) was the trustee of the Plan. Principal Life Insurance Company (Principal Life) served as custodian of the Plan.

Effective January 1, 2021, United Public Safety became a participating employer after acquisition by the Company. During March 2021, the accounts of these employees from the Extensis Retirement Savings Plan, merged into the Plan. Approximately \$268,000 was transferred into the Plan in March 2021.

NuPark was acquired by the Company on December 13, 2021 and those employees became participants of the Plan on that date.

During December 2021, the Company was acquired by Verra Mobility. On December 30, 2022, the assets of the Plan merged into the Verra Mobility 401(k) Plan and the participants became Verra Mobility 401(k) Plan eligible as of January 1, 2032. The Plan merger initiated a blackout period beginning December 11, 2022 and ending January 25, 2023. During this period, participants were unable to direct or withdrawal the assets held in their accounts. The transfer payable as of December 31, 2022 relates to the December 30, 2022 pay date participant and employer contributions which were subsequently deposited into the Verra Mobility 401(k) Plan in September 2023.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the Company make annual contributions of up to the maximum allowed by law. Roth and rollover contributions were also permitted. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan also included an automatic deferral feature whereby a participant is treated as electing 6% of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provided for an annual increase in the percentage deferred of 1% and is ultimately capped at 10% deferral rate.

The Company's matching contributions were discretionary as determined annually by the Company's management. The Company could also make an annual discretionary profit-sharing contribution to the Plan for those actively employed at year end. The Company made no discretionary profit-sharing contributions in 2022 or 2021.

Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available included various funds. Each participant had the option of directing his/her contributions into any of the separate investment accounts and could change the allocation at any time.

Participant Accounts

Each participant's account was credited with the participant's contribution, the Company's contribution, Plan earnings and allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefits to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Payment of Benefits

Upon termination of service, a participant could elect to receive a lump-sum amount equal to the value of his/her vested account balance. Withdrawals other than for termination were permitted under certain circumstances provided by the Plan.

Vesting

Participants were immediately vested in their voluntary contributions plus earnings thereon. For participants hired before January 1, 2014, they were 100% vested immediately in Company contributions plus earnings thereon. For participants hired after January 1, 2014, vesting in the Company's contribution portion of their accounts plus earnings thereon was based on years of continuous service. A participant was fully vested after four years of continuous service. 25% vested for each year after the first year of continuous service. Participants became 100% vested if termination was due to death, disability or normal retirement age (age 65). The nonvested balance was forfeited upon termination of service. Forfeitures were used to reduce Company contributions.

Notes Receivable From Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. Participants could only have one loan outstanding. The loan interest rate would be based on rates available for similar loans from commercial lending institutions as determined by the Plan Administrator. Principal and interest was paid ratably through payroll deductions.

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan Document.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0. During 2022 and 2021, approximately \$12,500 and \$20,220, respectively, of forfeitures were used to pay Plan administrative expenses. During 2022, forfeitures of approximately \$7,800 were used to offset employer contributions. Forfeiture balance of approximately \$12,400 transferred to the Verra Mobility 401(k) Plan in December 2022.

Plan Termination

Although the Plan was not terminated, as described above, the Plan transferred to the Verra Mobility 401(k) Plan after the Company was acquired.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Prior to September 10, 2021, investments held by a defined-contribution plan were required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value was the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, were used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end. Pooled separate accounts were valued at estimated fair value as provided by Principal utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year. For these accounts, fair value was measured using NAV as a practical expedient and there were no redemption restrictions.

Prior to September 10, 2021, the Principal Fixed Income Guaranteed Account fully benefit-responsive investment contract was valued at contract value. Contract value represented contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses. Effective September 10, 2020, the Plan elected to terminate the contract for this fund and replace it with the Morley Stable Value Fund that is a collective investment trust.

The Plan's interest in the collective investment trusts were valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The collective investment trusts provided for daily redemptions with no advance notice requirement. The investment strategy of the income fund was to seek current income, and as a secondary objective capital appreciation. The goal of the target date funds were to seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who was expected to retire in that respective year.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and custodial document sponsored by Principal Life Insurance Company. The Plan had not been submitted to the Internal Revenue Service (IRS) for an individual determination letter as the nonstandardized prototype document had a favorable opinion letter from the IRS. The Plan had been amended since the prototype received their determination letter. However, the Plan Administrator believes that the Plan was currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

Administrative Expenses

Administrative expenses could be paid by the Company or the Plan, at the Company's discretion. The Plan maintained a fee reimbursement account in which approximately \$27,000 and \$35,000 of credits received for fee reimbursements were used to pay Plan investment advisory expenses for 2022 and 2021, respectively, to LPL Financial, LLC. There were no unused credits as of December 31, 2022 or 2021.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2021
- Investment (loss) income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2022 and 2021

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Disclosures About Fair Value of Plan Assets

Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2022. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices were available in an active market, securities were classified within Level 1 of the valuation hierarchy. Level 1 securities included mutual funds. If quoted market prices were not available, then fair values were estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities were classified in Level 2 of the valuation hierarchy. There were no Level 2 investments held. In certain cases where Level 1 or Level 2 inputs were not available, securities were classified within Level 3 of the hierarchy. There were no Level 3 investments held by the Plan.

Note 5: Investment Contract With Insurance Company

Prior to September 10, 2021, the Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The guaranteed minimum interest rates were not less than 1% or greater than 3%.

The guaranteed investment contract was fully benefit-responsive; therefore, contract value was the relevant measurement. Contract value, was reported to the Plan by Principal Life Insurance Company, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract's surrender charge were avoided by extending the liquidation period to twelve months.

Note 6: Party-in-Interest Transactions

Party-in-interest transactions included those with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, and an employee organization whose members were covered by the Plan, a person who owned 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invested in certain funds of the Plan trustee. The Plan paid \$58,377 and \$66,040 of fees to Principal Life during 2022 and 2021, respectively. The Company provided certain administrative services at no cost to the Plan.

Note 7: Nonexempt Transactions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Contributions of \$46,012 and loan repayments of \$2,105 were not remitted within the required time period for the year ended December 31, 2022. These contributions were remitted to the Verra Mobility 401(k) Plan in September 2023.

Note 8: Reconciliation of Financial Statements to Form 5500

For 2021, the difference between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements is the Morley Stable Value common collective trust reflected in the Form 5500 has not adopted ASU 2015-12; therefore, the Form 5500 reflects an adjustment to the investment income as of December 31, 2022 and the fair value of that investment as of December 31, 2021 of approximately \$5,400.

For 2022, the Form 5500 does not reflect the participant and employer contribution receivables of \$46,012 and \$16,304, respectively, for the contributions from the December 30, 2022 pay date that were not remitted into the Plan during 2022. These were deposited in the Verra Mobility 401(k) Plan in 2023 and reflected as a transfer payable of \$62,316 at December 31, 2022. The participant contributions of \$46,012 and loan repayments of \$2,105 are considered a late remittance to the Plan. The Form 5500 will not reflect these employee contributions and loan repayments as late remittances because they will be deposited to the Verra Mobility 401(k) Plan.

Note 9: Subsequent Events

Subsequent events have been evaluated through October 9, 2023, which is the date the financial statements were available to be issued.
