INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
APC Paper Company, Inc. 401 (k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of APC Paper Company, Inc. 401 (k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of January 11, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period ended, January 11, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certifications from a qualified institution as of January 11, 2022 and December 31, 2021 and for the period ended January 11, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section of our report—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS).

Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As further discussed in Note A to the financial statements, APC Paper Company, Inc., the Plan sponsor, was acquired on July 7, 2021 by Ampac Holdco, Inc. of Cincinnati, Ohio. Our opinion is not modified with respect to this matter. On January 11, 2022, the plan was merged into Proampac Holdings, Inc. 401(k) Plan.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date the financial statements are issued or available.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

For the period ended January 11, 2022 and December 31, 2021

Note A - Description of the Plan

General:

The following description of the APC Paper Company, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility:

The Plan, originally sponsored by APC Paper Company, Inc. ("the Company"), includes, APC Paper Company, Inc. ("APC") and APC Paper Company of New York, Inc. ("APC NY"). APC and APC NY share common ownership. The plan is a defined contribution plan established January 1, 1993. The Plan provides for retirement, disability and death benefits and covers substantially all full-time employees of the Company who have one year of service and are age twenty-one or older. All employees are automatically enrolled when they become eligible unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contributions invested in a designated fund until changed by the participant. Alerus Financial NA (Alerus) serves as the trustee and custodian of the Plan. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), and is a qualified retirement plan under Internal Revenue Code (IRC) section 401(a) and other code sections.

Plan Merger:

The company was acquired on July 7, 2021 by Ampac Holdco, Inc. of Cincinnati, Ohio. On January 11, 2022, the Plan was merged into the Proampac Holdings, Inc. 401(k) Plan.

Contributions:

Participants may contribute pretax annual compensation up to a maximum specified by the IRC, \$20,500 for 2022. Participants who have attained the age 50 before the end of the plan year are eligible to make catch-up contributions, \$6,500 for 2022. Participants may also contribute amounts representing distributions from other qualified plans. The Company provides a matching contribution of \$.50 for every \$1.00 an employee contributes, not to exceed \$2,500.

The Plan has a voluntary non-contributory provision which allows the Company to make discretionary contributions. The Company made no discretionary contributions in the period ended January 11, 2022.

The Company's matching contribution for the year ended January 11, 2022 totaled \$0.

Participant Accounts:

Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses that are paid for by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note A - Description of the Plan - continued

Vesting:

Participants are vested immediately in their contributions and earnings thereon. The Company's matching contribution portion of the account and earnings thereon are vested immediately. The Plan has no forfeiture provision, as all Company contributions vest immediately. All assets transferred on January 12, 2022 were vested assets.

Payment of Benefits:

Distributions are payable as a result of termination for death, disability, retirement and other allowable reasons as soon as administratively feasible following the date on which a distribution is requested or is otherwise payable.

Notes Receivable from Participants

A Plan participant is allowed to borrow up to 50% of the vested account balance, provided such loan is at least \$1,000 and does not exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate of 2% over prime. Principal and interest is due ratably through bi-monthly payroll deductions.

Note B - Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements are prepared using the accrual method of accounting.

Administrative Expenses:

The Plan is responsible for payment of the trustee expenses and fees; however, the Company may pay the Plan expenses directly. Expenses that are paid by the Company are excluded from these financial statements.

Transaction fees for loans or benefit payments are paid by the Plan by reducing the balances of those participants initiating the transactions and are included in administrative expenses.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Benefits are recorded when paid.

Note B - Summary of Significant Accounting Policies - continued

Investment Valuation and Income Recognition:

The Plan's investments are stated at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note D for discussion of the fair value measurements. Quoted market prices are used to value investments when available. Purchases and sales of securities are recorded on a trade-date basis, and interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable From participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of January 11, 2022.

Note C - Certified Information

The Plan assets are invested in mutual fund products offered by Alerus Financial N.A. and selected by the Plan fiduciaries. The investments, notes receivable from participants held at January 11, 2022 and December 31, 2021 and net depreciation in fair value of investments and dividend and interest income for the period ended January 11, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A. The Plan's independent accountants did not perform auditing procedures with respect this information, except for comparing such information to the related information included in the financial statements.

Note D - Fair Value Measurements

The Fair Value Measurements Topic of the FASB Standards Codification 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This Hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used at January 11, 2022 and December 31, 2021.

Mutual Funds: are valued at net asset value (assets minus liabilities at the close of a trading day), which approximates fair value.

Money Market Fund: As with mutual funds, the Money Market Fund is valued at net asset value, which approximates fair value.

Note D - Fair Value Measurements - Continued

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the plan's assets at fair value as of January 11, 2022 and December 31, 2022.

Note E - Income Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the opinion letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note F - Related-Party/Party-In-Interest Transactions

Certain Plan investments managed by the custodian qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services, plus participant specific transaction fees, amounted to \$388 in 2022. Notes receivable from participants are also permitted party-in-interest transactions.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note H - Date of Subsequent Events Evaluation

Management has evaluated subsequent events through October 9, 2023, the date the financial statements were available to be issued.
