Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of kgb 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022 (liquidation basis), and the related statement of changes in net assets available for benefits for the year then ended (liquidation basis), and the statement of net assets available for benefits as of December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the year ended December 31, 2021 (ongoing) and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of kgb 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about kgb 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Empasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, those charged with governance made a decision to terminate the kgb 401(k) Plan. As a result, in accordance with accounting principles generally accepted in the United States of America, kgb 401(k) Plan changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting, effective January 1, 2022. Our opinion is not modified with respect to this matter.

1. Description of Plan

The following description of the kgb 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers eligible employees who have completed 60 days of continuous employment. Collectively bargained employees, leased employees, summer interns, overseas non-expatriates and highly compensated employees are not eligible to participate in the plan. The following entities participate in the Plan, referred to collectively as “the Company”:

- kgb USA, Inc.
- Operator Service Company, LLC
- Conduit Global, Inc.

Plan Termination

The directors of kgb adopted a resolution on June 18, 2021 with an effective date of July 18, 2021 to terminate the kgb 401(k) Plan. Effective with the Plan’s termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. Also effective as of the Plan termination, no more contributions were made to the Plan. The Plan’s termination also ceased employee and employer contribution into the Plan. All of the Plan’s assets were distributed to plan participants as of December 31, 2022.

Contributions

Each participant may make a pretax contribution of up to 75% of eligible compensation (as defined in the Plan document), subject to applicable Internal Revenue Service (“IRS”) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company’s contribution rate is a discretionary percentage, determined annually by the Company, for participants with at least 1,000 hours of service during the Plan year. In 2021, the Company elected to contribute 25% of the first 6% of eligible plan compensation that a participant contributes to the Plan. The Plan also provides for discretionary profit-sharing contributions. There were no such contributions for the 2022 and 2021 plan years. Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and stable value investment options under John Hancock Trust Company, LLC, as investment options for participants. All plan contributions ceased as of July 18, 2021 in conjunction with the termination of the Plan.

1. **Description of Plan (Continued)**

Participant Accounts

Each participant's account is credited with the participant's elective deferral contribution, any rollover contributions, an allocation of the Company's contribution, if any, and Plan earnings, net of expenses. Allocations of Company matching contributions are based on participant elective deferrals to the Plan. Allocations of profit sharing contributions are in proportion to total compensation. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts and related earnings is based on years of continuous service. A participant is 100 percent vested after six years of credited service, as follows:

Any participant who earned 3 or more years of vesting service under the Excell Services Savings Plan (merged into the kgb 401(k) Plan January 1, 2008), is entitled to the following vesting schedule.

Notes Receivable from Participants

Loans to participants are permitted under the Plan in an amount not to exceed the lesser of one-half of the participant's non-forfeitable interest under the Plan or \$50,000, whichever is less. Interest accrues on participant loans at the rate of prime plus 2%. All loans are to be repaid within five years unless the loan is used to acquire a principal residence in which case the term is fifteen years.

Payment of Benefits

If a participant terminates employment for any reason other than death or total and permanent disability prior to normal retirement age (65) and the value of the participant's vested account balance is less than \$5,000, the vested portion shall be distributed as soon as is administratively practical following termination. The full qualified joint and survivor annuity and preretirement survivor requirements of Section 401(A)(11) and Section 417 of the Code shall apply to all participants at all times. The Plan allows participants to make hardship withdrawals from salary reduction accounts and rollover contributions accounts.

Forfeited Accounts

Amounts contributed by the Company which are forfeited by participants as a result of the participants' separation from service prior to becoming 100% vested are available first to reduce plan expenses, then to reduce employer contributions. At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$-0- and \$-0-, respectively. In 2022 and 2021, \$-0- and \$18,750, respectively, of Plan expenses were paid from forfeited non-vested accounts. Additionally, in 2022 and 2021, employer contributions were reduced by \$-0- and \$-0-, respectively, from forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

As disclosed in Note 1, the Plan was terminated and all assets of the plan were liquidated in 2022. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2021, from the ongoing basis to the liquidation basis.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the years.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Participant Benefits Payable

Participant benefits payable represents un-cashed, re-deposited participant distribution checks held pending claim by recipient.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements.

Subsequent Events

Management has evaluated subsequent events through October 12, 2023, the date the financial statements were available to be issued.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Investment in Stable Value Fund

The Plan offers a fully benefit-responsive stable value investment contract issued by New York Life Insurance Company, (the "Issuer"). The New York Life Anchor Account IV is an investment contract made available through a group annuity contract. The group annuity contract consists of 1.) a stable value account that represents the guarantee that New York Life is making to the plan sponsors participating in the group annuity, and 2.) the NYL Pooled Separate Account No. 25, which is the account holding the underlying investments into which all Plan contributions are invested and which invests primarily in fixed income securities.

The Issuer maintains contributions in pooled accounts and common trusts which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus specified earnings, less participant withdrawals and administrative expenses. This is the contract's guaranteed value. Generally, the Issuer may not terminate the contract at any amount less than contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract has certain restrictions that impact the ability to collect the full contract value such as sponsor-initiated withdrawal or partial plan terminations. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable.

The Issuer is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the Issuer. Such interest rates are reviewed periodically for resetting. The actual and crediting interest rates are as follows:

5. Information Certified by the Custodian and Trustee

The financial information included in the Plan financial statements, except for contributions receivable, contributions and distributions for withdrawals and terminations, has been derived from information certified as complete and accurate by John Hancock Trust Company, LLC, the Trustee, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

6. Transactions with Parties in Interest

Certain legal and accounting fees and certain administrative expenses and services relating to the maintenance of employee eligibility records are incurred by the Company. Other than as described above, the Plan has had no agreements or transactions with any parties in interest.

7. Tax Status

The Company adopted a Prototype Non-standardized Profit-Sharing Plan with a cash or deferred arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) dated September 30, 2014. Although the Plan has since been amended, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
