Note 1: Description of Plan

The following description of ETX, Inc. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of ETX, Inc. (the “Company”), as well as certain subsidiaries (DACCO, Inc., Alma Products, Inc. and Atco Products, Inc., collectively the “Plan Sponsor”) who have executed a participation agreement under the terms of the Plan who are age 21 or older and who have completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. Effective January 1, 2015, employees of DACCO, Inc. not covered under a collective bargaining agreement with the United Auto Workers (UAW) are no longer eligible to participate in the Plan. These employees became eligible to participate in The Transtar Employees Retirement Savings Plan on this date. Effective April 1, 2022, the Plan was merged with a related plan and all assets were transferred to The Transtar Employees Retirement Savings Plan.

Contributions

Each year, non-highly compensated participants could have contributed up to 25% of pretax annual compensation and highly compensated participants could have contributed up to 5% of pretax annual compensation, as defined in the Plan. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

The Plan provided for various employer contributions to be made for participants of the Plan. Additional non-elective employer amounts could have been contributed at the option of the Plan Sponsor’s Board of Directors for participants who have completed one year of service. During 2022 and 2021, there were no such non-elective employer contributions or matching contributions.

Note 1: Description of Plan (continued)

The Plan provided for a discretionary matching contribution determined each year by each Participating Employer. For 2022 and 2021, DACCO, Inc. participants covered under a collective bargaining agreement received matching contributions equal to 40% of the first 7% of employee deferrals, as required under the DACCO, Inc. collective bargaining agreement. Atco Products, Inc. participants received matching contributions equal to 25% of the participants' contribution up to 6% of eligible compensation. The Plan Sponsor authorized matching contributions for hourly employees of Alma Products I, Inc. totaling 33% of employee deferrals, up to 6% of eligible compensation. The Plan Sponsor authorized matching contributions for salaried employees of Alma Products I, Inc. not active in the Salaried Pension Plan totaling 25% of employee deferrals, up to 6% of eligible compensation. Plan Sponsor contributions may not exceed the maximum amount deductible for federal income tax purposes.

Participant Accounts

Each participant's account was credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts was based on years of continuous service. A participant was 100% vested in the Company's discretionary contributions after five years of credited service.

Notes Receivable from Participants

Participants could have borrowed from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate, as defined. Principal and interest was paid ratably through biweekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant could have elected to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments for a specific number of years, or monthly installments for life. For termination of service for other reasons, a participant could have received the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$-0- and \$1, respectively. These accounts were first applied to restore participant accounts for participants that were re-hired prior to the passing of five consecutive years since their termination. Any remaining forfeitures, if available, could have been used to offset Plan expenses and then to reduce the Plan Sponsor's matching contributions to the Plan. In 2022, \$416 from forfeited nonvested accounts was used to restore participant accounts for participants that were re-hired prior to the passing of five consecutive years since their termination.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The Plan follows authoritative guidance issued by the Financial Accounting Standards Board (FASB) which established the FASB Accounting Standards Codification (ASC) as the single source of authoritative accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 11, 2023, the date the financial statements were available to be issued.

Note 3: Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, interest income on notes receivable from participants and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by State Street Bank and Trust Company (the trustee of the Plan).

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Registered investment companies: Valued at the daily closing price as reported by the fund. Shares held by the Plan are invested in open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The collective trust fund provides for daily redemption by the Plan at reported net asset values per share with no advance notice requirement. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Certain Plan investments were managed by State Street Bank and Trust Company. State Street Bank and Trust Company was the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan invested in a stable value collective trust fund managed by Diversified Investment Advisors, an affiliate of Transamerica Retirement Solutions Corporation, the record keeper of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Note 5: Related-Party Transactions and Party-in-Interest Transactions (continued)

Transamerica Retirement Solutions Corporation provided certain administrative services to the Plan pursuant to an Agreement between the Company and Transamerica Retirement Solutions Corporation. Transamerica Retirement Solutions Corporation received revenue from mutual fund and collective trust fund service providers for services Transamerica Retirement Solutions Corporation provided to the funds. This revenue was used to offset certain amounts owed to Transamerica Retirement Solutions Corporation for its administrative services to the Plan.

If the revenue received by Transamerica Retirement Solutions Corporation from such mutual fund or collective trust fund service providers exceeds the amount owed under the Agreement, Transamerica Retirement Solutions Corporation remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2022, the Plan received \$3,922 in excess amounts. The Plan or Plan Sponsor may make a payment to Transamerica Retirement Solutions Corporation for administrative expenses not covered by revenue sharing.

Note 6: Tax Status

On March 31, 2014, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the applicable sections of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Merger to Related Plan and Plan Termination

The Plan Sponsor has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their employer contributions.

Effective April 1, 2022, participant account balances totaling \$6,484,967 of this Plan were transferred into the related The Transtar Employees Retirement Savings Plan. It is the intent of management to terminate this Plan in conjunction with this merger to a related plan.
