## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Frey-Moss Structures, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Frey-Moss Structures, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2022 and 2021, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

**NOTE A – DESCRIPTION OF THE PLAN**

The following description of the **Frey-Moss Structures, Inc. (the Company) 401(k) Plan (the Plan)** provides only general information. Participants should refer to the **Plan** document for a more complete description of the **Plan's** provisions.

The **Plan's** custodian is Transamerica Financial Life Insurance Company (Transamerica).

**General**

The **Plan** is a defined contribution plan covering all employees of the **Company**, except union, part-time, temporary, and seasonal employees, as defined in the **Plan** document. Employees are eligible to participate in the **Plan** after they have completed sixty days of service. The same requirements must be met for purposes of being eligible for the discretionary employer match and profit-sharing contributions. The **Plan** is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year participants may contribute pretax annual compensation up to the dollar limit established by Internal Revenue Code (the IRC). If a newly eligible participant fails to file a salary reduction election with the **Plan** administrator, such participant will be automatically enrolled in the **Plan** to contribute 3% of pretax annual compensation. Beginning on January 1, 2018, the **Plan** provided for automatic deferral increases of 1% annually, up to a maximum of 10%, unless the participant elects otherwise. Contributions are automatically invested in a default fund until changed by the participant.

Participants who have attained age 50 before the end of the **Plan** year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans, referred to as rollovers. Participants direct the investment of their contributions into various investment options offered by the **Plan**. The **Plan** currently offers various mutual funds and a fully benefit-responsive investment contract as investment options for participants. Employer matching and profit-sharing contributions are discretionary. Employer matching contributions will not exceed 20% of the participant's compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the **Company's** discretionary matching and profit-sharing contributions, and an allocation of **Plan** earnings or losses. Each participant can be charged with an allocation of administrative expenses and fees. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the **Plan** document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the **Company's** discretionary matching and profit-sharing contributions portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. If continuous service is terminated by death, disability, or retirement, participants or their beneficiaries become 100% vested in their accounts.

**Payments of Benefits**

On termination of service due to death, disability, retirement, or other reasons, participants or their beneficiaries will receive a lump-sum amount equal to the value of the participant's vested interest in their account if their vested interest does not exceed \$5,000. If the vested interest exceeds \$5,000, the participant or their beneficiary may elect to receive a lump-sum amount or an amount in installments. Distributions may also be taken by participants prior to termination of service in the event of financial hardship, as defined in the **Plan** document. If a qualified domestic relations order is received by the **Plan** administrator, all or a portion of the participant's account balance may be used to satisfy the obligation.

**Forfeited Accounts**

During the years ended December 31, 2022 and 2021, additions to forfeited nonvested accounts including earnings totaled \$13,725 and \$9,233, respectively. These accounts may be used to reduce future employer contributions or to pay **Plan** expenses. During the years ended December 31, 2022 and 2021, forfeited nonvested accounts used to reduce employer contributions totaled \$8,825 and \$9,336, respectively. As of December 31, 2022 and 2021, forfeited nonvested accounts totaled \$5,203 and \$303, respectively.

**NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the **Plan** have been prepared on the modified cash basis of accounting, which is a basis of accounting other than generally accepted accounting principles. Accordingly, investment income is recognized when received, disbursements are recognized when made, and employer and participant contributions, if any, are accrued at year end.

**Use of Estimates**

The preparation of financial statements in accordance with the modified cash basis of accounting requires the **Plan** administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Accounting for Uncertainty in Income Taxes**

The **Plan** recognizes material amounts of uncertain tax positions as income tax expense. The **Plan** recognizes accrued interest and penalties associated with uncertain tax positions as part of deductions from net assets.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a timely transaction with an independent buyer in the principal market, or in the absence of a principal market, the most advantageous market for the asset or liability (see Note D). Contract value is the relevant measurement for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the **Plan** (see Note E).

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses and Fees**

Pursuant to provisions of the **Plan**, administrative expenses incurred in the administration of the **Plan** may be paid by the **Plan** or the **Company**. The administrative expenses paid from plan assets are allocated to all participants. Currently, substantially all administrative expenses are paid by the **Plan**, except for audit fees which are paid by the **Company**.

Pursuant to provisions of the **Plan**, fees paid from the **Plan** are charged directly to the account of the participant on whose sole behalf the fee was incurred.

**Subsequent Events**

The **Plan** administrator has evaluated subsequent events that have occurred up through September 29, 2023, the date the financial statements were available to be issued. No material subsequent events have occurred since December 31, 2022 that required recognition or disclosure in the current period financial statements.

**NOTE C – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS**

The **Plan** administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the **Plan's** independent auditors did not perform any auditing procedures with respect to the following information certified by Transamerica as complete and accurate, except for comparing such information with information included in the **Plan's** financial statements and supplemental schedule:

- Investments at fair value and contract value as shown in the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2022 and 2021.
- Total investment (loss) income as shown in the accompanying statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2022 and 2021.
- All investment-related information in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2022.

**NOTE D – FAIR VALUE MEASUREMENTS**

FASB ASC 820, Fair Value Measurement, provides the framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Basis of Fair Value Measurement**

*Level 1:* Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

*Level 2:* Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3:* Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Following is a description of the valuation methodology used for investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* The daily closing price as reported by the fund is used to estimate fair value. Mutual funds held by the **Plan** are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the **Plan** are deemed to be actively traded and are redeemable immediately without notice.

As of December 31, 2022 and 2021, all of the **Plan's** investments at fair value are mutual funds and are classified within the fair value hierarchy in Level 1.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The **Plan** maintains an investment contract with Transamerica that is fully benefit-responsive. Transamerica maintains the contributions in a general account. The account is credited with earnings and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is set semi-annually on January 1 and July 1. The average yield earned by the **Plan** equals the credited interest rate to plan participants. The effective credited interest rate during the years ended December 31, 2022 and 2021 was 1.20% and 1.10% respectively. The investment contract has no stated minimum or maximum interest rate and no set maturity.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the **Plan**. Contract value, as reported to the **Plan** by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The **Plan's** ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the **Plan** to transact at contract value with the contract issuer. Such events include (1) amendments to the **Plan's** documents, including complete or partial **Plan** termination or merger with another plan, (2) changes to the **Plan's** prohibition on competing investment options or deletion of equity wash provisions, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the **Plan** to transact at contract value with the contract issuers and that also would limit the ability of the **Plan** to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contracts with the **Plan** and settle at an amount different from contract value. Such events include (1) an uncured violation of the **Plan's** investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuers.

**NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Three members of management serve on the **Plan's** administrative committee and currently participate in the plan. Two of these members are stockholders and co-trustees of the **Plan**.

The fully benefit-responsive investment contract offered by the **Plan** is managed by Transamerica. Transamerica is the custodian as defined by the **Plan** and, therefore, these transactions qualify as party-in-interest transactions. Direct and indirect compensation paid to an affiliate of Transamerica for the years ended December 31, 2022 and 2021 was \$46,132 and \$49,795, respectively. Direct compensation paid is included in administrative expenses and fees on the statements of changes in net assets available for benefits (modified cash basis).

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the **Company** has the right under the **Plan** to discontinue its contributions at any time and to terminate the **Plan** subject to the provisions of ERISA. In the event of **Plan** termination, participants will become 100% vested in their accounts.

**NOTE H – TAX STATUS**

The Internal Revenue Service has determined and informed Transamerica, by letter dated June 30, 2020, that the **Plan** and related trust are designed in accordance with applicable requirements of the IRC.

For the years ended December 31, 2022 and 2021, the **Plan** administrator believes there were no material amounts of uncertain tax positions. Additionally, there were no amounts of interest or penalties recognized in the statement of net assets available for benefits (modified cash basis) as of December 31, 2022 and 2021 or the statements of changes in net assets available for benefits (modified cash basis) for the years then ended. Further, the year ended December 31, 2019 and all years subsequent remain subject to examination.

**NOTE I – RISKS AND UNCERTAINTIES**

The **Plan** invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

**NOTE J – CORRECTIVE DISTRIBUTIONS**

The **Plan** failed to pass the Actual Deferral Percentage (ADP) test and the Actual Contribution Percentage (ACP) test for the 2021 and 2020 **Plan** years. In order to correct the failure, as permitted under IRS guidance, the **Company** opted to refund excess contributions and related earnings to the applicable employees. Refunds are made and recorded in the year subsequent to the failure. Corrective distributions made during 2022 and 2021, for refunds related to the 2021 and 2020 **Plan** years, totaled \$67,233 and \$68,155, respectively.

**NOTE K – OPERATIONAL FAILURE**

During the years ended December 31, 2022 and 2021, the **Company** failed to enroll certain eligible employees in the **Plan**. Management is currently calculating the financial impact of the missed contributions and accumulated earnings.


