### Note 1: Description of the Plan

The following description of Vi-Jon Personal Choice 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Vi-Jon, LLC (the “Company”) for the benefit of its employees who are not covered by a collective-bargaining agreement. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Fidelity Management Trust Company (the “Trustee”) is the trustee and custodian of the Plan.

#### **Contributions**

Participants are allowed to contribute up to 85% of their annual wages, subject to certain limitations. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions of 100% of employees’ salary deferral amounts up to 3% of employees’ compensation and 50% of the next 2% of employees’ compensation after six months of service. The Company can make additional discretionary contributions as determined by the Company’s board of directors; however, there were no such contributions in 2022 or 2021. Contributions are subject to certain limitations.

#### **Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant makes an affirmative election otherwise.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s contribution and Plan earnings are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that could be provided from the participant’s vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions, safe harbor contributions and the Company's discretionary contributions plus earnings thereon.

### ***Payment of Benefits***

Upon termination of service, a participant may elect to receive the value of their vested account either as a lump-sum amount or to receive a direct rollover to a specified account.

### ***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. The loans bear interest at rates that range from 4.25% to 9.25% which are commensurate with local prevailing rates at loan inception as determined by the Plan Administrator.

### ***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

## **Note 2: Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan holds an interest in a common collective trust fund, which invests in investments that pursue multiple strategies to provide preservation of principal while maintaining stable interest rates. The NAV of the trust fund is valued based on quoted market prices of underlying assets, as determined by the Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

### ***Plan Tax Status***

The Plan operates under a nonstandardized adoption agreement in connection with a prototype 401(k) profit-sharing plan sponsored by FMR LLC. This prototype Plan Document has been filed with the appropriate agency. The prototype has obtained a determination letter dated June 30, 2020, from the Internal Revenue Service stating that the prototype was qualified under Section 401 of the Internal Revenue Code. The Plan has been amended since the prototype received the determination letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

### ***Payment of Benefits***

Benefit payments to participants were recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

## **Note 3: Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. There is a hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets
