Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the accompanying financial statements of Aerofil Technology, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2022 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2022 Financial Statements section

- the amounts and disclosures in the 2022 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the 2022 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Emphasis of Matter

As described in Notes 1 to the financial statements, effective January 1, 2023, the Plan merged an existing Plan, KDC USA 401(k) Plan. Our opinion is not modified with respect to this matter.

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2022 Financial Statements section of our report. We are required to be independent of Aerofil Technology, Inc. Employee Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2022 Financial Statements

NOTE 1 DESCRIPTION OF THE PLAN

The following brief description of Aerofil Technology, Inc. Employee Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan, which had been adopted by Aerofil Technology, Inc. (the Company), was a defined contribution profit sharing plan, which includes a 401(k) provision. The Plan covered all employees who had completed two months of service and were 21 years of age. The Plan allowed participant's entry to the Plan on the first day of the month coinciding with meeting the eligibility requirements or the next month following if achieved mid-month. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In April 2022 the Plan sponsor was acquired by KDC/ONE. Effective January 1, 2023, the Plan merged into an existing plan, KDC USA 401(k) Plan. All eligible employees who were employees of Aerofil Technology, Inc. and participated in the Plan and who have met the age and service requirements of the merged-in plan were allowed to enter the KDC USA 401(k) Plan on January 1, 2023. All Plan assets were transferred out from the Plan as December 31, 2022, and transfer into the KDC USA 401(k) Plan on January 3, 2023.

Contributions

Participants may contribute a percentage of their annual compensation as defined in the Plan Document. Additionally, participants age 50 and over may make catch-up contributions. Participants may also make rollover contributions to the Plan, provided such rollover amounts meet the criteria for transfer as established under the Internal Revenue Code (IRC or Code).

For the Plan year ended December 31, 2022, the Plan included an ADP Safe Harbor matching provision whereby the Company matches salary deferral contributions at a rate of 100% of the first 3% and 50% of the next 2% of eligible compensation. The Company may also make a discretionary matching contribution. There were no discretionary matching contributions for the Plan year ended December 31, 2022.

The Company may also make a discretionary profit sharing contribution. The employee does not have to make deferral contributions to receive the contribution. There were no discretionary profit sharing contributions made during 2022 and 2021.

Participant Accounts

Each participant's account was credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings. The allocation of earnings was determined by the earnings of the participant's investment selection based on each participant's account balance, as defined in the Plan Document. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting Schedule

Participants were vested immediately in their contributions and the ADP Safe harbor match plus actual earnings thereon. Vesting in the Company's discretionary contributions was based on years of continuous service. A participant was vested ratably at 20% per year of service and was fully vested after five years of service or in the event of death or disability.

Forfeitures

Forfeitures of nonvested participant balances can be used to reduce the Company discretionary matching contribution, discretionary profit sharing contribution, or ADP Safe Harbor matching contribution to the Plan. In 2022, there were \$1,898 of forfeitures utilized. As of December 31, 2022 and 2021, the remaining available balance was \$0 and \$1,888, respectively.

Notes Receivable From Participants

A participant may borrow from their account subject to certain limitations. The minimum amount of any note was \$1,000. In no event can the participant borrow more than \$50,000 or 50% of the participant's vested balance. Note terms were for a period up to five years or 10 years for the purchase of a principal residence and bear interest based on prevailing market rates. A participant may have only one note outstanding at any time. The notes are repaid through payroll withholdings including principal and interest.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a number of investment options offered by the Plan.

Payment Of Benefits

Upon termination of employment, death, total disability, or attainment of normal retirement age (65), a participant (or beneficiary) may elect distribution of their account as a single lump sum.

In-Service Withdrawals

A participant may also elect to receive an in-service distribution upon attaining age 59½ or reach normal retirement age. Participants may also elect an in-service distribution for having incurred a financial hardship as defined by the Plan Document.

Administrative Expenses

Salaries and related benefits of employees who administer the Plan were paid by the Company. Other administrative expenses, primarily transaction fees and account fees, were paid by the Plan. Expenses incurred on the purchase or sale of investments were added to the cost or deducted from the proceeds of the respective investment.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Investment Income Recognition

The Plan's investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See fair value measurement discussions at Note 4.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Subsequent Events

Management evaluates subsequent events through October 3, 2023, which is the date the financial statements are available for issue.

NOTE 3 CERTIFIED INVESTMENT INFORMATION

Ascensus Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, and the statement of changes in net assets available for benefits for the year ended December 31, 2022. Ascensus Trust Company also certified notes receivable from participants in the accompany statement of net assets available for benefits as of December 31, 2021.

As a result of the Plan merger effective January 1, 2023, as described in Note 1, all investments and notes receivable from participant were transferred out from the Plan on December 30, 2022. The investments and notes receivable from participant were in transit on December 31, 2022.

NOTE 4 FAIR VALUE MEASUREMENTS

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

Collective Trust Fund – Valued at the Net Asset Value (NAV) of units of a bank collective trust. The NAV, as provided by the qualified institution, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidation will be carried out in an orderly business manner. No redemption restrictions noted, but during certain circumstances a redemption notice of 12 months may be required.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net NAV and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of a different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 INCOME TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the nonstandardized prototype profit-sharing plan sponsored by Ascensus LLC. This letter stated that the prototype plan document, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the prototype plan document. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax- exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 TRANSACTIONS WITH PARTIES IN INTEREST

Plan investments are managed by the Plan's qualified institution. The Plan pays consulting fees to the qualified institution. In addition, certain participants have outstanding loans with the Plan. These transactions qualify as party in interest transactions allowable under ERISA.
