Basis for Opinion

NOTE A - DESCRIPTION OF PLAN

The following brief description of the Global Leadership Academy 403(b) Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) established on January 1, 2009, covering all employees of Global Leadership Academy Charter School (the “Organization”) who have been employed for at least one year. Employees who normally work less than 20 hours per week are generally excluded from participation in the Plan; however, if any such employee completes 1,000 hours of service during a plan year, they become eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their compensation on a pre-tax or after-tax basis, up to the maximum allowed by IRC regulations. There are no employer contributions made to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses, if any. Allocations are based on earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Forfeited Accounts

As participants are immediately vested in their accounts, the Plan has no forfeitures.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant, or their beneficiary, may elect to receive a lump sum amount equal to the value of the participant's vested interest. If a participant's vested balance is less than \$5,000, but more than \$1,000, the participant's balance will automatically be distributed and rolled over into an individual retirement account unless the participant elects otherwise. If a participant's vested balance is less than \$1,000, the participant's balance will automatically be distributed in the form of a lump sum to the participant. Hardship distributions are permitted by the Plan. In service distributions are permitted by the Plan upon attaining age 59 ½.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Due to the Plan termination, the financial statements as of and for the years ended December 31, 2022 and 2021 have been prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expenses. As of December 31, 2022 and 2021, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management fees are also included in administrative expenses.

NOTE C – CERTIFIED INVESTMENTS

The following information related to investments disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied to the Plan administrator and certified to as complete and accurate by the trustees American United Life Insurance Company, MassMutual Ascend Life Insurance Company (formerly GreatAmerican Life Insurance Company), and Equitable Financial Life Insurance Company.

NOTE D - FAIR VALUE MEASUREMENTS

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTES TO FINANCIAL STATEMENTS

NOTE E - GUARANTEED INVESTMENT CONTRACTS

The Plan has fully benefit-responsive guaranteed investment contracts with American United Life Insurance Company, MassMutual Ascend Life Insurance Company (formerly GreatAmerican Life Insurance Company), and Equitable Financial Life Insurance Company. American United Life Insurance Company, MassMutual Ascend Life Insurance Company, and Equitable Financial Life Insurance Company maintain the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reset at a certain frequency disclosed in the contract. The interest rates are reset on an annual basis for the contracts with American United Life Insurance and MassMutual Ascend Life Insurance Company and are reset monthly for the contract with Equitable Financial Life Insurance Company.

The contracts meet the fully benefit-responsive investment contract criteria, and therefore, are reported at contract value. Contract value is the relevant measure for fully-benefit responsive investment contracts because it is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with the issuers. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. During the year ended December 31, 2022, the guaranteed investment contract with American United Life Insurance Company was terminated due to the liquidation of the Plan as a result of Plan termination (see Note G). The Plan held assets with MassMutual Ascend Life Insurance Company and Equitable Financial Life Insurance Company as of December 31, 2022 and is in the process of liquidating and distributing the balances. As a result of the decision to terminate the Plan (as discussed in Note G), adjustments due to differences between the fair value and contract value may occur per the provisions of the contracts.

NOTE F – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are managed by American United Life Insurance Company, Equitable Financial Life Insurance Company, and MassMutual Ascend Life Insurance Company (formerly GreatAmerican Life Insurance Company). American United Life Insurance Company, a OneAmerica company, is the third-party administrator and recordkeeper for the Plan. Fees incurred by the Plan for the services provided by American United Life Insurance Company, Equitable Life Insurance Company, and MassMutual Ascend Life Insurance Company (formerly GreatAmerican Life Insurance Company) are party-in-interest transactions, which are exempt from the prohibited transaction rules. The fees are included in administrative expenses.

Notes receivable from participants and related interest income are also considered party-in-interest transactions.

NOTE G - PLAN TERMINATION

Effective August 31, 2022, the Organization adopted a resolution to terminate the Global Leadership Academy 403(b) Plan because the Organization offers an alternative retirement savings plan option that is a better benefit to employees. The Organization has the right to terminate the Plan subject to the provisions of ERISA. As a result of the decision to terminate the Plan, participant contributions ended effective November 2022. The financial statements as of and for the years ended December 31, 2022 and 2021 have been presented on the liquidation basis of accounting. This had no impact on the values of the assets reported in the financial statements. No liabilities were recognized in connection with the termination. In connection with the Plan's termination, participants were permitted to rollover their account balances into the alternative retirement savings plan offered by Global Leadership Academy Charter School. The Plan Sponsor expects the Plan to be fully liquidated and to file their final Form 5500 filing in 2023.

NOTE H - TAX STATUS

The Plan operates under a volume submitter 403(b) plan. The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated November 22, 2017 that the volume submitter plan is designed in accordance with section 403(b) and other applicable sections of the IRC. The Plan is required to operate in conformity with the Code and to maintain tax-exempt status for plan participants under 403(b). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan as of December 31, 2022 and 2021, and is not aware of any uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market rate, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The ongoing COVID-19 pandemic and the associated governmental responses have led to volatility in financial markets and could continue to affect the market price of the Plan assets. The extent and duration of the global pandemic's impact on the financial markets is highly uncertain and the short and long-term financial impact to the Plan cannot be reasonably estimated at this time.

NOTE J – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain amounts included on Schedule H Part I and II on the Annual Return/Report of Employee Benefit Plans (Form 5500) have been grouped differently for purposes of presentation in the financial statements.

NOTE K – PROHIBITED TRANSACTIONS

During the years ended December 31, 2022 and 2021, the Organization inadvertently failed to remit participant contributions within the required timeframe as stated by the Department of Labor (DOL).

During the year ended December 31, 2022, the Organization failed to contribute \$675 in participant contributions to the Plan, which have been presented as participant contributions receivable in the statement of net assets available for benefits as of December 31, 2022, and have been included in the “contributions not corrected” total in the supplemental schedule of delinquent participant contributions. Additionally, the Organization had four instances totaling \$2,900 in participant contributions during the year ended December 31, 2022, that were remitted to the Plan late and have been included in the “contributions not corrected” total in the supplemental schedule of delinquent participant contributions.

During the year ended December 31, 2021, the Organization had four instances totaling \$2,970 in participant contributions plus loan repayments that were remitted to the Plan late. These were corrected during 2022 and have been reflected as “Contributions Corrected Outside Voluntary Fiduciary Correction Program (VFCP)” in the supplemental schedule of delinquent participant contributions.

The DOL considers late remittances of participant contributions to be nonexempt prohibited transactions. Due to complications to correct the late remittances because of the Plan’s termination, the Plan will consult and work with an ERISA attorney to correct the 2022 late remittances properly and completely during 2023.

NOTE L – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 5, 2023, the date the financial statements were available to be issued.
