## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Pittsburgh Technical College Retirement Savings Plan  
Pittsburgh, Pennsylvania

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pittsburgh Technical College Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Pittsburgh Technical College Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pittsburgh Technical College Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pittsburgh Technical College Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Pittsburgh Technical College Retirement Savings Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Management has evaluated subsequent events through October 12, 2023, the date the financial statements were available to be issued and has no material subsequent events to report.

#### **General**

The Plan is a defined contribution plan covering substantially all eligible employees of Pittsburgh Technical College (Company or Employer). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). To be eligible to participate in the Plan for salary deferrals, employer matching, and profit-sharing contributions, employees must be age 21 or older and complete 500 hours of service within the six-month period following their date of hire.

#### **Contributions**

Participants may make pretax contributions to the Plan at a minimum of 1% of their eligible compensation up to the maximum percentage allowable by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants.

The Employer may elect to match an employee's contributions in an amount equal to a discretionary percentage of the employee's deferrals, to be determined annually by the Board of Directors. Catch-up contributions will also be matched. The Company matches 4% of all eligible compensation.

The Employer may also elect to make a discretionary contribution. Discretionary contributions, if any, are determined annually by the Board of Directors. The employee's share of the discretionary contribution is based on the proportion of the employee's compensation to the total compensation for all eligible participants. During 2022, the Company did not declare a discretionary contribution.

#### **Participant Accounts**

Each participant account is credited with the participant's contribution and an allocation of (a) the Employer's matching contribution, if any, (b) the Employer's discretionary contribution, if any, (c) Plan earnings (losses) based on investment options selected by participants. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

#### **Vesting**

Participants are immediately vested in their contributions and associated earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. Participants vesting percentage is 20% after one year of service, and increases by 20% for each year of service until an employee is 100% vested after five years of service.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The maximum number of outstanding loans permitted at any given time is two. The loans are secured by the balance in the participant's account and bear interest at the prime rate of the month the loan is originated. Loans must be repaid in level payments through payroll deductions over a five-year period, or ten years for loans used to purchase a principal residence. The loans bear interest at rates ranging from 3.25% to 6.25%. A \$50 loan processing fee is charged by the Plan to each loan recipient as well as a \$50 annual loan administration fee.

#### **Payment of Benefits**

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement or attainment of age 59½, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" (RMD) must commence by age 70½, unless the participant is an active employee. All benefits other than "required minimum distributions" may be paid in the form of a lump sum, or in installment payments over a period not to exceed the participant's and beneficiary's expected life expectancies.

Employees may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

#### **Forfeited Account**

At December 31, 2022 and 2021, the forfeited non-vested balances were \$46,590 and \$34,839, respectively. This balance will first be used to reduce Plan administrative expenses. Any excess remaining will be allocated to participants as additional Employer contributions. During the year ended December 31, 2022 forfeitures of \$2,915 were used to pay Plan administrative expenses and \$725 of forfeitures were used for additional Employer contributions.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's guaranteed investment contract is deemed to be fully benefit-responsive at December 31, 2022 and 2021.

#### **Use of Estimates in the Preparation of Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### **Valuation of Investments and Investment Income**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. Loans are in arrears and delinquent when any payment is missed. Loans not paid up-to-date by the end of the calendar quarter following the calendar quarter in which a payment is first delinquent will be deemed in default.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Operating Expenses**

The Plan trustees and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. Some expenses of maintaining the Plan are paid by the Employer. The Employer paid \$17,000 in operating expenses on behalf of the Plan during the year ended December 31, 2022.

### **NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a benefit-responsive guaranteed interest account with Empower Annuity Insurance Company of America through a group annuity contract. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Empower Annuity Insurance Company of America. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Empower Annuity Insurance Company of America considers this investment option to be fully benefit-responsive notwithstanding the liquidation value events (see below) under the contract that limit the ability of the Plan to transact at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Such interest rates are reviewed on a quarterly basis for resetting. As of December 31, 2022 and 2021, the average yield earned was .94% and .90%, respectively.

Certain events (for example, premature termination of the contracts by the plan, plant closings, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives) may limit the ability of the Plan to transact at contract value. Consult the Plan's group annuity contract for further information. The fund administrator believes that it is not probable that events may occur that will limit the ability of the Plan to transact at contract value with the issuer. Either party may terminate the contract with at least 60 days advanced written notice to the other party. Details of events that permit the issuer to terminate the contract can be found within the group annuity contract.

### **NOTE E - INFORMATION CERTIFIED BY TRUSTEES (UNAUDITED)**

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualified institutions, have certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Interest (including interest on notes receivable from participants), dividends and net appreciation (depreciation) of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2022, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE F - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE G - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company may discontinue its contributions to the Plan at any time and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance.

### **NOTE H - COMMITMENT**

The Plan's investments include \$3,848,378 allocated to participants who have withdrawn from the Plan as of December 31, 2022 but have not yet been paid. These participants may elect to withdraw their vested balances at any time.

### **NOTE I - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Plan by letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE J - PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investment in the Key Guaranteed Portfolio Fund consists of fixed income funds managed by Empower Annuity Insurance Company of America. In addition, all other investments of the Plan are managed by Empower Trust Company, LLC. Empower Annuity Insurance Company of America (record-keeper) and Empower Trust Company, LLC are the trustees for the Plan. Therefore, these transactions qualify as party-in-interest.

### **NOTE K - NONDISCRIMINATION TESTING**

As of the date of this report, the required non-discrimination testing for the year ended December 31, 2022 has not been completed. In addition, the Employer does not expect that this testing will have any impact on the Plan's tax status.
