## **Independent Auditors' Report**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of The Resource Center 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 14, 2022 (in liquidation) and the related statement of changes in net assets available for benefits for the period January 1, 2022 through December 14, 2022 (in liquidation), and the statement of net assets available for benefits as of December 31, 2021 (on going), and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Resource Center 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 14, 2022 and for the period January 1, 2022 through December 14, 2022, and as of December 31, 2021 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Resource Center 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Basis of Accounting***

As discussed in Note 8 to the financial statements, the governing body of The Resource Center 403(b) Plan approved a plan of liquidation as of December 14, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the December 31, 2021 financial statements to the liquidation basis used in presenting the December 14, 2022 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Resource Center 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of The Resource Center 403(b) Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF PLAN**

The following description of The Resource Center 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

***General***

The Plan is a 403(b) defined contribution plan covering eligible employees of Chautauqua County Chapter of NYSARC, Inc., dba The Resource Center (the Organization). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2022, the management of The Resource Center 403(b) Plan approved a resolution to merge into the ARC New York Affiliated Employer's 403(b) Plan. As a result of this merger, all contributions to The Resource Center 403(b) Plan ceased in December 2022 and the assets were transferred into the ARC New York Affiliated Employer's 403(b) Plan as of December 14, 2022.

The statement of net assets available for benefits as of December 14, 2022 and the related statement of changes in net assets available for benefits for the period then ended are presented on the liquidation basis. The statement of net assets available for benefits as of December 31, 2021, and the related statement of changes in net assets available for benefits for the year then ended are presented on the ongoing basis.

***Contributions***

Participants may make elective deferrals into the Plan of up to 100% of their compensation, or the maximum allowable annual deferral amount, whichever is less. Participants age 50 or older also are eligible to make additional catch-up contributions. The Organization can make matching contributions of a discretionary amount and percentage of employees' contributions, which include both elective deferrals and catch-up contributions. The Organization also has the sole discretion to contribute on an annual basis a non-elective contribution to the Plan. Participants direct the investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's elective deferrals and allocations of the Organization's matching and non-elective contributions, in addition to the earnings (losses) of a participants selected Plan investments. Allocations of any matching and non-elective contributions are based on participant earnings or account balances, as defined. The Organization's non-elective contribution is allocated as described below in the Vesting section. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. DESCRIPTION OF PLAN**

***Vesting***

Participants are immediately 100% vested in their elective deferrals plus actual earnings thereon. For the Organization's matching and non-elective contributions and actual earnings thereon, participants are subject to a three-year cliff vesting schedule. Under this cliff vesting schedule, participants are 0% vested until they have three years of qualifying service, when they become 100% vested.

***Forfeited Accounts***

Any former participant's account that is not fully vested will be forfeited after the participant terminates their employment with the Organization, as defined by the Plan document. Any forfeited accounts are to be first used to pay Plan administrative expenses and then used to reduce future Organization contributions. In 2022 and 2021, no forfeitures were used to reduce the Organization's matching contributions. Forfeitures of \$-0- and \$7,714 for the period ended December 14, 2022 and the year ended December 31, 2021, respectively, were used to reduce the Organization's non-elective contributions.

***Death and Disability Benefit***

Upon death or total disability, the benefit will be 100% of the participant's account.

***Notes Receivable from Participants***

Participants may borrow from their individual account balance a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their account balance, whichever is less. The notes are secured by the balance in the participants' accounts and bear interest at rates determined by similar loans from commercial lending institutions at the time the loans were issued. Note repayments can be paid by methods prescribed by the Plan Administrator.

***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in the participant's account, or other payment options as provided under the Plan.

***Plan Expenses***

Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in the net appreciation (depreciation) in fair value. Fees for the administration of participant accounts, distributions, and management of the Plan by the Plan's trustees are reported as administration expenses in these financial statements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared using the accrual method of accounting and are in conformity with accounting principles generally accepted in the United States.

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses. As of December 14, 2022 and December 31, 2021, no allowance for loan defaults was recorded. Defaulting on a loan as defined in the Plan document, may result in the loan balance being recorded as a "deemed distribution" and becoming a taxable distribution to the participant.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value as certified to the Plan Administrator by the Plan trustee and Plan custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments are recorded when paid.

***Date of Management's Review***

Subsequent events were evaluated through October 4, 2023, which is the date the financial statements were available to be issued.

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

*Level 1 Fair Value Measurements*

**4. TAX STATUS**

**3. FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.
