### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of AeroThrust 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021, and for the years then ended, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ## **Emphasis of Matter - Correction of Error**

As discussed in note 11 to the financial statements, management determined that previously issued financial statements included certain errors related to excess contributions refundable as of December 31, 2021. Accordingly, the 2021 financial statements have been restated to correct these errors. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1 - Description of Plan

The following description of AeroThrust 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions, which are available from the plan administrator.

#### General

The Plan is a defined contribution 401(k) retirement plan available to all employees of AeroThrust Holdings, LLC, AeroThrust Holding Leasing, LLC, and JAM Aerospace Parts, LLC, (collectively, the "Company") with the exception of collectively bargained employees and non-resident aliens. Employees are eligible to participate on the first day of the month after attaining age twenty-one (21). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective March 1, 2021 Company determined a plan of merger into the iAero Group 401k and employees of the Company became eligible to participate in the iAero Group 401k as of that date. The Company is working to finalize the plan of merger in order to transfer participant account balances out of the Plan.

#### Contributions

Prior to March 1, 2021, participants could contribute a minimum of one percent (1%) and a maximum of 90 percent (90%) of pre-tax or after-tax (roth contributions) annual eligible compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) limitations. Participants who had reached the age of fifty (50) before the end of the plan year were eligible to make catch-up contributions. Participants could also make rollover contributions representing distributions from other qualified retirement plans. The Company could make discretionary matching and discretionary employer contributions to the Plan in amounts determined by the Company. To qualify for the discretionary employer contributions, participants must have worked 1,000 hours. There were no discretionary matching or employer contributions in 2022 or 2021.

#### Participant investment account options

The Plan allows participants to direct varying portions of their contributions and account balances among the different investment options offered by Reliance Trust Company which include mutual funds and a stable value common collective trust.

#### Participant accounts

Each participant's account is credited with the participant's deferral contributions, the Company's discretionary matching contributions, and discretionary employer contributions, if any, and a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested and an allocation of administrative expenses. Allocations are based upon the

#### Participant accounts (continued)

participant's eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their deferral and rollover contributions plus earnings thereon. Participants become fully vested in Company discretionary matching and employer contributions and related earnings after two (2) years of credited service. In the event of death, disability, normal retirement age (65), or if the Plan is discontinued, participants become 100% vested in all account balances.

#### Payment of benefits

Upon termination of service, death, disability or retirement, a participant may elect to receive account distributions in the form of a lump sum payments.

### Note 2 - Summary of significant accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions which affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits

Benefits are recorded when paid.

#### Administrative expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Certain investment related expenses are included in the net appreciation (depreciation) in fair value of investments.

### Note 3 - Information prepared and certified by the custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan has certified that the following data included in the accompanying financial statements and the supplemental schedule is complete and accurate.

- Investments at fair value
- Net appreciation (depreciation) in fair value of investments
- Dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and the schedule of assets (held at end of year).

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value common collective trust:* A stable value fund that is composed primarily of fully benefit-responsive investment contracts is valued as the NAV of units of the bank collective trust. The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

### Note 5 - Related party transactions and party-in-interest transactions

Plan investments include interests in certain mutual funds and a stable value common collective trust managed or offered by Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan and, therefore, these investments and related investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in the net appreciation (depreciation) in fair value of the investments as they are paid through revenue sharing, rather than a direct payment. Fees incurred by the Plan for administrative services totaled \$9,186 and \$9,674 in 2022 and 2021, respectively. The Company pays directly any other fees related to the Plan's operations.

### Note 6 - Plan termination

Contributions to the Plan have been discontinued and the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### Note 8 - Tax status

The IRS has determined that the Non-Standardized Pre-Approved Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and informed the recordkeeper of such in a letter dated October 6, 2020. The plan administrator has adopted the prototype plan and believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risks, uncertainties, and concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As of December 31, 2022, approximately 19% of the Plan's total investments were invested in the Fidelity Freedom Index 2040 Premier Fund. As of December 31, 2021, approximately 24% of the Plan's total investments were invested in the Vanguard Target Retirement 2040 Fund.

### Note 10 - Delinquent participant contributions

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. Contributions of \$49,194, \$74,783, and \$81,447 were not remitted within the required time period during 2021, 2019, and 2018, respectively. The Company remitted these delinquent employee contributions during 2021, 2019, and 2018, but has not yet remitted any lost earnings associated with the delinquent contributions. Additionally, the Company has not remitted delinquent employee contributions nor calculated lost earnings on \$3,200, which is included in participant contributions receivables.

### Note 11 - Prior period adjustment and restatement

During 2022, management determined that previously issued financial statements included certain errors in the recognition and accrual of excess contributions refundable. Accordingly, the 2021 financial statements have been restated to correct these errors. The restatement resulted in the removal of excess contributions refundable in the statement of net assets available for benefits as of December 31, 2021 and an increase in participant contributions in the statement of changes in net assets available for benefits for the year ended December 31, 2021 of \$14,740.

### Note 12 - Subsequent events

Plan management has evaluated subsequent events through October 12, 2023, which is the date that the financial statements were available to be issued. No significant matters were identified for disclosure.


