We have performed audits of the accompanying financial statements of Atrion, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of January 12, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to January 12, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Atrion, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of January 12, 2023 and December 31, 2022, and for the period January 1, 2023 to January 12, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Emphasis of Matter – Plan Merger

As further discussed in Note 1 to the financial statements, on January 1, 2023, Atrion, Inc., the plan sponsor, entered into a merger agreement with Carousel Industries of North America, Inc. 401(k) Plan & Trust ("Carousel 401(k) Plan"). As a result of the merger, the Plan transferred all of its assets to the Carousel 401(k) Plan on January 12, 2023. Therefore, the Plan ceased to exist as of this date.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

1. Description of Plan

The following description of the Atrion, Inc. 401(k) Plan (the "Plan") provides general information about the Plan's provisions. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions, copies of which may be obtained from Atrion, Inc. ("Company" or "Plan Sponsor").

General

The Plan is a defined contribution plan qualified under Section 401(a) of the Internal Revenue Code ("IRC") with a deferred arrangement qualified under Section 401(k) of the IRC. Pursuant to the requirements of Section 401(a)(27) of the IRC, the Plan is also a profit sharing plan. The Plan covers all employees of the Company who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan initially became effective on January 1, 1997, for the purpose of providing benefits to participants upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was administered by the Company and the assets of the Plan were held and invested by Hand Benefits & Trust Company (the "Custodian"). On January 1, 2023, the Company entered into a merger agreement with Carousel Industries of North America, Inc. 401(k) Plan & Trust ("Carousel 401(k) Plan"). As a result of the merger, the Plan transferred all of its assets to the Carousel 401(k) Plan on January 12, 2023.

Eligibility

Employees who are 21 years of age are eligible and automatically enrolled to participate in the Plan on the first day of the month following the date the eligibility requirements are satisfied. Eligible participants are automatically enrolled with a deferral rate of 3% of pretax annual compensation unless another option is elected by the participant. The automatic enrollment feature includes an automatic escalation of one percent every year up to a maximum deferral rate of six percent. Eligible participants have the option to cease participation at any time.

Contributions

Participants may elect to contribute a percentage of their annual pretax compensation to the Plan, subject to certain limitations as allowable under Section 401(k) of the IRC.

These contributions, and earnings thereon, are not subject to federal income taxes until withdrawn from the Plan. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans. The Plan provides for a discretionary matching contribution from the Company. All contributions to a participant's account are allocated among the various investments based on each participant's elections. The Company contribution is determined by a resolution of its Board of Directors. The Company made no discretionary matching contributions during the period from January 1, 2023 to January 12, 2023.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

Vesting

Participants are immediately vested in their pretax contributions and any amounts rolled over or transferred into the Plan. Vesting in the Company's matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's account attributable to the matching and profit sharing contributions becomes 100% vested upon completion of one year of credited service, as defined.

Forfeitures

Any balance in the employer contribution account of a participant who has separated from service, to which he or she is not entitled, is administered by the Custodian and is subsequently to be used to pay administrative expenses under the Plan, as directed by the Employer or to reduce future employer contributions. Nonvested forfeited account amounts of \$5 were used during the period January 1, 2023 to January 12, 2023 to pay administrative expenses. At December 31, 2022, forfeited nonvested accounts totaled \$5. At January 12, 2023, the Plan had no forfeited nonvested accounts.

Payment of Benefits

Participants are entitled to the total value of their accounts in the form of lump-sum distributions upon attaining the age of 59-½. Generally, there is a 10% excise tax on the taxable amount of any distribution taken before age 59-½. Upon the death of a participant, his or her beneficiaries are entitled to 100% of the total value of the participant's account. Participants suffering total and permanent disability will be considered retired and any amount credited to the participant's account will be distributed to the participant in a lump-sum distribution upon disability. Upon termination of employment, participants are entitled to all vested monies in the Plan.

Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other expenses, including investment advisor and recordkeeping fees, are paid by the Plan and are included within administrative expenses on the accompanying statement of changes in net assets available for benefits. Fees related to the administration of participant loans and payments of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). A participant may not have more than one outstanding general purpose loan, nor one outstanding residential loan, at one time. The term of the loan may not exceed five years unless the proceeds of the loan are used to purchase the participant's principal residence. The loans bear interest at interest rates commensurate with local prevailing rates. Principal and interest are paid in level payments through bi-weekly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. The mutual funds held by the Plan were valued at fair value based on the daily closing price as reported by the funds. All of the funds were open-ended and were registered with the Securities and Exchange Commission. These funds were required to publish their daily NAV and to transact at that price. These funds were deemed to be actively traded. The common/collective trusts were valued at the NAV of units held by the Plan. The NAV, as provided by the Trustee, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the funds less their liabilities. The practical expedient was not used when it was determined to be probable that a fund would sell the investment for an amount different than the reported NAV.

Investment Valuation and Income Recognition (continued)

Purchase and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deemed the participant loan to be in default, the participant loan balance was reduced and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 6, 2023.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at January 12, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended January 12, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company, a qualified institution.

5. Common/Collective Trust

The MetLife Stable Value Fund Series 25053 Class 65 (the "Fund") is a common/collective trust that provides for the collective investment of assets of defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC. The Fund allows participating plan sponsors to invest in the MetLife Group Annuity Contract 25053 and the MetLife Group Annuity Contract 37000 (collectively the "Contracts"), which are issued by Metropolitan Life Insurance Company ("MetLife") to Reliance Trust Company, the trustee of the Fund. The Contracts are administered by MetLife and are managed by MetLife and Reliance Trust Company.

Units of the Fund are valued each day and the NAV of the Fund is calculated as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit value.

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV of the Fund as of the close of business each day. The Fund has no unfunded commitments due from the Plan at December 31, 2022.

6. Tax Status

The Plan has adopted a pre-approved 401(k) profit sharing plan. The Internal Revenue Service has issued a letter, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

6. Tax Status (*continued*)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination and Merger

The Company expressly reserves the right to amend or terminate the Plan at any time. Effective January 12, 2023, the Atrion, Inc. 401(k) Plan merged into the Carousel Industries of North America, Inc. 401(k) Plan & Trust. The participants in the Plan carried their existing vesting into the Carousel 401(k) Plan as part of the merger.

8. Party-in-Interest Transactions

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants on the statements of net assets available for benefits.
