### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements

We have performed an audit of the financial statements of Bid2Win Software, Inc. 401(k) Plan (the Plan), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 20, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period of January 1, 2022 through December 20, 2022 (in liquidation), and the related notes to the 2022 financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 20, 2022 and for the period January 1, 2022 through December 20, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section:

- The amounts and disclosures in the accompanying 2022 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles (U.S. GAAP).
- The information in the accompanying 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion on the 2022 Financial Statements**

We conducted our audit in accordance with U.S. generally accepted auditing standards (U.S. GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Plan Termination and Liquidation Basis of Accounting for 2022**

As discussed in Note 2 to the financial statements, the Plan was terminated effective September 17, 2022, with all remaining Plan assets having been distributed as of December 20 2022. As a result, the Plan has presented the 2022 financial statements on the liquidation basis. Our opinion is not modified with respect to that matter.

### **Responsibilities of Management for the 2022 Financial Statements**

Management is responsible for the preparation and fair presentation of the 2022 financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the 2022 Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2022 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2022 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

*Report on Compiled 2021 Financial Statement*

Plan management is responsible for the accompanying financial statement of the Plan, which comprises the statement of net assets available for benefits as of December 31, 2021 (ongoing basis). We have performed a compilation engagement in accordance with the Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the 2021 financial statement, nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the 2021 financial statement.

### 1. Description of the Plan

The following description of Bid2Win Software, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a tax-exempt, defined contribution plan that covers substantially all employees of Bid2Win Software, Inc. (the Plan Sponsor and Employer). The Plan was adopted on January 1, 2000 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Principal Life Insurance Company (Principal) was the trustee and recordkeeper of the Plan.

On September 17, 2022, the Plan Sponsor was acquired by Trimble, Inc. Participants of the Plan were given the option to roll over their account balances, including any outstanding notes receivable from participants, into the Trimble Inc. Savings and Retirement Plan. The Plan was terminated effective September 17, 2022 with all remaining Plan assets having been distributed as of December 20, 2022.

#### Eligibility

All employees of the Plan Sponsor, except for (i) employees covered by a collective bargaining agreement, (ii) employees acquired as a result of an acquisition, merger, or similar transaction, for the duration of the transition period, as defined, become eligible for participation in the Plan on the date of hire and upon attaining age 21. Eligible employees enrolled in the Plan are referred to as "Participants" in the Plan.

#### Contributions

Participants may contribute up to 100% of compensation to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). In addition, participant contributions may also consist of rollovers from other qualified retirement plans. Participants are immediately vested in their elective deferrals and any rollover contributions.

The Company makes matching contributions to the Plan equal to 50% of the first 6% of compensation and may elect to make discretionary profit-sharing contributions. There was no discretionary profit-sharing contribution for the period January 1, 2022 through December 20, 2022.

Participants become fully vested in the Plan Sponsor's profit-sharing contributions on a graded scale through five years of service. Participants also become fully vested in the Plan Sponsor's contributions upon death, permanent disability, or normal retirement age (65) or termination of the Plan.

#### **Participant Accounts**

Each Participant's account is credited with the Participant's contributions and allocations of (a) the Plan Sponsor's contributions, (b) Plan earnings or losses, and (c) charged with an allocation of administrative expenses, if any. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

#### **Notes Receivable from Participants**

Participants may borrow from their Plan accounts in amounts attributable to the Participant's vested balance for a maximum term of five years. If the loan is for the purchase of a principal residence, the term of the loan may be extended. A Participant may borrow the lesser of 50% of their eligible balance up to \$50,000. The minimum loan amount is \$1,000 and only two can be outstanding at any time. The loan balance is secured by the Participant's account and bears fixed interest at rates that are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

#### **Forfeited Accounts**

Participants who terminate their employment prior to becoming 100% vested forfeit their non-vested account balance. These benefits plus accumulated investment earnings are left in the Plan and can be used to reduce employer matching contributions or pay Plan expenses. Employer contributions paid to the Plan were reduced by \$13,580 from forfeited nonvested accounts during the period ended December 20, 2022. There were no forfeited nonvested accounts at December 20, 2022 and December 31, 2021.

#### **Investments**

Participants may direct their contributions into any of the funds offered by the Plan, which are held by Principal. These investments include mutual funds and a guaranteed investment contract.

#### **Payment of Benefits**

Participants shall become eligible to withdraw their vested account balances upon retirement (normal retirement age is 65), death, disability or termination of employment. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump sum, installment or monthly annuity. In addition, Participants may withdraw their elective deferral contributions upon demonstration to the Plan Administrator that they are suffering a hardship, as defined by the Code.

In the event of the above, the Participants or their beneficiaries will receive a lump sum distribution if the account balance has a value less than or equal to \$1,000. Participants whose account balances exceed \$1,000 may elect to receive a lump sum or partial withdrawal distribution, or may leave their vested balance in the Plan.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The Plan was terminated effective September 17, 2022 with all remaining Plan assets having been distributed as of December 20, 2022. As a result, the Plan has changed its basis of accounting from the going concern (ongoing) accrual basis used in presenting the 2021 financial statement to the liquidation basis used in presenting the 2022 financial statements. Under the liquidation basis of accounting, assets are reflected at the estimated amount of cash or other consideration expected to be collected in settling or disposing of those assets in carrying out the Plan's liquidation (estimated net realizable value). There were no changes to the 2021 financial statement as a result of the change to the liquidation basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value, except for the investment contract with an insurance company, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

##### Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 20, 2022 and December 31, 2021. If a Participant ceases to make loan repayments and the Plan Administrator deems the Participant loan to be in default, the note receivable balance is reduced and a benefit payment is recorded.

##### Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

#### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan.

#### **Subsequent Events**

Management has considered transactions or events occurring through October 12, 2023, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

#### **3. Investment Contract with Insurance Company**

The Plan has a benefit-responsive investment contract with Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings (losses), less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract was fully liquidated during the period of January 1, 2022 through December 31, 2022.

#### **4. Information Prepared and Certified by the Trustee**

The investments, investment transactions, net depreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from information certified by Principal, as complete and accurate. This information is included in the following:

#### 5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2021. There were no assets measured at fair value at December 20, 2022.

*Collective trust:* Valued at net asset value (NAV) of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is excluded from the fair value hierarchy. The NAV is based on the fair value of the underlying investments in the collective trust.

*Pooled separate accounts:* Values are derived from the fair values of the underlying securities, primarily invested in equities of companies domiciled in developed international market.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Parties-in-Interest

Principal manages the investment contract and certain investment funds. Principal is the third-party administrator and trustee of those investments and, therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the Plan for the investment management services amounted to \$40,025 for the period of January 1, 2022 through December 20, 2022.

#### 7. Tax Status

The Plan has adopted the nonstandardized pre-approved profit-sharing plan of Principal Financial Group. The nonstandardized prototype plan sponsor received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the form of the nonstandardized prototype plan was in compliance with the applicable requirements of the Code. The nonstandardized prototype plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan and the related trust are currently being operated in compliance with the applicable provisions of the Code, and that the related trust is therefore tax-exempt.
