## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Rincon Fresh, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C)]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Rincon Fresh, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 - DESCRIPTION OF PLAN**

The following description of Rincon Fresh, LLC 401(k) Plan provides only general information. Participants should refer to the summary plan description or the plan document for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all employees of Rincon Pacific, LLC, Sorrento Berry Farms, LLC, and Mission Oaks Management Group, Inc. who have completed one year of service and are age twenty-one or older. John Hancock Insurance Company is the Plan's directed trustee. CrossPlans is the Plan's third party administrator. Rincon Fresh, LLC 401(k) Plan has adopted CrossPlans defined contribution volume submitter plan and trust basic plan document No. 04 on October 1, 2019. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions.** Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Total deferrals in any taxable year may not exceed a dollar limit set by federal tax law, \$20,500 for 2022. Participants age 50 or over are eligible to make catch-up contributions to the Plan in an amount not to exceed the federal tax laws for that calendar year. The Plan accepts Rollover Contributions made on behalf of any eligible employees.

**Matching Contributions.** The employer will determine in its sole discretion how much, if any, it will make as a matching contribution. Such an amount can be determined either as a uniform percentage of deferrals or as a flat dollar amount for each participant. The employer currently makes safe harbor matching contributions equal to 100% on the first 4% of the participant's compensation which is deferred as an elective deferral. Matching contributions shall be determined each payroll period.

**Nonelective Contributions.** The employer may decide to make a nonelective contribution to the Plan, although the employer is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the Plan. A participant must be employed by the employer on December 31 and have completed 1,000 hours of service during the plan year to receive this allocation. If employment is terminated prior to December 31 due to death, disability, or normal retirement age, the participant will be eligible to receive any nonelective contribution that the employer may make for the year in which the employment terminated.

**Expenses.** Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net appreciation of fair value of investments.

**Participant Accounts.** Each participant's account is credited with the participant's contribution and allocations of the employer's contribution, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on a reasonable method that does not violate Title I of ERISA and does not discriminate in favor of Highly Compensated Employees within the meaning of applicable provisions of Code section 401(a)(4). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting.** Participants are immediately vested in their contributions and employer's safe harbor match, plus actual earnings thereon. Vesting in the employer's discretionary profit-sharing contributions and employer matching contributions is based on years of continuous service. A participant is 100% vested in the employer's discretionary profit-sharing contributions and employer matching contributions after six years of credited service.

**NOTE 1 - DESCRIPTION OF PLAN - Continued**

**Notes Receivable from Participants.** The Plan does not allow participants to borrow from their fund accounts.

**Payment of Benefits.** On termination of service, for any reason, including retirement, disability, or death, a participant may receive his or her vested benefit in a single lump sum payment or have the payment paid as a “direct rollover” to his or her individual retirement account (IRA) or to another employer’s tax qualified plan. Participants may elect to withdraw their vested account balance after reaching the Plan’s normal retirement age of 65 or delay it until they retire.

**Forfeited Accounts.** Any forfeitures occurring during a plan year will be transferred to the forfeiture account and may be used to pay administrative expenses of the Plan or may be used to reduce future Company contributions to the Plan. There is no balance in the forfeiture accounts at December 31, 2022.

**Investment Options.** Each employee is permitted to direct the investment of funds in his or her individual account among any of the investment funds permitted under the Plan. The Plan offers various investment options through John Hancock and each participant can select from one or more investment options. To the extent that the employee directs the investment of his individual account, the trustees are relieved of their fiduciary responsibilities as provided in Section 404(a)(1)(C) of ERISA.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation.** The accompanying financial statements of the Plan have been prepared on the accrual basis and are presented in accordance with generally accepted accounting principles.

**Estimates.** The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investment committee determines the Plan’s valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Concentration of Credit Risk.** The Plan’s exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments.

**Payment of Benefits.** Benefits are recorded when paid.

**Excess Contributions Payable.** Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan generally distributes any excess contributions to the applicable participants prior to March 15 of the following year. No payable has been recorded as of December 31, 2022.

**Reclassifications.** Certain amounts in the 2021 financial statements have been reclassified for comparison purposes to conform to the current year presentation.

**Subsequent events.** The Plan has evaluated subsequent events through October 11, 2023, the date the financial statements were available to be issued. The Plan did not experience material subsequent events requiring financial statements disclosure except as disclosed below.

The Plan changed its name to Mission Oaks Management Group, Inc 401 (k) Plan subsequent to year end.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2022 and 2021.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Exchange traded funds:** Valued at the closing price reported on the active market on which the securities are traded at the year end.

**Interest-bearing cash:** Includes investment in a money market account and is valued at carrying value which approximates fair value due to the short maturity of this instrument.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result

**NOTE 4 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)**

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator has received certification from the trustee, John Hancock Insurance Company, as to the accuracy and completeness of certain financial information. Accordingly, as permitted under such regulations, the plan administrator instructed its independent auditors not to perform, and they did not perform any auditing procedures with respect to the information certified by the trustee, except for comparing that information to the financial statements. The trustee has certified the accuracy and completeness of investments of \$720,897 and \$636,536 at December 31, 2022 and 2021 respectively, and investment loss of \$109,677 for the year ending December 31, 2022.

**NOTE 5 - PARTIES-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual fund managed by John Hancock Insurance Company. John Hancock Insurance Company is the investment trustee as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan invests, through some mutual funds in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

**NOTE 7 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and amend or modify, or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 8 - TAX STATUS**

The Internal Revenue Service has determined and informed CrossPlans, by a letter date March 31, 2014, that their Profit-Sharing Plan is acceptable under section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The Plan adopted CrossPlans defined contribution volume submitter plan and trust basic plan document No. 04. The Plan administrator believes that by adopting CrossPlans basic plan document No. 04, the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken

an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or the Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, and the administrator believes it is no longer subject to income tax examinations for years prior to 2019.
