Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of Knight's Mechanical, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 2, 2022 (in liquidation) and December 31, 2021 (ongoing), and the related statement of changes in net assets available for benefits for the period and year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Knight's Mechanical, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2022 and 2021 and for the years ended December 2, 2022 and December 31, 2021, stating that the certified investment information, as described in Note G to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Knight's Mechanical, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

As discussed in Notes A, B and H to the financial statements, the governing body of Knight's Mechanical, LLC 401 (k) Plan approved a plan of liquidation of July 15, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2021 financial statements to the liquidation basis used in presenting the 2022 financial statement. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Knight's Mechanical, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The

risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Knight's Mechanical, LLC 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Knight's Mechanical, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A DESCRIPTION OF PLAN

The Knight's Mechanical, LLC 401(K) Plan (the "Plan") was established to provide retirement benefits for employees of Knight's Mechanical, LLC (the "Company"). The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan covering substantially all employees of Knight's Mechanical, LLC. Eligible employees became participants in the Plan following one year of continuous service and attainment of age 18, as defined in the Plan agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

PLAN TERMINATION

On July 15, 2022, the Board of Directors of Knight's Mechanical, LLC, the Plan sponsor, approved the termination of the Plan. Subsequent to July 22, 2022, no contributions, loan payments or new loans were allowed into or out of the Plan, and no distributions or rollovers were allowed subsequent to July 22, 2022 through December 2, 2022. Participant balances were distributed to participant IRA accounts or the participants's current employer's plan. All balances were distributed as of December 2, 2022.

CONTRIBUTIONS

Prior to the termination, participants could contribute a percentage of their compensation, the maximum of which is set by law. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions consist of pretax elective deferrals, Roth contributions, fringe benefits on prevailing wages and rollover contributions.

The Company made a matching contribution equal to 25 percent of the first five percent of compensation that the participant contributed. The Company may have made an annual discretionary matching contribution equal to a uniform percentage of participant's salary deferrals. The Company contributed the required fringe benefits on prevailing wage projects to the Plan as an employer contribution.

PARTICIPANT ACCOUNTS

Each participant's account was credited with the participant's contribution, the employer's contribution, and an allocation of the Plan's earnings and charged with an allocation of investment management fees. The Plan's earnings and investment management fees were allocated according to participants' relative account balances in the investment options. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

In certain hardship situations, as described in the Plan agreement, participants could have withdrawn part of their account balances while actively employed, but such withdrawals were limited to the amount dictated by the hardship. Participants' withdrawals were limited to deferred account balances and may have not included Roth contributions or any interest earned thereon.

A DESCRIPTION OF PLAN (continued)

VESTING

Participants were immediately vested in their contributions plus actual earnings thereon. Employer contributions were fully vested after completion of six years of service

NOTES RECEIVABLE FROM PARTICIPANTS

Participants could have borrowed up to one-half of their vested account balances up to \$50,000. The minimum loan available was \$1,000. Loan terms ranged from one to five years. Loans to purchase a principal residence may have had a longer repayment term. Participant notes were secured by the balance in the participant's account and were repaid through payroll deductions. Interest rates on loans were set at one percent above the prime interest rate. Interest was earned on the notes receivable from participants at a rate of 4.25 % to 6.25% for 2022 and 2021. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and are expensed when they were incurred.

PAYMENT OF BENEFITS

Participants' accounts became fully vested upon attainment of the normal retirement age of 65, provided the participant had been contributing for at least two years or at age 62 with five years of service or in the event of death or total disability. For termination of service for other reasons, a participant may have received the value of the vested interest in his or her account as a lump sum distribution.

FORFEITED ACCOUNTS

At December 2, 2022 and December 31, 2021 forfeited nonvested accounts totaled \$0 and \$7,178, respectively. The accounts were used to reduce future administrative expenses. The Plan used \$7,226 in 2022 and \$300 in 2021 toward administrative expenses.

B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

Effective July 15, 2022, the Board of Directors of Knight's Mechanical, LLC, the Plan sponsor, adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of December 2, 2022, have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable, and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts.

The financial statements of the Plan are prepared on the accrual basis of accounting for the year ended December 31, 2021.

Investments held by a defined contribution plan were required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value was the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants normally would have received if they were to initiate permitted transactions under the terms of the Plan.

B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments were reported at fair value except for fully benefit-responsive investment contracts, which were reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded at the ex-dividend date. Net depreciation and appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants were measured at their unpaid principal balance. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. No allowance for credit losses had been recorded as of December 2, 2022 and December 31, 2021. If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit based on the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits were recorded when paid.

ADMINISTRATIVE EXPENSES

All expenses of maintaining the Plan were paid through forfeitures or by the Company, at their discretion and those expenses would be excluded from the Plan. Fees related to the administration of notes receivable from participants were charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net depreciation/appreciation of fair value of investments.

C FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan used appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measured fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 2, 2022 and December 31, 2021.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset value of the shares as reported by the fund. The mutual funds held by the Plan were open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan were considered to be actively traded. The Plan's investments at fair value as of December 2, 2022 and December 31, 2021:

Gains and losses included in changes in net assets available for benefits for the period and year ended December 2, 2022 and December 31, 2021, are reported in net appreciation in fair value of investments.

The Plan's policy was to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period and year ended December 2, 2022 and December 31, 2021, there were no transfers of investments into or out of Level 3.

D GROUP ANNUITY CONTRACT

The Plan had a fully benefit-responsive investment contract with Empower Retirement, LLC. Empower Retirement, LLC maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Retirement, LLC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 2, 2022 was \$0 and \$706,813 at December 31, 2021. The crediting interest rate was 0.9% during 2021.

Certain events limit the Plan's ability to transact at contract value with Empower Retirement, LLC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator did not believe that any events that would limit the Plan's ability to transact at contract value with plan participants were probable of occurring.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

E TAX STATUS

The Internal Revenue Service had determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust, were designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan had been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan was qualified, and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS and DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F ADMINISTRATIVE FEES

The Plan paid \$56,216 in 2022 and \$27,808 in 2021 for administrative fees. This administrative fee charged to the Plan by the Trusts includes a base rate per plan and a charge per participant.

G CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 2, 2022 and December 31, 2021, and net appreciation in fair value of investments, interest and dividends for the period ended December 2, 2022 and the year ended December 31, 2021 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Retirement, LLC (the trustee of the Plan).

H TERMINATION

On July 15, 2022, Knight's Mechanical, LLC was sold as part of a Asset Purchase and Sale Agreement. Pursuant to the Asset Purchase and Sale Agreement, the board of Directors of Knight's Mechanical, LLC adopted a resolution to terminate the Plan, effective November 29, 2022. As permitted by the Sale Agreement, the Plan distributed assets to the participants as soon as practicable. The final distributions from the Plan were made on December 2, 2022.

I PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of funds managed by Empower Retirement, LLC. Empower Retirement, LLC was also the custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions were exempt from the prohibited transactions rules of ERISA.
